Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Belhaven University 403(b) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of the Plan

General

The following description of Belhaven University 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan document and Summary Plan Description for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

The Plan is a 403(b) defined contribution plan covering all employees of Belhaven University (Belhaven), except for students performing services that are enrolled at Belhaven and regularly attending classes, and temporary faculty and others as defined in the Plan Document. The Plan has an effective date of July 1, 1996 and was amended and restated effective July 1, 2020.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Belhaven is the Plan's Sponsor and serves as the Plan Administrator. Teachers Insurance and Annuity Association of America (TIAA) serves as issuer of the TIAA Traditional Annuity Contract held by the Plan. College Retirement Equities Fund (CREF) serves as the issuer of CREF variable annuities held by the Plan. Collectively, TIAA-CREF serves as the Custodian of the Plan.

Contributions

Eligible employees can defer up to 100% of their eligible compensation into the Plan, up to the maximum allowed by the Internal Revenue Code (IRC). Participants are allowed to make additional catch-up contributions to the Plan if they are 50 years of age or older as of the end of the plan year. At the discretion of Belhaven, a contribution may be made as a percentage of the employee's eligible compensation, not to exceed the employee's allowable deferral contribution amount. Contributions are made to the Plan each pay period. Additionally, participants are permitted to make rollover contributions to the Plan from an individual retirement account or annuity.

Participant Investment Account Options

Investment account options available include various annuity accounts, investment contracts, a pooled separate account, and mutual funds. Each participant has the option of directing his contribution on behalf of Belhaven into any of the investment accounts selected by Belhaven and may change the allocation to the extent permitted by the individual agreements.

Participant Accounts

Each participant's account is credited with the participant's contributions, Belhaven's contributions, and plan earnings and is charged with an allocation of administrative expenses. Expense allocations are based on account balances, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant accounts are valued daily.

Vesting

Participants are immediately fully vested in their employee contributions and earnings thereon. Participants are vested in employer contributions and earnings thereon according to the following vesting schedule:

Less than 1 year	0%
1 year	0%
2 years	25%
3 years	50%
4 years	75%
5 years	100%

Notes Receivable from Participants

The Plan began allowing participant loans in 2020. The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000, or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through bank account withdrawals unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

Forfeitures

The participant's nonvested balance is forfeited upon termination of employment, certain breaks in service as defined by the Plan Document, or a distribution. Forfeited balances may be used to reduce future Belhaven contributions or to pay certain administrative expenses of the Plan. The forfeiture balance totaled \$11,221 and \$6,272 at December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, forfeitures used to reduce Belhaven contributions totaled \$42,150 and \$27,157, respectively.

Payment of Benefits

Participants may receive all or a portion of their account balance upon termination of employment. Benefits may be paid in the form of a single lump sum or may be paid under optional forms, including the following: payments over a fixed time period, life annuity with or without a term certain, or joint and survivor annuity. If a participant dies or becomes disabled before distributions to the participant begin, the distribution of benefits may be elected at any time commencing no later than the month in which the participant would have attained age 70½.

Hardship Withdrawals

Under certain conditions, participants, while still employed by Belhaven, are permitted to withdraw the employee contribution portion of their account balance. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of postsecondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster cleanup on the participant's principal residence, or to prevent eviction or foreclosure from the participant's principal residence.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments.

The Plan is funded by individually controlled TIAA and CREF investments. Contributions are allocated to the TIAA Traditional Annuity Contract, CREF variable annuity accounts, TIAA-CREF mutual funds, and the TIAA Real Estate Pooled Separate Account.

The TIAA Traditional Annuity Contract is a fixed-dollar annuity and investment product offered by TIAA, an insurance company. The TIAA Traditional Annuity Contract is maintained in the TIAA general account. Contributions to the TIAA Traditional Annuity Contract purchase a contractual or guaranteed amount of future benefits for the participants and are secured by the general assets of TIAA. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The investment contract with TIAA contains liquidity restrictions that require withdrawals and transfers from the investment contract to other investment options available to the Plan to be spread over a period of ten annual installments or five annual installments for withdrawals after a participant's termination of employment. Therefore, a portion of this account is considered a fully benefit-responsive investment contract (FBRIC), and another portion is considered nonbenefit-responsive.

A portion of the TIAA Traditional Annuity Contract account is recorded at contract value. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus interest at the contract rate, less funds to pay withdrawal benefits and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The fully benefit-responsive portion of the contract is recorded at contract value, and the nonbenefit-responsive portion of the contract is recorded at fair value, which approximates contract value as estimated by TIAA. At December 31, 2024, the fair value of nonbenefit-responsive contracts at TIAA totaled \$1,634,930, and the contract value of the benefit-responsive contracts totaled \$1,941,888. At December 31, 2023, the fair value of the nonbenefit-responsive contracts at TIAA totaled \$1,553,250, and the contract value of the benefit-responsive contracts totaled \$2,035,077.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Document [including complete or partial plan termination or merger with another plan], (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other plan sponsor events [for example, divestitures or spin-offs of a subsidiary] that cause significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Variable Annuity Accounts

Participants purchase accumulation units in the variable annuity accounts, and the value is calculated daily. Variable annuity accounts, except for the money market account, are recorded at their estimated fair value, which is based upon the underlying value of the assets. The money market account is recorded at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount of premium from its face value at a constant rate until maturity.

Mutual Funds

TIAA-CREF mutual funds are valued at fair value based on the net asset value (NAV) of shares held by the Plan.

Pooled Separate Account

The TIAA Real Estate Pooled Separate Account is valued at fair value based on the closing price reported on the active market on which the individual security is traded. The underlying real estate holdings or other real estate related investments are valued principally utilizing external appraisals. Although the underlying assets of the account cannot be quickly sold and converted to liquid assets, the TIAA general account provides the Plan with a liquidity guarantee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from Belhaven are recorded in the year in which the employee contributions are withheld from compensation.

Plan Loans

TIAA issues loans to plan participants outside the scope of the Plan. Participants pledge as security a portion of their balance in the TIAA Traditional Annuity Contract, which represents 110% of the outstanding loan balance. There were no defaulted plan loans collateral included in the net assets available for benefits at December 31, 2024 or 2023. Participants had outstanding plan loan balances due to TIAA-CREF totaling \$7,682 and \$15,025 at December 31, 2024 and 2023, respectively.

The Employee Benefit Security Administration (EBSA) has expressed concern that the pledging of collateral of a participant's balance could be considered a prohibited transaction; however, formal guidance has yet to be issued by EBSA.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit loss has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loans to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits payments are recorded when paid.

Administrative Expenses

All fees are paid by either the Plan Sponsor or forfeitures, except certain investment management fees and operating fees which are paid from the assets of the Plan.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA-CREF, a qualified institution and the Custodian of the Plan, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. Level 1 investments include a pooled separate account, mutual funds, and variable annuity accounts. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatiles, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. See the table below for inputs and valuation techniques used for Level 3 securities.

All plan investments are managed by an entity related to TIAA. Fees paid by the Plan for the investment management services are included as a reduction of investment income. The Plan's traditional annuity contract is maintained in TIAA-CREF's general account.

The Plan paid \$600 and \$823 of recordkeeping fees to TIAA during the years ended December 31, 2024 and 2023, respectively.

Belhaven provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed an interest to do so, Belhaven has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the IRC of 1986, as amended. The Plan has not requested or obtained a determination letter, as the Internal Revenue Service (IRS) does not currently provide that service for 403(b) plans. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and not subject to tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.
