Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN:

The following description of the Hueman People Solutions, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, adopted effective October 24, 2016, amended and restated July 1, 2022, is a defined contribution plan immediately covering employees of Hueman People Solutions, LLC (the Company, Employer, or Plan Sponsor) who have met service requirements and attained the age of 21; excluding temporary or seasonal employees. The Plan is a 401(k) profit sharing plan, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Board of Trustees is responsible for oversight of the Plan. The Plan's investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Employer contribution, and Plan earnings or losses and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their total account balance, including rollover contributions, any Employer match or discretionary contributions, plus actual earnings thereon.

Contributions

Each year, participants may contribute a percentage or flat dollar amount of pre-tax annual compensation, as defined by the Plan document, of at least 1% up to 90% of their eligible compensation, within the limitations prescribed by law. Participants may also make Roth 401(k) contributions, pursuant to Section 402A of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute rollovers or amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by John Hancock Life Insurance Company (U.S.A.) (John Hancock).

1. DESCRIPTION OF PLAN (CONTINUED):

Contributions (Continued)

The Employer makes a matching contribution of 50% of the first 6% of compensation each participant contributes to the Plan. In addition, the Employer may also decide to make a discretionary profit sharing contribution to the Plan. No such discretionary contributions were made for the years ended December 31, 2024 and 2023.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0-. Forfeitures are generated from excess match required to be returned as a result of compliance testing. These accounts will be used to reduce future administrative expenses or Employer match contributions. During the years ended December 31, 2024 and 2023, \$-0- in forfeitures were used.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan outstanding at any time and the loans are made for terms not to exceed five years, unless for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate equal to 2% above the prime rate. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, or any other reason, a participant, or beneficiary in the case of death, will receive a benefit payment in a single lump-sum amount equal to the value of the participant's vested interest in his or her account. Upon termination of employment, the Plan provides for a distribution of funds directly to the participant as soon as administratively feasible following severance of employment.

Other than termination, participants may not make in-service withdrawals from their contributions until they attain age 59 ½, in accordance with provisions specified in the Plan documents, or in the case of a financial hardship under specific circumstances. Participant consent is required for all distributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are maintained by John Hancock and are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, net of investment management fees.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. Excess deferrals of \$7,589 and \$16,592 were reduced from employee contributions for the years ended December 31, 2024 and 2023, respectively. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, as applicable.

Payment of Benefits

Benefits are recorded when paid.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan unless directly paid by the Employer. Other expenses for various service providers, including the third-party administrator and investment advisor, are paid directly from the Plan and are included in administrative expenses. Expenses paid by the Employer are excluded from these financial statements. Plan expense allocations are based on the value of the participant's account balance or proportionally allocated based on the number of participant accounts in the Plan, as defined by the Plan document.

Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events

The Plan's management has evaluated subsequent events for adjustment to or disclosure in the Plan's financial statements through October 14, 2025, the date the financial statements were available to be issued. No recordable or disclosable events occurred through this date.

3. FAIR VALUE MEASUREMENTS:

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. The fair value framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

3. FAIR VALUE MEASUREMENTS (CONTINUED):

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts – Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is based on the fair value of the underlying investments held by the fund less any liabilities as a practical expedient at the valuation date. Purchases and sales may occur daily within these accounts. As of December 31, 2024 and 2023, there were no unfunded commitments. Should the Plan initiate a full redemption on any of the pooled separate investment accounts, the redemption period is immediate.

Common collective trust – Valued at NAV of units held by the Plan after adjustment to reflect the fair values of the collective trust's underlying investments, including direct and indirect interest in fully benefit-responsive contracts, based on information reported by the investments advisor using the audited financial statements of the collective trust at year end. The NAV is used as a practical expedient to estimate fair value. As of December 31, 2024 and 2023, there were no unfunded commitments.

4. CERTIFIED INVESTMENTS:

As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator has elected that information certified by John Hancock not be subjected to any auditing procedures except for comparing such information to the information contained in the accompanying financial statements and supplemental schedule. Accordingly, John Hancock has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate at December 31:

5. TRANSACTIONS WITH PARTIES-IN-INTEREST:

Certain Plan assets are in investment funds managed by John Hancock. John Hancock provides services as a custodian and recordkeeper to the Plan. As described in Note 2, the Plan paid certain expenses to various service providers. These services qualify, as defined by ERISA, as party-in-interest transactions.

The Plan issues notes to participants, which are secured by the balances in the participants’ accounts. These transactions qualify as party-in-interest transactions.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. INCOME TAX STATUS:

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan. The Non-Standardized Pre-Approved Profit Sharing Plan received a favorable opinion letter from the IRS dated June 30, 2020. The letter states that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirement of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. CONCENTRATIONS:

Four investments comprised 60% of net assets available for benefits as of December 31, 2024. Four investments comprised 62% of net assets available for benefits as of December 31, 2023.
