NOTE 1 – DESCRIPTION OF PLAN

The following description of the Graves, Dougherty, Hearon & Moody 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, which covers eligible employees of Graves, Dougherty, Hearon & Moody, a professional corporation (Sponsor). The Plan was established effective January 1, 1989 and is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was amended and restated effective January 1, 2021.

Participation: Effective November 1, 2013, the Plan was amended regarding eligibility. Employees are eligible to immediately begin making salary deferral contributions upon employment as described in the plan document. The Plan has applied an automatic elective deferral enrollment provision. This provision states that if an employee has met the eligibility requirements and fails to provide the employer a salary reduction agreement a portion of such eligible employee's compensation will be automatically withheld and contributed to the Plan for employees hired on or after the effective date. Automatic enrollment for elective deferrals will not apply to eligible employees who fail to return a salary reduction agreement if they were an employee prior to the effective date. The initial amount of automatic elective deferral is 5%. Elective deferrals will be increased by 1% automatically on the first day of each calendar year for employees who are automatically enrolled up to a maximum of 10%.

Contributions: Employees may elect to contribute from 1% to 75% of either pretax or after tax annual compensation, as defined in the Plan, through payroll deductions. Effective July 1, 2000, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Total participant contributions in any calendar year are limited to the applicable limit under IRC section 402(g). Such contributions are recorded by the Plan in the period in which the Sponsor makes applicable payroll deductions.

Under the provisions of the Plan, the Sponsor may make matching contributions at its discretion. Employees are eligible to receive matching contributions upon their employment but must be employed as of the last day of the year to receive a matching contribution. For 2024, the Sponsor elected to make a matching contribution equal to 25% of participants total elective deferrals excluding catch-up contributions.

Under the provision of the Plan, the Sponsor may also make an additional discretionary employer contribution to the Plan. For Plan years prior to 2024, employees were eligible to receive a discretionary employer contribution if they had completed a year of service and were employed on the last day of the year and worked at least 1,000 hours during the Plan year. As of January 1, 2024, the Plan was amended to remove the year of service and hours requirement. For 2024, the Sponsor made a discretionary employer contribution of \$256,943.

If the Plan is a top-heavy plan according to the definition set forth in the plan document and the Sponsor makes discretionary employer contributions and matching contributions, the Sponsor's contributions shall be allocated based on the discretionary formula; however, if the allocation does not satisfy the top-heavy minimum allocation by design; the contribution shall instead be allocated first to non-key employees having less than the minimum top-heavy allocation in an amount equal to the initial allocation plus any additional amount necessary to provide the top-heavy minimum allocation. The Plan was top-heavy for 2024 and 2023.

Investment Options: Participants elect to have their contributions allocated among various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund as investment options for participants. Participants may modify, transfer existing balances, and obtain information regarding investments on a daily basis.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Sponsor's contributions, an allocation of Plan earnings (losses), and administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined in the plan document. The benefit to which each participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are fully vested in their contributions plus actual earnings thereon. If employment is terminated before a participant meets the requirements for retirement, the distribution from the employer discretionary accounts will be limited to the participant's vested portion. Vesting in employer and matching contributions is based on each employee's length of service. A participant will become fully vested after six years of credited service.

Notes Receivables From Participants: Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. Loans are repaid through regular payroll deductions over a period not to exceed five years, or not to exceed ten years for home loans. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local commercial banks for similar loans.

Payment of Benefits: Participants who terminate employment at normal retirement age (age 65), or due to disability or death, are entitled to receive 100% of the amounts in their plan accounts as of the day benefits are paid. If a participant terminates employment for any other reason before age 65, the participant is entitled to 100% of their account's vested balance. If a participant's total vested account balance exceeds \$7,000 as of the distribution date, they may receive a distribution from the Plan as soon as administratively feasible following termination of employment. If the participant does not consent to a distribution of their vested account balance, their balance will remain in the Plan. If a participant's total vested account balance under the Plan is \$7,000 or less as of the distribution date, they will be eligible to receive a distribution of their entire vested account balance in a lump sum as soon as administratively feasible following termination of employment. If a participant's total vested account balance under the Plan is between \$1,000 and \$7,000 as of the distribution date and they do not consent to a distribution of their vested account balance, their vested benefit automatically will be rolled over to an IRA selected by the Plan Sponsor. If a participant's total vested balance is \$1,000 or less as of the distribution date, their entire vested benefit will be distributed to them in a lump sum, even if they do not consent to a distribution.

Participants who reach age 59½ may receive an in-service distribution from certain accounts. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Forfeitures: When participants separate from service, any amounts that are not vested will be forfeited. Forfeitures may be used to reduce employer contributions to the Plan or to pay Plan expenses.

Administrative Expenses: The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. However, substantially all administrative expenses of the Plan are paid from the forfeiture account or the Sponsor. Expenses relating to specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant's account.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Plan Termination: Although it has not expressed any intent to do so, the Sponsor has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions and earnings thereon.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events: The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- *Level 1* – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

- *Level 2* – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- *Level 3* – Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Money Market Fund: The fair value of the money market fund investment is based upon the closing net asset value (NAV) per share of the fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 4 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Sponsor. Certain Plan investments are managed by the Vanguard Fiduciary Trust Company. These transactions qualify as party-in-interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transaction rules under ERISA. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan with CODA sponsored by the Vanguard Group. The preapproved profit sharing plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the pre-approved profit sharing plan, as then designed, was acceptable under section 401 of the IRC for use by the employer for the benefits of its employees. Although the Plan has been amended from the original pre-approved document, Plan management believes that the Plan is currently being operated in accordance with the requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
