### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of The Manor 401K Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Manor 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2022 and 2021 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of The Manor 401K Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information description of the Plan's provision.

**General**

The Plan is a defined contribution plan covering substantially all full-time employees and does not stipulate excluded employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and was established to provide eligible employees, and their beneficiaries, funds for retirement. The Plan was originally effective on October 1, 1997, amended on March 1, 2009 and restated in July 2022.

Bow and Arrow Inc. is the Plan Sponsor. The Plan includes employees from the Bow and Arrow Inc. and the Pleasantdale Chateau. Both companies have the same ownership structure. The Plan Administrator is responsible for oversight of the Plan and along with the investment adviser determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan recordkeeper and custodian is Capital Group and Capital Trust Company, respectively. The contract administrator is Altigro Retirement Services, LLC.

**Employee Eligibility and Contributions**

Employees of the Company reach the age of 21-years-old and one year of service are eligible to participate in the Plan. The service requirements are not applicable for employees hired on or before October 1, 1997. The entry date to the Plan is quarterly on the first day of the plan year and the first day of the fourth, seventh and tenth months of the plan year. The Plan automatically enrolls the eligible participant at 3% of the participant's eligible compensation unless they elect out. Employees may contribute pre-tax or Roth-401K contributions up to the Internal Revenue Service's contribution limits. Participants who have attained age 50 before the end of the plan are eligible to make catch-up contributions.

Participants may also contribute certain rollover amounts representing distributions from other qualified plans.

**Employer Contributions**

After one year of service and completion of 1,000 hours in the year of service, employees will be eligible for discretionary employer matching contributions although the Company is not required to do so. For the years ended December 31, 2022, and 2021, no employer contributions were made.

**Participant Accounts allocation**

Individual accounts are established for each participant. Each participant's account is credited with the participant's contributions, Plan earnings and charged with an allocation of investment gains or (losses), withdrawals, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits**

On termination of service due to death, retirement, or disability, a participant or participant's beneficiary may elect to receive a single lump sum payment equal to the value of the vested portion of his or her account, equal installments or partial payments as long as the balance is over \$1,000. Single lump sum payment is provided to balances under \$1,000. The Plan also allows for participant withdrawals in the event of financial hardship, limited to the dollar amount of participant elective deferrals. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or a rollover depending on the balance in their account.

**Vesting**

Participants contributions are 100% vested immediately. Employer match contributions have the following vesting schedule:

A participant's "vested percentage" is based on vesting years of service. A participant earns and accumulates a year of vesting for each year of continuous service. A participant is always 100% percent vested in his/her own deferred salary contribution to the Plan, but with respect to the Company's contributions, any unvested portion of his/her account shall be forfeited at termination.

Participants will become 100% vested in the company's matching upon death or disability.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum of \$50,000. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant accounts. Loan terms range from one to five years unless for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in The Wall Street Journal on the 14<sup>th</sup> of each month plus 2%. Principal and interest are paid ratably through payroll deductions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

This summary of significant accounting policies of the Plan is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Plan's administrator, who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States of America (GAAP) and have been consistently applied in the preparation of financial statements.

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America, except those benefits paid to Plan participants are recorded on a cash basis.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of certain assets and liabilities and change therein, disclosures of contingent assets and liabilities. Accordingly, the actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

**Contributions**

Contributions from employees are recorded as they are withheld from the participant's wages.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

All Plan expenses, including those without limitation, expenses and fees (including fees for legal services, accounting fees, and stock transfer charges rendered and fees to the custodian, administrator, investment manager, trustee, or any insurance company) shall be paid from the Plan if, and to the extent, the Company does not pay such expenses, fees and charges. Plan expenses of \$2,905 and \$2,085 were paid by the Plan in 2022 and 2021, respectively.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding expense account.

**Forfeited Accounts**

Forfeited amounts are used to first pay any administrative expenses and any remaining will be used to reduce any employer's contributions. There was \$0 in forfeitures during the year ended December 31, 2022.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The interest rates at December 31, 2022 varied from 5.5% to 7.50%. Related fees are recorded as administrative expenses and are recorded when they are incurred. The notes receivable from participants for December 31, 2022, and 2021 are \$37,810 and \$107,047 respectively.

**Recent Accounting Guidance**

There are no recent Financial Accounting Standards Board (FASB) pronouncements that impact on the Plan's Financial position and the change in net assets available for benefits.

**NOTE 3 - INVESTMENTS**

No auditing procedures were performed by the independent public accountants as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA with respect to information certified as complete and accurate by the custodians except for comparing such information with the related information included in the in the financial statements. The Plan's investments were held and administered by the trustees and American Funds of Capital Group for the years December 31, 2022, and 2021. Based on the information provided and certified by the custodian, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectable as defined by ERISA, as of December 31, 2022, and 2021.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board ("FASB") established a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's assets measured at fair value at December 31, 2022 and 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

The Capital Group is the recordkeeper, The Capital Trust Company, the custodian of the investment assets. Merrill, a Bank of America Company, is the investment manager and Altigro Retirement Services LLC is the contract administrator. These parties are related and qualify as party in-interest transactions however, they are exempt from the ERISA prohibited transaction rules. The total fees paid by the Plan were \$2,905 and \$2,085 for the year December 31, 2022, and 2021, respectively.

**NOTE 6- RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefit.

**NOTE 7 - FEDERAL INCOME TAX STATUS**

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore exempt from federal income taxes. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 7 - FEDERAL INCOME TAX STATUS (Continue)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions however, there are currently no audits for tax periods in progress. In addition, there are no tax released interest or penalties presented in these financial statements.

**NOTE 8 - PLAN TERMINATION**

Although it has not been expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account.

**NOTE 9 - SUBSEQUENT EVENTS**

For the year-ended December 31, 2022, the Plan Sponsor evaluated subsequent events for potential recognition and disclosure through October 10, 2023, the date of financial statements issuance.
