## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the  
Nekoosa Retirement Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements**

We have performed an audit of the financial statements of the Nekoosa Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (the 2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the 2024 financial statements is complete and accurate.

### **Opinion on the 2024 Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Their report dated October 9, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of Plan

The following description of Nekoosa Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Nekoosa Coated Products, LLC (the Company or the Plan Sponsor), excluding lease employees, employees regularly scheduled to work less than 1,000 hours per year, and employees subject to a collective bargaining agreement that does not provide for participation in the Plan. Employees are eligible to enter the Plan on the first day of the month following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Plan was amended and restated to facilitate the change in the Plan's qualified institution and recordkeeper, provide for safe harbor matching contributions, and adjust the percentage of eligible compensation able to be deferred from 100% to 50%. In conjunction with this amendment and restatement, the RTape Corp. UAW 401(k) Plan merged its participant accounts of approximately \$3,771,000 into the Plan and its participants joined the Plan upon having met the eligibility requirements of the Plan.

Effective January 1, 2024, the Plan's assets held at Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, Empower) were transferred to Delaware Charter Guarantee & Trust d/b/a Principal Trust Company (Principal). As of January 1, 2024, Principal is providing recordkeeping and trustee services for the Plan. The Plan's investment options with Principal are substantially similar to those offered for the Plan by Empower, the previous recordkeeper.

#### Contributions

Prior to January 1, 2024, eligible employees were automatically enrolled in the Plan and pre-tax contributions were withheld at 3% of eligible compensation, unless the employee elected otherwise. Participants could elect to contribute pre-tax and/or Roth contributions of up to 100% of eligible annual compensation, as defined in the Plan document.

Effective January 1, 2024, eligible employees are automatically enrolled in the Plan and pre-tax contributions are withheld at 4% of eligible compensation, unless the employee elects otherwise. On July 1 of each year, this will be increased annually by 1% of eligible compensation not to exceed 10%, unless the employee elects otherwise. Participants may elect to contribute pre-tax and/or Roth contributions of up to 50% of eligible annual compensation, not to exceed \$23,000 in 2024 plus an additional \$7,500 catch-up deferral for eligible employees who have attained age 50 prior to the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Effective January 1, 2024, the Company makes a safe harbor matching contribution equal to 100% of a participant's contributions to the Plan to the extent the contributions do not exceed 5% of their eligible compensation.

The Company may also make discretionary qualified nonelective contributions to non-highly compensated employees, at the discretion of the Company. No such additional discretionary qualified nonelective contributions were made for the year ended December 31, 2024.

### Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company contributions, and earnings and losses on the investments in their account, and is charged with certain administrative expenses and transaction fees. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions portion of their account is based on years of continuous service. For Company discretionary contributions, participants vest 20% per year of service and are fully vested after 5 years of service. A participant is also considered fully vested upon reaching early or normal retirement age, death, or permanent disability.

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one note receivable outstanding at any time. The notes receivable are secured by the balance in the participant's account. During 2024, notes receivable had fixed rates of 4.16% to 10.50% for the term of the note receivable, not to exceed 5 years, unless used for the purchase of a residence. Principal and interest are paid through payroll deductions.

### Payments of Benefits

At the time of retirement, death, disability, or termination of employment, a participant or their beneficiary may receive the payment of the vested interest in their account in a lump sum distribution. If a participant's account balance is \$5,000 or less upon termination of service, the Plan may pay the benefits owed in a lump sum without participant consent. In-service withdrawals are also permitted for participants who have attained age 59½. Participants are eligible to receive hardship withdrawals when certain conditions are met.

### **Forfeited Accounts**

Forfeited non-vested account balances totaled \$114 and \$125,745 as of December 31, 2024 and 2023, respectively. These accounts may be used to reduce future employer safe-harbor or discretionary matching contributions or pay Plan administrative expenses. During 2024, the Plan used forfeitures of \$220,331 to reduce employer safe-harbor matching contributions. During 2024, the Plan used forfeitures of \$4 to pay Plan administrative expenses.

### **Administrative Expenses**

The Plan pays certain administrative fees, such as record keeping and advisory fees. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan. Participants pay expenses through earnings sharing based on their account balances. Transaction fees related to specific participant transactions are charged directly to the specific participant account. Expenses paid to service providers of the Plan qualify as party-in-interest transactions.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

### **Contributions**

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. Employer safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. Once approved by the Company, the employer discretionary qualified nonelective matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. Any unfunded employee or employer contributions are included in the employee or employer contribution receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board's Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Company estimates the current credit risk associated with employer contribution receivables. The Company determined that no allowance for credit losses was necessary as of December 31, 2024 and 2023, and there was no activity in the allowance for credit losses during 2024.

### **Valuation of Investments and Income Recognition**

The Plan's investments are stated at fair value, except for the guaranteed interest account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments and net change in contract value of the guaranteed interest account includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

### **Notes Receivable from Participants**

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note receivable repayments and the plan administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced, and a benefit payment is recorded. Notes receivable from participants qualify as party-in-interest transactions.

### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to participant contributions. The Plan distributed 2023 excess contributions payable in accordance with IRS regulations in 2024. There were no excess contributions for the year ended December 31, 2024.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Reclassifications**

Certain amounts in the 2023 financial statements have been reclassified to conform with the 2024 presentation. The effects of the reclassifications are not considered material to the financial statements taken as a whole.

### Subsequent Events

The Plan's management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

### 3. Information Certified by the Qualified Institutions

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net change in fair and contract value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan's administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal), Empower Annuity Insurance Company of America, and Empower Trust Company, LLC, the Plan's qualified institutions.

### 4. Investments

During 2024 and as of December 31, 2024, certain Plan investments include shares of pooled separate accounts and a guaranteed interest account managed by Principal, a service provider of the Plan. Accordingly, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair and contract value of investments, as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to several risks such as interest rate, market, currency, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, and other similar events. It is at least reasonably possible that changes in fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

Investments in pooled separate accounts (PSAs) and common/collective trust funds (CCTs) are valued daily using their net asset value (NAV). The NAVs are based on the fair value of the mutual funds, stocks, debt instruments, and other securities in the accounts. Participants can trade the PSAs and CCTs daily at the published NAV (Level 2).

The Plan invests in a stable value fund held in a common collective trust, which trades at the NAV of the units held by the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. The fund is invested primarily in U.S. treasury and other U.S. government securities and corporate bonds. Were the Plan to initiate a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

During 2024, the Plan invested in a guaranteed interest account. The guaranteed interest account is a fully benefit-responsive investment contract and is a general obligation of Principal. Principal maintains the contributions in a general account. The account is credited with interest at a guaranteed interest rate Principal declares for a set period of time. During 2024, the net crediting rate ranged from 4.65% to 5.05%. The Plan's investment in this account is stated at contract value. Contract value of the guaranteed interest account represents deposits and transfers made to the account, plus earnings at guaranteed crediting rates, less withdrawals and fees. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become fully vested in their accounts.

### 6. Income Tax Status

Beginning January 1, 2024, the Plan is operating under a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) offered by Principal. The Internal Revenue Service has determined and informed Principal by a letter dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). As of December 31, 2023, the Plan was operating under a prototype plan document developed by CCH Incorporated, dba ftwilliam.com (CCH). The Internal Revenue Service had determined and informed CCH, by letter dated June 30, 2020, that the written form of the underlying prototype plan document was designed and in accordance with the applicable sections of the IRC. Although the Plan has not obtained an individual determination letter and has been

amended since receiving the opinion letters, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
