Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Coway USA Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.



- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Assets Held for Investment Purposes as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that is agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note A - Description of Plan

The following description of Coway USA Inc. 401(k) Plan (the "Plan") provides only general information. Readers should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Coway USA Inc. (the "Company"). Employees become eligible to make elective deferral contributions who are at least 21 or older at employment and complete 3 months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may elect to defer up to 100% of their compensation on a pre-tax basis, excluding reimbursement or other expense allowances, moving expenses, deferred compensation, and welfare benefits, not to exceed the limits of Code Sections 401(k), 402(g), 404 and 415; \$23,000 and \$22,500 per annum for 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year may be eligible to contribute an additional \$7,500 in both 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contribution into various investment options offered by the Plan. Employees become eligible for matching contributions only if they make deferral contributions. The Company may make a discretionary matching contribution, a discretionary profit sharing contribution, and a discretionary qualified non-elective contribution to the Plan on employees' behalf. There were no discretionary profit sharing contributions for 2024 and 2023. Participants always be 100% vested in their elective deferral account, rollover contribution account, in-plan Roth rollover account and qualified non-elective contribution account.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and, plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Interest in participant's matching contribution account and profit sharing contribution account are vested on participant's years of vesting service in accordance with the following schedule:

"Year of Vesting Service" means a 12-month period of time beginning on date of hire. All periods of service and less than whole year periods of service will be aggregated on the basis that 12 months of service (30 days are deemed to be a month in the case of the aggregation of fractional months) or 365 days of service constitutes a whole year of vesting service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of one-half the present value of their vested account balance or \$50,000 minus the highest outstanding balance of loans in the past 12 months. Participants may apply only one loan each calendar year and have only one loan outstanding at any given time. Loans will only be made to persons who the Plan Administrator determines have the ability to repay the loan. Loans must be paid in full on termination of employment. The loans are secured by the balance in the participant's account and bear interest at prime rates on the issuance date plus 1%. Principal and interest payments are made through payroll deduction from each regular paycheck. As of December 31, 2024, interest rates on loan to participants ranged from 4.50% to 9.50%.

Top-Heavy Plan

If more than 60 percent of assets in the Plan are held by employees who are considered key employees, the Company may need to make an additional contribution to the Plan for participants who are not key employees.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a single lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts

If an employee is terminated before fully vested in the Company's contribution portion of his or her account, such unvested amount is forfeited. Forfeitures may be applied first to payment of plan administration expenses. Any remaining amounts will be used towards the Company's matching contributions. As of December 31, 2024, the balance of unallocated forfeiture totaled approximately \$1,791.

SECURE 2.0 Act

On December 29, 2022, the Securing a Strong Retirement Act (SECURE 2.0 Act) became law. The purpose of the legislation is to expand access to retirement plans and to help working Americans increase their retirement savings. The SECURE 2.0 Act includes various required and option provisions that will become effective between 2023 and 2033, certain of which are described below.

- Beginning in 2023, the age for required minimum distributions will increase from age 72 to 73. Beginning in 2033, the age for required minimum distributions will increase from age 73 to 75.
- Beginning in 2025, a participant from the ages 60 to 63 can elect catch-up contributions up to the limit of the greater of \$10,000 or 150% of the catch-up contribution limit imposed by the IRS.
- Beginning in 2025, long-term part-time workers (defined as employees who have worked for two consecutive 12-month periods during each of which they have at least 500 hours of service) will become eligible to enroll in their employer's retirement plan after two years.
- Beginning in 2026, catch-up contributions will be made on a Roth basis, unless the participant earns \$145,000 or less.

Additionally, Plan management has not yet determined which of the optional provisions, if any, the Plan will implement. Plan management expects to formally amend the Plan by December 31, 2025.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The fair value of the Plan's mutual fund investments is determined by quoted market prices on the last day of the Plan year. Notes Receivable from participants are stated at cost, which approximates fair value. Investment transactions are recorded as of the trade date. The Plan's investments are valued at investment market value, which represent the net asset value of shares held by the Plan at year-end. Interest and dividend income are recorded on the accrual basis.

Note C - Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements on December 31, 2024 and 2023, the supplemental schedule on December 31, 2024, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Trust Company (the custodian of the Plan).

Note D - Fair Value Measurement

The Plan measures fair value in accordance with Accounting Standard Codification ("ASC") 820 - Fair Value Measurements. ASC 820 defines fair value and establishes a three-level valuation hierarchy for disclosures of fair value measurements. ASC 820 establishes a framework for measuring fair value in generally accepted accounting principles, and expands disclosures about fair value measurements. To increase consistency and comparability in fair value measurements and related disclosures, ASC 820 establishes a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value into three (3) broad levels. The fair value hierarchy gives the highest priority to quoted prices (unadjusted) in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three (3) levels of fair value hierarchy defined by ASC 820 are:

Level 1 - Inputs are unadjusted, quoted prices in active markets for identical assets or liabilities at the measurement date.

Level 2 - Inputs (other than quoted market prices included in Level 1) are either directly or indirectly observable for the asset or liability through correlation with market data at the measurement date and for the duration of the instrument's anticipated life.

Level 3 - Inputs reflect management's best estimate of what market participants would use in pricing the asset or liability at the measurement date. Consideration is given to the risk inherent in the valuation technique and the risk inherent in the inputs to the model. Valuation of instruments includes unobservable inputs to the valuation methodology that are significant to the measurement of fair value of assets or liabilities.

As defined by ASC 820, the fair value of a financial instrument is the amount at which the instrument could be exchanged in a current transaction between willing parties, other than in a forced or liquidation sale, which was further clarified as the price that would be received to sell an asset or paid to transfer a liability ("an exit price") in an orderly transaction between market participants at the measurement date.

Note E - Group Annuity Contract

In 2019, the Plan entered in a custodial guaranteed interest option group annuity contract that has been issued by Principal Life Insurance Company (Principal Life) to Principal Trust Company as custodian. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0 percent. The crediting rate is reviewed on a semiannual basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Note F - Related Party Transactions

Certain Plan investments in registered investment companies are managed by the custodian of the Plan. Any purchases and sales of these funds are performed in the open market at fair value and qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note G - Federal Income Taxes

The Plan has received an updated post-Tax Reform Act of 1986 favorable determination letter from the Internal Revenue Service indicating that the Plan is a qualified plan under Section 401(a) and 401(k) of the Internal Revenue Code (the "IRC") and the Plan is exempt from federal income taxes under Section 501(a) of the IRC. Although the plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan administrator is not aware of any uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note H - Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In such event, all participants would become fully vested in their account balances.

Note I – Legal Matter

The Plan Sponsor is currently involved in a legal proceeding initiated by the DOL on September 23, 2024. The complaint alleges non-compliance with the Fair Labor Standards Act (FLSA) in connection with unpaid overtime wages and improper record-keeping for certain employees. The Plan Sponsor acknowledges that the litigation may potentially lead to settlement discussions, but the outcome remains uncertain. Given the complexity and early stage of the proceeding, the Plan Management cannot estimate the likelihood of a material adverse impact or quantify the potential financial liability at this time.

Note J – Plan Qualification

In a letter dated December 15, 2022, the DOL informed the Company that they would be conducting a review of the Plan to determine compliance with the provisions of ERISA. The DOL has initiated a review of the Plan, the results of which are pending. As of the date of this audit report, the DOL review of the Plan is still underway, and the DOL's final findings and recommendations have not yet been issued to the Plan Sponsor.

Note K - Subsequent Events

The Plan Administrator has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued under FASB ASC Topic 855, Subsequent Events.
