1. DESCRIPTION OF THE PLAN

The following description of the United Pacific Forest Products, Inc. ("the Company") 401(k) Plan ("the Plan") provides only general information. Reference should be made to the Plan document for a more complete description of its provisions.

**GENERAL.** The Plan was established July 1, 2010, and is a defined contribution 401(k) and profit sharing plan covering employees of the Company who have met certain periods of service and age requirements. The Plan's trustees manage the operation and administration of the Plan. Empower Trust Company, LLC serves as the investment advisor, record-keeper, and custodian of the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

**CONTRIBUTIONS.** Contributions to the Plan are in the form of salary reductions which participants have elected to defer in lieu of current compensation. Effective January 1, 2022, the plan was amended to reinstate an employer safe-harbor matching contribution. The employer is required to make matching contributions equal to 100% of the participants' contributions that are not in excess of 4% of the participants' eligible compensation.

**PARTICIPANT ACCOUNTS.** Each participant's account is credited with an allocation of (a) employee elective deferrals, (b) employer contribution as defined above, and (c) Plan earnings. Item (a) is allocated based on participants' elective contributions. Items (b) and (c) are allocated based on participants' contributions, relative eligible compensation, and account balances, as defined and specified in the Plan document.

**VESTING.** Participants are fully vested in their elective and rollover contributions plus earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested after six years of credited service, and also upon death, disability or upon reaching normal retirement age. Effective January 1, 2015, the Plan became a "safe harbor 401(k) plan". This type of plan requires a matching contribution equal to 100% of the salary deferrals not to exceed 4% of compensation. This safe harbor matching contribution follows the six-year vesting schedule.

**ADMINISTRATIVE EXPENSES.** Generally, fees associated with the administrative expenses of the Plan include professional fees, office supplies, and payroll expenses of administrative and clerical personnel, and they are provided for by the Company without charge to the Plan. Expenses not paid by the Company are deducted from investment earnings before allocation to participants' accounts.

**PAYMENT OF BENEFITS.** On termination of service, due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account, receive installment payments over the participants' life expectancy, roll their account balance to another company's qualified plan or IRA, or defer distribution until a later date of their choosing (if the balance exceeds \$5,000). At December 31, 2024 and 2023, there were no amounts allocated to accounts of participants who had elected to withdraw from the Plan, but had not been paid.

1. DESCRIPTION OF THE PLAN - Continued

**HARDSHIP WITHDRAWALS.** Pre-retirement distributions of elective deferrals are available on a hardship basis. These distributions are limited to the specific financial need and are available only after utilizing all other distribution and loan options available under the Plan's provisions. They must be approved by the employer and administered on a nondiscriminatory basis.

**INVESTMENT OPTIONS.** Upon enrollment, a participant may direct contributions to certain investment accounts selected by the Trustees. Participants may change their investment options daily.

**FORFEITED ACCOUNTS.** Forfeited accounts shall be made available to reinstate previously forfeited account balances of former participants, if any. Any remaining balance may be used to reduce the contribution of the employer or reduce plan expenses. As of December 31, 2024 and 2023, the forfeiture account balance was \$1,114 and \$1,094, respectively. The forfeitures are being held in the guaranteed interest funds.

**NOTES RECEIVABLE FROM PARTICIPANTS.** Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance (\$1,000 minimum) and are treated as notes receivable from participants measured at unpaid principal balance plus accrued but unpaid interest.

Note terms range from one to six years, are secured by the balance in the participant's account, and bear interest at a rate commensurate with the profit-sharing local lending market. Principal and interest are paid ratably through regular payroll deductions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan employs accounting policies generally accepted in the United States of America. The Financial Accounting Standards Board ("FASB") has issued guidance which establishes the FASB Accounting Standards Codification (the "Codification" or "FASB ASC") as the source of authoritative accounting principles recognized by the FASB to be applied to nongovernmental entities in the preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America.

**BASIS OF ACCOUNTING.** The accompanying financial statements have been prepared on the accrual basis of accounting.

**USE OF ESTIMATES.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**VALUATION OF INVESTMENTS – MUTUAL FUNDS.** Investments in mutual funds are carried at fair value, which is the net asset value per unit of each mutual fund multiplied by the number of units owned. The value of each unit is computed by the mutual fund company on the last business day of the plan year, based on quoted market prices of the underlying securities, bonds and other financial instruments owned by each fund.

**VALUATION OF INVESTMENTS – GUARANTEED INTEREST FUNDS.** The methodology for calculating the interest crediting rate on guaranteed interest accounts is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. Plan management and the custodian consider the fund investments to not be considered fully benefit responsive at the plan level.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

**VALUATION OF INVESTMENTS – VARIABLE INTEREST FUNDS.** The methodology for calculating the interest crediting rate is based on the underlying contracts and prevailing market conditions. Account balances and rates are calculated daily.

**NOTES RECEIVABLE FROM PARTICIPANTS.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan documents.

**PAYMENT OF BENEFITS.** Benefits are recorded when paid.

**RISKS AND UNCERTAINTIES.** The Plan provides for investment options primarily in mutual funds, which invest in portfolios of investment securities through Empower Trust Company, LLC, the custodian of the Plan assets. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

From time to time, investments may include securities and contractual cash flows, such as asset backed securities, collateralized mortgage obligations, and commercial mortgage-backed securities including securities backed by subprime mortgage loans. The value, liquidity, and related income of these securities are sensitive to changes in economic conditions including real estate values, delinquencies, or defaults, or both, and they may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan has implemented the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC 740, *Income Taxes*. Using that guidance, the Plan does not believe it has any uncertain tax positions that qualify for either recognition or disclosure in the financial statements as of December 31, 2024 and 2023.

**SUBSEQUENT EVENTS.** The Plan has evaluated subsequent events through October 7, 2025, the date that the financial statements were available for issue.

3. FAIR VALUE MEASUREMENTS AND DISCLOSURES

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 for financial assets and financial liabilities are described below:

Level 1	Values are based on unadjusted quoted prices in active markets for identical securities.
Level 2	Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets in non-active markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.
Level 3	Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. These inputs may reflect the Plan's estimates of the assumptions that market participants would use in valuing the financial asset or financial liability.

Pursuant to FASB ASC 820, fair value is a market-based measure, considered from the perspective of a market participant who owns an asset or owes a liability. Accordingly, when market observable data is not readily available, assumptions are set to reflect those that market participants would be presumed to use in pricing the asset or liability at the measurement date. Prices and inputs are used that are current as of the measurement date, including during periods of market disruption. In periods of market disruption, the ability to observe the prices and inputs may be reduced for many instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or from Level 2 to Level 3.

4. INCOME TAX STATUS

Effective January 1, 2022, the Plan was restated in its entirety using a volume submitter as its plan document. The volume submitter obtained its latest opinion November 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements under section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the applicable requirements of the Internal Revenue Code, and therefore believes the Plan is qualified and the related trust is tax exempt.

5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become fully vested in all their accounts.



1. DESCRIPTION OF THE PLAN

The following description of the United Pacific Forest Products, Inc. ("the Company") 401(k) Plan ("the Plan") provides only general information. Reference should be made to the Plan document for a more complete description of its provisions.

**GENERAL.** The Plan was established July 1, 2010, and is a defined contribution 401(k) and profit sharing plan covering employees of the Company who have met certain periods of service and age requirements. The Plan's trustees manage the operation and administration of the Plan. Empower Trust Company, LLC serves as the investment advisor, record-keeper, and custodian of the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

**CONTRIBUTIONS.** Contributions to the Plan are in the form of salary reductions which participants have elected to defer in lieu of current compensation. Effective January 1, 2022, the plan was amended to reinstate an employer safe-harbor matching contribution. The employer is required to make matching contributions equal to 100% of the participants' contributions that are not in excess of 4% of the participants' eligible compensation.

**PARTICIPANT ACCOUNTS.** Each participant's account is credited with an allocation of (a) employee elective deferrals, (b) employer contribution as defined above, and (c) Plan earnings. Item (a) is allocated based on participants' elective contributions. Items (b) and (c) are allocated based on participants' contributions, relative eligible compensation, and account balances, as defined and specified in the Plan document.

**VESTING.** Participants are fully vested in their elective and rollover contributions plus earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested after six years of credited service, and also upon death, disability or upon reaching normal retirement age. Effective January 1, 2015, the Plan became a "safe harbor 401(k) plan". This type of plan requires a matching contribution equal to 100% of the salary deferrals not to exceed 4% of compensation. This safe harbor matching contribution follows the six-year vesting schedule.

**ADMINISTRATIVE EXPENSES.** Generally, fees associated with the administrative expenses of the Plan include professional fees, office supplies, and payroll expenses of administrative and clerical personnel, and they are provided for by the Company without charge to the Plan. Expenses not paid by the Company are deducted from investment earnings before allocation to participants' accounts.

**PAYMENT OF BENEFITS.** On termination of service, due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account, receive installment payments over the participants' life expectancy, roll their account balance to another company's qualified plan or IRA, or defer distribution until a later date of their choosing (if the balance exceeds \$5,000). At December 31, 2024 and 2023, there were no amounts allocated to accounts of participants who had elected to withdraw from the Plan, but had not been paid.

1. DESCRIPTION OF THE PLAN - Continued

**HARDSHIP WITHDRAWALS.** Pre-retirement distributions of elective deferrals are available on a hardship basis. These distributions are limited to the specific financial need and are available only after utilizing all other distribution and loan options available under the Plan's provisions. They must be approved by the employer and administered on a nondiscriminatory basis.

**INVESTMENT OPTIONS.** Upon enrollment, a participant may direct contributions to certain investment accounts selected by the Trustees. Participants may change their investment options daily.

**FORFEITED ACCOUNTS.** Forfeited accounts shall be made available to reinstate previously forfeited account balances of former participants, if any. Any remaining balance may be used to reduce the contribution of the employer or reduce plan expenses. As of December 31, 2024 and 2023, the forfeiture account balance was \$1,114 and \$1,094, respectively. The forfeitures are being held in the guaranteed interest funds.

**NOTES RECEIVABLE FROM PARTICIPANTS.** Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance (\$1,000 minimum) and are treated as notes receivable from participants measured at unpaid principal balance plus accrued but unpaid interest.

Note terms range from one to six years, are secured by the balance in the participant's account, and bear interest at a rate commensurate with the profit-sharing local lending market. Principal and interest are paid ratably through regular payroll deductions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan employs accounting policies generally accepted in the United States of America. The Financial Accounting Standards Board ("FASB") has issued guidance which establishes the FASB Accounting Standards Codification (the "Codification" or "FASB ASC") as the source of authoritative accounting principles recognized by the FASB to be applied to nongovernmental entities in the preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America.

**BASIS OF ACCOUNTING.** The accompanying financial statements have been prepared on the accrual basis of accounting.

**USE OF ESTIMATES.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**VALUATION OF INVESTMENTS – MUTUAL FUNDS.** Investments in mutual funds are carried at fair value, which is the net asset value per unit of each mutual fund multiplied by the number of units owned. The value of each unit is computed by the mutual fund company on the last business day of the plan year, based on quoted market prices of the underlying securities, bonds and other financial instruments owned by each fund.

**VALUATION OF INVESTMENTS – GUARANTEED INTEREST FUNDS.** The methodology for calculating the interest crediting rate on guaranteed interest accounts is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. Plan management and the custodian consider the fund investments to not be considered fully benefit responsive at the plan level.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

**VALUATION OF INVESTMENTS – VARIABLE INTEREST FUNDS.** The methodology for calculating the interest crediting rate is based on the underlying contracts and prevailing market conditions. Account balances and rates are calculated daily.

**NOTES RECEIVABLE FROM PARTICIPANTS.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan documents.

**PAYMENT OF BENEFITS.** Benefits are recorded when paid.

**RISKS AND UNCERTAINTIES.** The Plan provides for investment options primarily in mutual funds, which invest in portfolios of investment securities through Empower Trust Company, LLC, the custodian of the Plan assets. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

From time to time, investments may include securities and contractual cash flows, such as asset backed securities, collateralized mortgage obligations, and commercial mortgage-backed securities including securities backed by subprime mortgage loans. The value, liquidity, and related income of these securities are sensitive to changes in economic conditions including real estate values, delinquencies, or defaults, or both, and they may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan has implemented the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC 740, *Income Taxes*. Using that guidance, the Plan does not believe it has any uncertain tax positions that qualify for either recognition or disclosure in the financial statements as of December 31, 2024 and 2023.

**SUBSEQUENT EVENTS.** The Plan has evaluated subsequent events through October 7, 2025, the date that the financial statements were available for issue.

3. FAIR VALUE MEASUREMENTS AND DISCLOSURES

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 for financial assets and financial liabilities are described below:

Level 1	Values are based on unadjusted quoted prices in active markets for identical securities.
Level 2	Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets in non-active markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.
Level 3	Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. These inputs may reflect the Plan's estimates of the assumptions that market participants would use in valuing the financial asset or financial liability.

Pursuant to FASB ASC 820, fair value is a market-based measure, considered from the perspective of a market participant who owns an asset or owes a liability. Accordingly, when market observable data is not readily available, assumptions are set to reflect those that market participants would be presumed to use in pricing the asset or liability at the measurement date. Prices and inputs are used that are current as of the measurement date, including during periods of market disruption. In periods of market disruption, the ability to observe the prices and inputs may be reduced for many instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or from Level 2 to Level 3.

4. INCOME TAX STATUS

Effective January 1, 2022, the Plan was restated in its entirety using a volume submitter as its plan document. The volume submitter obtained its latest opinion November 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements under section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the applicable requirements of the Internal Revenue Code, and therefore believes the Plan is qualified and the related trust is tax exempt.

5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become fully vested in all their accounts.
