**Note 1. Description of the Plan**

The following description of Hattiesburg Medical Park Management Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Hattiesburg Medical Park Management (Company) for the benefit of its employees who have at least one year of service and are age 21 or older. Related employers who also participate in the Plan are listed below:

- Bedford Alzheimer's Care Center, LLC
- Bedford Care Center-Warren Hall, LLC
- Bedford Care Center of Hattiesburg, LLC
- Bedford Care Center of Mendenhall, LLC
- Bedford Care Center of Newton, LLC

- Bedford Care Center of Marion, LLC
- Bedford Care Center-Monroe Hall, LLC
- Hattiesburg Medical Park Management Corp.
- HMP Nursing Services, Inc.
- Unicare Rx, Inc.
- Walnut Square Pharmacy, LLC

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Life Insurance Company, and Principal Life Insurance Company on behalf of Principal Global Investors Trust Company serve as the Trustees and third-party administrators of the Plan. The Company serves as the Plan Administrator.

**Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual pretax contributions subject to the limitations set forth in the Internal Revenue Code (IRC). Employee rollover contributions are also permitted. The Company makes matching contributions of 50% of employees' salary deferral amounts on the first 6% of employees' compensation and profit-sharing contributions. Company profit-sharing contributions are discretionary as determined by the Company's Board of Directors. Contributions are subject to certain limitations.

Effective July 1, 2024 the Plan was amended to allow for an automatic deferral feature, whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 6%.

**Participant Investment Account Options**

Investment account options available include various mutual funds, an investment contract, and pooled separate accounts. Each participant has the option of directing his contributions into any of the various investment options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of credited service. The nonvested balance is forfeited upon termination of service.

Regardless of the years of employment, the participant's employer contributions account becomes fully vested in the event of death, disability, or the attainment of normal (age 65) retirement age.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their account balance, reduced by any outstanding loan balance. The loans are secured by the balance in the participant's account. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

***Payment of Benefits***

Upon retirement, the participant may elect to receive benefits in substantially equal annual payments over a fixed period of whole years, a specified dollar amount each year, or a single sum payment. Upon death of a participant prior to retirement, benefits are paid to the surviving spouse through a qualified preretirement survivor annuity. A single sum payment will be paid to a participant's beneficiary who does not have a spouse who is entitled to the qualified preretirement survivor annuity. Hardship distributions are also available from a participant's vested account, including earnings thereon, subject to regulatory requirements.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$17,731 and \$23,481, respectively. These accounts may first be used to offset the Plan's administrative costs and then used to reduce employer contributions. In 2024 and 2023, employer contributions were reduced by \$22,218 and \$10,628 from forfeited nonvested accounts, respectively.

***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are stated at fair value as determined by publicly quoted prices available on an active market. The Plan's interest in investments held in the collective investment trust and pooled separate accounts are valued at net asset value (NAV) as provided by the Trustees utilizing the practical expedient at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Contributions***

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit loss has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loans to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustees**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, and Principal Life Insurance Company on behalf of Principal Global Investors Trust Company, the Trustees of the Plan, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

**Note 4. Disclosure About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities that the entity can access at the measurement date
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

**Recurring Measurements**

There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. The Plan's Level 1 investments include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. The Plan has no Level 2 or 3 investments.

**Note 5. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, or a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are units of pooled separate accounts and collective investment trusts managed by Principal Life Insurance Company and Principal Trust Company. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments.

The Plan paid \$72,509 and \$65,107 of administrative fees to the Trustees during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

**Note 6. Tax Status**

The Plan Sponsor operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and custodial document sponsored by Principal Life Insurance Company and Principal Trust Company. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained

or requested a determination letter. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Subsequent Events**

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
