## Independent Auditor's Report

To the Plan Administrator and Participants of the  
Insurance Company Supported Organizations 401(k) Savings Plan as adopted by  
California FAIR Plan Association

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the Insurance Company Supported Organizations 401(k) Savings Plan (the "Plan") as adopted by California FAIR Plan Association, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedules Required by ERISA***

The supplemental schedule of assets held at end of year December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## 1. Description of the Plan

The following description of the Insurance Company Supported Organizations 401(k) Savings Plan (the “Plan”) as adopted by California FAIR Plan Association provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### *General*

The Insurance Company Supported Organizations offers organizations that support the provision of residual market insurance, a 401(k) retirement arrangement under which participating organizations (employers) each are sponsors of individual 401(k) plans administered through a common recordkeeper and with a common investment platform held in a group trust.

The audited Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (the “Code”) covering all employees of California FAIR Plan Association (the “Association”, “Employer” and “Plan sponsor”). The trustee and custodian of the Plan assets is the Voya Retirement Insurance and Annuity Company (“Trustee”). The Named Fiduciaries of the Insurance Company Supported Organizations 401(k) Savings Plan c/o AIPSO serves as the Plan administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is currently in conformity with all Internal Revenue Service (“IRS”) and Department of Labor rules and regulations.

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act (“Secure 2.0 Act”) was passed by Congress. The Secure 2.0 Act contains numerous provisions that impact employee benefit plans. Generally, the deadline for formally adopting any required plan amendments made pursuant to the Secure 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effective dates of each new provision. The Plan has administratively complied with and adopted all applicable provisions of the Secure 2.0 Act for the years ended December 31, 2024 and 2023. Plan management expects the Plan to be formally amended prior to the Secure Act 2.0 deadline.

### *Eligibility*

Employees are eligible to participate in the Plan immediately upon hire. Employees can make contributions to the Plan and receive safe harbor matching contributions on the first day of the calendar month coinciding with or immediately following the date they perform an hour of service.

### *Contributions*

Under the terms of the Plan, eligible employees may make elective deferral contributions on a pre-tax basis. They may elect to defer up to 75% of their plan compensation on a pre-tax basis but must defer at least 1%. They may also elect to make a voluntary contribution to the Plan on an after-tax basis ranging from 1% to 75% of their plan compensation. Their combined elective deferral contribution election and voluntary contribution election may not exceed 75% of their plan compensation. The IRS specifies the maximum annual amount of elective deferral contributions (\$23,000 for employees under age 50 and \$30,500 for employees ages 50 and over in 2024). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

**1. Description of the Plan (Continued)**

***Contributions (Continued)***

The Association makes employer safe harbor matching contributions in an amount equal to 100% of the employee contributions that are not in excess of 6% of their plan compensation. In addition to the safe harbor matching contributions, the Association may make additional discretionary non-elective contributions. For the year ended December 31, 2024, the Association made \$793,293 and \$0 of safe harbor matching contributions and discretionary non-elective contributions, respectively.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, including the earnings and losses on these contributions, and an allocation of the Association's matching and non-elective contribution. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Investment Options***

The Plan provides a variety of investment options with differing risk and growth characteristics. As of December 31, 2024 and 2023, Plan's net assets available for benefits were invested in the mutual funds and guaranteed investment contract. Participants may change their investment allocations and/or transfer their account balances among the various funds at any time.

***Vesting***

Participants are always fully vested in the contributions.

***Notes Receivable from Participants***

Participants may borrow from their accounts, subject to Code regulations, up to the lesser of a) \$50,000 reduced by the excess, if any, of the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan over the current outstanding balance of loans as of the date of the new loan; b) 50% of the vested balances in the Plan. The minimum loan amount is \$1,000. All loans are required to be repaid within five years of the date of the loan. The outstanding loans are secured by the balance in the participant's account. The interest applied to the loan is the prime interest rate plus one percent, or such other reasonable rate established by the Plan administrator. Principal and interest are paid ratably through payroll deductions. The notes mature through December 2029. The unpaid balance of any loan is immediately payable upon termination of employment and maybe offset against the participant's vested account.

***Benefit Payments and Withdrawals***

Benefits start on a participant's normal retirement date if the participant is no longer an employee and has a vested account under the Plan. The participant may choose to have benefits paid on this date even if the participant is still an employee. Normal retirement means the first day of the month on or after the participant reaches age 65.

If a participant's employment ceases as a result of termination, normal retirement, death or disability, the participant or participant's beneficiaries are entitled to receive the value of the participant's vested interest. Participants or their beneficiaries may receive benefit payments in a lump-sum amount equal to the value of the participant's vested interest, in installments over a period determined by the participant, or a direct transfer to a qualified plan of equivalent value. The Plan allows for in-service distributions if a participant reaches age 59 ½ and hardship distributions subject to Plan provisions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**2. Summary of Significant Accounting Policies (Continued)**

***Forfeited Accounts***

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures may be used to pay Plan's administrative expenses or reduce future Employer's contributions. The forfeiture account balance was \$158 and \$8,956 as of December 31, 2024, and 2023. During 2024, forfeitures of \$8,907 were applied to reduce the Employer's contributions to the Plan and no non-vested accounts were forfeited.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value (except for the fully-responsive guaranteed investment contract discussed in Note 5, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. In accordance with the Plan's policy of stating investment at fair value, net unrealized gains for the year are included in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of securities are recorded on a trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold, as well as unrealized gains and losses on investments held during the year.

***Administrative Expenses***

Most of the expenses incurred in maintaining the Plan are paid by the Plan sponsor. These expenses include fees of the Plan's custodian and third-party administrators. The expenses of maintaining the Plan paid directly by the Plan sponsor are excluded from these financial statements. Fees related to the administration of notes receivable or distributions of participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in the fair value of investments. Administrative expenses for the year ended December 31, 2024 were \$3,775.

**3. Information Prepared and Certified by the Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, investments and notes receivable on December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan.

**4. Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Quoted market prices in active markets for identical assets or liabilities.

*Level 2* - Observable market-based inputs or unobservable inputs that are corroborated by market data, such as quoted prices for similar assets or liabilities or model-derived valuations.

*Level 3* - Unobservable inputs that are not corroborated by market data.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the quoted market price of shares held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There are no redemption restrictions or future commitments on the instruments that use net asset value as the practical expedient.

**5. Guaranteed Investment Contract**

The Plan has entered into a Synthetic Guaranteed Investment Contract (“GIC”) with Prudential Trust Company (“Prudential”), provided through a group annuity contract. Under the terms of the group annuity contract, a crediting rate is established for amounts invested in the GIC and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. The contract meets the fully benefit-responsive investment contract criteria, notwithstanding the contract provisions that limit the ability of the plan to transact at contract value when a market value event occurs. Because the GIC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC.

No events limit the ability of the Plan to transact at contract value so long as the contract remains in force. Except for events which may result in termination for cause, as outlined in the contract (e.g. Plan termination or merger, early retirement incentive, layoffs, etc.), Prudential may not cause the contract to be terminated at an amount other than contract value. The Plan administrator believes that any events that would limit the Plan’s ability to transact at contract value with participants are not probable of occurring. None of these events occurred during 2024.

**6. Related Party and Party-In-Interest Transactions**

The Plan’s engages in transactions involving acquisition or disposition of units in funds managed by the Trustee. These transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan allows participants to borrow from their vested balances. These transactions qualify as party-in-interest transactions and are exempt from prohibited transaction rules under ERISA.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

**8. Tax Status**

The Plan sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable IRS opinion letter dated June 30, 2020. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability or (asset) if the plan takes a position that is more likely than not to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**10. Subsequent Events**

Management has evaluated subsequent events through September 16, 2025, which is the date the financial statements were available to be issued. No events have occurred subsequent to December 31, 2024 requiring recording or disclosure in these financial statements.
