# UBEO WEST REGION 401(k) RETIREMENT PLAN

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the UBEO West Region 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Ray A. Morgan Company, LLC (the Company) who meet certain eligibility criteria. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

The Board of Directors of the Company approved the merger of the Plan into the UBEO, LLC 401(k) Retirement Plan (the "Ubeo Plan"). The Company and UBEO, LLC ("Ubeo"), the plan sponsor of the Ubeo Plan, are both wholly owned subsidiaries of UBEO Midco, LLC. As a result of the merger, the Company became a participating employer in the Ubeo Plan effective March 15, 2024. On March 15, 2024, the majority of the Plan's assets were transferred to the Ubeo Plan, totaling \$25,290,557, including \$655,578 of notes receivables. Subsequent to year end on January 2, 2025, the remaining plan assets of \$522,674 were transferred to the Ubeo Plan related to an investment in a fixed annuity contract that cannot be terminated before the scheduled maturity date.

#### **Administration**

The Company is the Plan Sponsor and Plan Administrator. Three members of management serve as trustees to the Plan. Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, "Empower Retirement") is the Plan's custodian and recordkeeper.

#### **Eligibility**

Employees of the Company that are not nonresident aliens or represented by a collective bargaining agreement are eligible to participate in the Plan. Employees are eligible to make salary deferrals and receive a matching contribution 31 days after their date of employment and attainment of age twenty-one. Employees can be enrolled on the first date of the calendar month coinciding with the date eligibility requirements are met.

#### **Contributions**

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan, up to the maximum amount allowable in accordance with applicable sections of the Internal Revenue Code (IRC). Participants may also rollover contributions from other qualified retirement plans, at the discretion of the Plan Administrator. During 2024 and 2023, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of up to \$7,500.

The Company may make a discretionary matching contribution in an amount to be determined each year. The discretionary matching contribution is made to eligible participants, as defined above, who make salary deferrals to the Plan. During 2024 and 2023, the Company made matching contributions equal to 50% of each participant's elective deferral up to a maximum of 3% of the participant's compensation. During the 2024 Plan year, participant and employer contributions were made through February 29, 2024.

## 1. DESCRIPTION OF PLAN (Continued)

### **Contributions (Continued)**

The Company may make additional discretionary employer contributions in an amount to be determined each year. Employees become eligible for the employer contributions upon completion of at least 1,000 hours of service during the 12-month period following the date of hire. The Company made no additional discretionary employer contributions to the Plan for the year ended December 31, 2024 or 2023.

### **Participant Accounts**

Each participant's account is allocated with the participant's contributions, the Company's matching contributions, the Company's discretionary contributions, Plan earnings (losses), forfeitures, and administrative expenses. Company discretionary contributions are allocated to participants equally. Allocations are based on participant earnings and losses and plan expenses on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions and actual earnings and losses thereon. Participants become vested in their matching and discretionary employer contributions based on a five-year graded vesting schedule at a rate of 20% each year. Participants are also fully vested upon attainment of age 65, death, or total and permanent disability.

### **Forfeitures**

Forfeitures of matching and discretionary employer contributions are used to reduce future employer matching contributions or cover Plan expenses. Forfeitures of non-vested account balances and earnings on unused amounts totaled \$103 and \$21,162 in 2024 and 2023, respectively. During 2024, the remaining forfeiture balance of \$38,243 was transferred to the Ubeo Plan. During 2023, \$16,897 were used offset employer contributions. At December 31, 2024, there were no forfeited account balances available. At December 31, 2023, there were \$38,140 available to offset future expenses or employer contributions.

### **Notes Receivable from Participants**

Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless they are used to purchase a primary residence, in which case repayment may be made over a maximum of fifteen years. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of Prime plus 1% at the first business day of the month that the loan is originated. The Plan allows for participants to have a maximum of one active loan. Principal and interest are paid ratably through payroll deductions. Loans in default must be paid before another loan may be issued.

### **Benefit Payments**

The Plan provides for normal retirement benefits upon termination of service due to death, disability or attainment of retirement age. The normal retirement age is the date a participant reaches the age of 65. Participants may elect disbursement of their vested account balance in either a lump-sum amount or direct rollover into an individual retirement account or another qualified plan. Vested account balances of \$5,000 or less are paid as lump sum distributions or rollover distributions as soon as administratively possible. Distributions due to termination or disability may be deferred until the participant retires if the value of their account exceeds \$5,000.

## 1. DESCRIPTION OF PLAN (Continued)

### **In-Service Withdrawals**

Participants may elect disbursement of all or part of their vested account balance upon attainment of age 59 ½.

### **Hardship Withdrawals**

Hardship withdrawals from the Plan are permitted from a participant's vested account balance. All hardship withdrawals are subject to the Company's approval and must comply with the rules relating to hardships, which are uniformly applicable to all participants.

### **Plan Termination**

Effective March 15, 2024, the Plan was amended to legally merge the Plan into the Ubeo Plan. The majority of the Plan's assets were transferred into the Ubeo Plan on March 14, 2024, and subsequent to year-end, the remaining plan assets were transferred into the Ubeo Plan.

### **Administrative Expenses**

The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. Expenses relating to specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant's account.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements are prepared in accordance with accounting principles generally accepted in the United States of America.

### **Interest-Bearing Cash**

Interest-bearing cash may include bank demand deposits accounts, money market accounts and all highly liquid debt instruments purchased with a maturity of three months or less. The Plan's cash balances may at times exceed federally insured limits. The Plan has not experienced any losses in these accounts and believes it is not exposed to any significant risk with respect to cash and cash equivalents.

### **Investments and Income Recognition**

The Plan's investments in mutual funds and fixed annuity are reported at fair value as reported by the custodian. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. The net appreciation (depreciation) in the fair value of investments consists of both realized and unrealized gains and losses on the Plan's investments.

### **Fair Value Measurements - Definition and Hierarchy**

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Fair Value Measurements - Definition and Hierarchy (Continued)**

The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

### **Benefit Payments**

Benefits are recorded when paid.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### **Risks and Uncertainties**

Investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amount reported in the financial statements.

### **Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates and such differences may be significant.

Empower Trust Company, LLC certified the following information as complete and accurate as of December 31, 2023 and for the period January 1, 2023 through March 15, 2024. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Interest-bearing cash:* fair value approximates the carrying amounts of such instruments due to their short maturity.

*Mutual funds:* valued at fair value based on quoted market prices.

*Fixed annuity:* valued based on observable inputs of existing contracts and readily available financial information of the issuing financial institutions.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. PARTY-IN-INTEREST TRANSACTIONS

Empower Retirement is the custodian and the recordkeeper of the Plan assets for the years ended December 31, 2024 and 2023. Consequently, transactions involving Empower Retirement and the Plan qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

#### 6. TAX STATUS

The Internal Revenue Service has determined, by letter dated June 30, 2020, that the written form of the underlying volume submitter plan document is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan has been amended since receiving that determination letter. The Plan has not yet applied for its own determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
