

Reasonable Cause for Failure to Attach Accountant's Opinion

For the 2024 plan year, Solesis, LLC has not had sufficient time to complete the audit of the Solesis 401(k) Plan. Our prior plan was divided into two separate plans for 2024, The Secant Group, LLC 401(k) Plan & the Solesis, LLC 401(k) Plan, and a newly acquired entity, Polyzen, LLC, was transferred under one of these plans. This restructuring increased the audit's scope & complexity, leading to unforeseen timing constraints. Furthermore, access to certain records was delayed due to the loss of HRIS access for Polyzen, LLC prior to the start of the audit.

The audit is still in process and is expected to be completed as soon as feasibly possible. Once the audit has been completed, an amended Form 5500 and the auditor's opinion report for the plan year ending December 31, 2024 will be filed.

Solesis, LLC respectfully requests that any penalties that could apply to the failure to attach an audit report at this time be abated.
