We have performed audits of the financial statements of Golden Moments 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. A. Description of Plan

The following description of the Golden Moments 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering all employees of Golden Moments LLC (Plan sponsor) and affiliated participating employer, JD Enterprises Inc., (collectively, the Employer or Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.
2. *Eligibility.* Employees become eligible to participate in the Plan, for both employee and Employer contributions, once they have completed one year of service and are 21 years of age or older. Employees are eligible for Employer nonelective contributions if they have met the age requirement and are employed on the last day of the Plan year (or have at least 550 service hours during the Plan year).
3. *Contributions.* Each year, participants may contribute up to 100% percent of pre-tax or after-tax annual compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Employer makes a safe harbor matching contribution on behalf of contributing participants each year which is equal to 100% of employee contributions up to 3% of eligible compensation plus 50% up to 5%. Nonelective or discretionary matching contributions may be contributed at the option of the Employer. No such nonelective or discretionary matching contributions were made to the Plan for 2024. Participants direct the investment of their contributions and the Employer's contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

4. *Participant accounts.* Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as allocations of the Employer's nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
5. *Vesting.* Participants are vested immediately in their contributions, Employer safe harbor or discretionary matching contributions, plus actual earnings thereon. Vesting in the Employer's nonelective portion of their accounts is based on years of continuous service and a six-year graded schedule. Separate rules apply in the event of disability or death of a participant.

6. *Payment of benefits.* Upon termination of service due to death, disability, or retirement, a participant can receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, installments, or partial withdrawals. Distributions after termination of employment for reasons other than the above shall commence as soon as administratively feasible. Participant consent is required for account distributions over \$7,000. In addition, the Plan allows for hardship distributions if certain criteria are met.
7. *Forfeited accounts.* At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,019 and \$3,296, respectively. These accounts will be used to reduce future Employer contributions or Plan expenses. No forfeitures were used during the year ended December 31, 2024.

B. Summary of Accounting Policies

1. *Basis of accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).
2. *Use of estimates.* The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. *Investment valuation and income recognition.* Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodian and investment advisors.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

4. *Payment of benefits.* Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Expenses related to distributions are charged directly to the participant's account and are included in administrative expenses. Recordkeeping and administrative fees are charged directly to administrative expenses. Investment related expense are included in net appreciation/depreciation in fair value of investments.

5. *Subsequent events.* The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

C. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, and United of Omaha Life Insurance Company (Mutual of Omaha), the trustee and former custodian, respectively, have certified that the following data included in the Plan's financial statements and supplemental schedules is complete and accurate. Matrix Trust Company has certified information as of and for the year ended December 31, 2024. Mutual of Omaha has certified information as of December 31, 2023.

The Plan's independent accountant did not perform auditing procedures with respect to the above information, except for comparing such information to related information in the financial statements and supplemental schedules.

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective trusts: Valued at the NAV of units held by the Plan at year-end. NAV is calculated using the fair value of the underlying securities, and is available to participants.

Pooled separate accounts: The underlying assets of the pooled separate accounts consist of funds known as sub-accounts. Each sub-account invests its shares or units in an underlying mutual fund. Sub-accounts are measured in terms of accumulation units. The sub-accounts are valued based on the quoted market prices of the mutual funds. Certain fund fees and expenses, mortality and risk charges, and administration charges are deducted from the value of the mutual funds to arrive at the value of the sub-accounts. The accumulation units are valued at NAV on a daily basis. The NAV is made publicly available by the issuer.

Investment Contract with Insurance Company

The Plan previously held a fully benefit-responsive investment contract with the former custodian, Mutual of Omaha. Contributions were maintained by Mutual of Omaha in their general accounts. The accounts were credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value is the relevant measure for benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

E. Party in Interest Transactions

Plan investments are managed by the trustee and former custodian, and therefore, these transactions qualify as party in interest transactions. Additionally, fees were paid to parties in interest for recordkeeping, administration, and investment management.

F. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

G. Tax Status

The Plan adopted a non-standardized defined contribution plan with CODA that has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the non-standardized plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

I. Prohibited Transaction

During 2023, the Company inadvertently failed to deposit \$114,664 of participant contributions within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Company has corrected the failure and has deposited lost earnings in 2025 and has made required filings with the DOL. The correction and any excise taxes were made from the Company's assets and not from assets of the Plan.



Notes to Financial Statements
December 31, 2024 and 2023

A. Description of Plan

The following description of the Golden Moments 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering all employees of Golden Moments LLC (Plan sponsor) and affiliated participating employer, JD Enterprises Inc., (collectively, the Employer or Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.
2. *Eligibility.* Employees become eligible to participate in the Plan, for both employee and Employer contributions, once they have completed one year of service and are 21 years of age or older. Employees are eligible for Employer nonelective contributions if they have met the age requirement and are employed on the last day of the Plan year (or have at least 550 service hours during the Plan year).
3. *Contributions.* Each year, participants may contribute up to 100% percent of pre-tax or after-tax annual compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Employer makes a safe harbor matching contribution on behalf of contributing participants each year which is equal to 100% of employee contributions up to 3% of eligible compensation plus 50% up to 5%. Nonelective or discretionary matching contributions may be contributed at the option of the Employer. No such nonelective or discretionary matching contributions were made to the Plan for 2024. Participants direct the investment of their contributions and the Employer's contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

4. *Participant accounts.* Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as allocations of the Employer's nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
5. *Vesting.* Participants are vested immediately in their contributions, Employer safe harbor or discretionary matching contributions, plus actual earnings thereon. Vesting in the Employer's nonelective portion of their accounts is based on years of continuous service and a six-year graded schedule. Separate rules apply in the event of disability or death of a participant.

6. *Payment of benefits.* Upon termination of service due to death, disability, or retirement, a participant can receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, installments, or partial withdrawals. Distributions after termination of employment for reasons other than the above shall commence as soon as administratively feasible. Participant consent is required for account distributions over \$7,000. In addition, the Plan allows for hardship distributions if certain criteria are met.
7. *Forfeited accounts.* At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,019 and \$3,296, respectively. These accounts will be used to reduce future Employer contributions or Plan expenses. No forfeitures were used during the year ended December 31, 2024.

B. Summary of Accounting Policies

1. *Basis of accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).
2. *Use of estimates.* The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. *Investment valuation and income recognition.* Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodian and investment advisors.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

4. *Payment of benefits.* Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Expenses related to distributions are charged directly to the participant's account and are included in administrative expenses. Recordkeeping and administrative fees are charged directly to administrative expenses. Investment related expense are included in net appreciation/depreciation in fair value of investments.

5. *Subsequent events.* The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

C. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, and United of Omaha Life Insurance Company (Mutual of Omaha), the trustee and former custodian, respectively, have certified that the following data included in the Plan's financial statements and supplemental schedules is complete and accurate. Matrix Trust Company has certified information as of and for the year ended December 31, 2024. Mutual of Omaha has certified information as of December 31, 2023.

The Plan's independent accountant did not perform auditing procedures with respect to the above information, except for comparing such information to related information in the financial statements and supplemental schedules.

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">▪ quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective trusts: Valued at the NAV of units held by the Plan at year-end. NAV is calculated using the fair value of the underlying securities, and is available to participants.

Pooled separate accounts: The underlying assets of the pooled separate accounts consist of funds known as sub-accounts. Each sub-account invests its shares or units in an underlying mutual fund. Sub-accounts are measured in terms of accumulation units. The sub-accounts are valued based on the quoted market prices of the mutual funds. Certain fund fees and expenses, mortality and risk charges, and administration charges are deducted from the value of the mutual funds to arrive at the value of the sub-accounts. The accumulation units are valued at NAV on a daily basis. The NAV is made publicly available by the issuer.

Investment Contract with Insurance Company

The Plan previously held a fully benefit-responsive investment contract with the former custodian, Mutual of Omaha. Contributions were maintained by Mutual of Omaha in their general accounts. The accounts were credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value is the relevant measure for benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

E. Party in Interest Transactions

Plan investments are managed by the trustee and former custodian, and therefore, these transactions qualify as party in interest transactions. Additionally, fees were paid to parties in interest for recordkeeping, administration, and investment management.

F. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

G. Tax Status

The Plan adopted a non-standardized defined contribution plan with CODA that has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the non-standardized plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

I. Prohibited Transaction

During 2023, the Company inadvertently failed to deposit \$114,664 of participant contributions within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Company has corrected the failure and has deposited lost earnings in 2025 and has made required filings with the DOL. The correction and any excise taxes were made from the Company's assets and not from assets of the Plan.
