Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements the Irritec USA Retirement Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management, having determined it is permissible in the circumstances, has elected to have the audits of Irritec USA Retirement Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

December 31, 2024 and 2023

NOTE 1 - Description of Plan:

The following brief description of Irritec USA Retirement Trust is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Irritec USA Retirement Trust covers substantially all employees of Irritec USA, Inc. (the Company), the plan sponsor. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Vesting

A participant's vested right in the safe harbor contribution account is 100%. Employees are also 100% vested in employee contributions. Effective January 1, 2023, a six-year vesting schedule was implemented.

Participant loans

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The maximum duration of loans is five years for general purpose loans, and fifteen years for residential loans. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% - 10.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan is reduced, and the delinquent participant loan is recorded as a benefit payment based on the terms of the Plan document.

Payment of benefits

Upon the attainment of normal retirement age, or in the event of termination of an employee's participation by reason of his death or disability, the full value of his Company contribution account shall become vested and nonforfeitable.

The unvested portion of a participant's Company contribution account shall be forfeited and used to reduce future employer contributions.

Upon retirement or permanent disability, the participant shall receive their portion of the Company contribution account by payment in a lump sum.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0-. These accounts are used to reduce future employer contributions. During the years ended December 31, 2024 and 2023, no amounts were forfeited or used to supplement employer contributions.

Plan expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration are included as expenses on the statement of changes in net assets available for benefits and charged directly to the participant's account.

(continued)

Termination of Plan

The Company shall have the right to amend the Plan by resolution of the Board of Trustees and to amend or cancel any amendments, provided that no amendment shall attempt to cause any of the assets of the Plan to be used for or diverted to purposes other than for the exclusive benefit of participants or their beneficiaries.

In the event the Company elects to terminate the Plan or discontinues operation of its business, the entire interest of the participants shall vest 100% immediately and be nonforfeitable.

Employer contributions

For each year an employee of Irritec USA, Inc. participates in the Plan, the Company may, from its net profits or accumulated net profits, make a contribution of such amount as determined in accordance with a resolution of the Board of Directors. The amount of the contribution may not obligate the Company to contribute, for any year, any sums which are estimated to be in excess of the amount which the Company would be permitted to deduct on its Federal income tax return for such year. In no event shall the annual addition to the account of each participant with respect to any given plan year exceed the lesser of the limitation provided by Section 415 of the Internal Revenue Code (\$69,000 and \$66,000 for 2024 and 2023), or 25% of each participant's compensation during such year. Additionally, the Company made a nonelective contribution equal to 4% of the employee's compensation for 2024. For the years ended December 31, 2024 and 2023, the Company made net contributions in the amount of \$242,006 and \$226,769, respectively.

Employee contributions

Employees eligible to participate in the plan can contribute up to the maximum amount allowable under Internal Revenue Service codes. Additionally, each employee directs the ratio or fixed amount to be allocated to one of several investment options offered by the Company. All contributions by participants in the plan are self-directed and can be invested in various funds offered through Principal Life Insurance Company.

Subsequent events

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.

NOTE 2 - Summary of significant accounting policies:

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and present the net assets available for plan benefits and changes in those assets at current values. The difference between the current value and the cost of the investments is reflected in the statement of changes in net assets available for benefits as appreciation (depreciation) of investments.

Management estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management and the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Federal income taxes

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no significant uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The plan administrator believes it is no longer subject to income tax examinations for the years prior to December 31, 2021.

Information certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's Trustee has certified that the following data included in the accompanying financial statements is complete and accurate: (a) investments as shown in the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and (b) investment income as shown in the statement of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023. The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Concentrations of risk

The Financial Accounting Standards Board requires disclosure in the financial statements relating to concentrations of risk and financial instruments with off-balance-sheet risk. Financial instruments that potentially subject the Plan to concentrations of risk consist of investments.

The Plan has significant amounts of investments which are uninsured and subject to market value fluctuations. The Plan had \$6,080,545 and \$4,866,015 invested at December 31, 2024 and 2023, respectively, subject to this type of risk.

Related party transactions

Certain Plan investments are shares of mutual funds managed by Principal Life Insurance Company. Principal Life Insurance Company is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Fair value of financial instruments

Unless otherwise indicated, the fair value of all reported assets and liabilities which represent financial instruments (none of which are held for trading purposes) approximates the carrying values of such amounts.

Fair value measurements

The Financial Accounting Standards Board (FASB) has provided a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Reclassifications

Certain reclassifications have been made to the prior year presentation in order for it to conform to the current year presentation.

NOTE 3 – Investments at fair value:

The Plan's investments are reported at their fair value at the measurement date. The fair value of the investment in mutual funds, common stock and unit investment trusts are based on using quoted market prices in active markets. The Plan Administrator has obtained certification from the Plan Trustee, Principal Life Insurance Company in 2024 and 2023, that the information summarized below is complete and accurate. The following tables present by level, within the fair value hierarchy, the Plan's investment assets at fair value:

ASU 2018-09 Amended Subtopic 962-325, "Plan Accounting - Defined Contribution Plans – Investment – Other" removes the stable value common collective trust fund from the illustrative example in paragraph 962-325-55-17 to avoid the interpretation that such an investment would never have a readily determinable fair value and, therefore, would always use the NAV practical expedient. This new guidance has prompted us to change our suggested input level for PSAs and CCTs from NAV as a practical expedient to a level 1 input. Based on the above, they do have a readily determinable fair value.

NOTE 4 – Allocation of assets:

Net assets available in the amount of \$212,420 and \$136,776 at December 31, 2024 and 2023 respectively, have been allocated to the accounts of employees who have withdrawn from the Plan.

NOTE 5 - Plan status:

Each year, plan documents, eligibility tests (ACP and ADP tests) 5500's, etc., are all prepared by a third-party administrator as required by the Internal Revenue Service (IRS). The Plan has applied for a determination letter from the IRS and received an acceptance letter stating that their Plan is qualified under the Internal Revenue Code.

The Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes the Plan is qualified and the related trust is tax-exempt.
