### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Southside Medical Center, Inc. SAVE Retirement Plan Part II (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Southside Medical Center, Inc. SAVE Retirement Plan Part II's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024, and 2023, and for the years then ended, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

### ***Opinion***

## **Note 1. Description of the Plan**

### ***General***

The following description of Southside Medical Center, Inc. SAVE Retirement Plan Part II (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan sponsored by Southside Medical Center, Inc. (the “Company”) for the benefit of its noncontract employees. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Company. Participants are required to attain age 21 and have one year of service to qualify for Company contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Ascensus Trust Company (Ascensus) serves as the Plan’s primary custodian. The Variable Annuity Life Insurance Company (VALIC) still holds certain plan assets at December 31, 2024 and 2023.

### ***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation, considering this percentage does not exceed the maximum amount allowed by law. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company may make discretionary matching contributions, which had historically been 50% of employees’ salary deferral amounts up to 6% of employees’ compensation and discretionary nonelective contributions as determined by the Company’s Board of Directors. Contributions are subject to certain limitations.

The Company no longer contributes elective deferral contributions to the accounts held at VALIC.

### ***Participant Investment Account Options***

Investment account options available include various funds. Each participant has the option of directing their account into any of the separate investment accounts and may change the allocation daily.

### ***Participant Accounts***

Each participant’s account is credited with the participant’s contributions, the Company’s contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company’s contribution portion of their accounts plus earnings thereon is based on years of eligible service. A participant is fully vested after six years of eligible service. The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce the employer contributions, pay plan expenses, or be reinstated or reallocated to participants.

### ***Payment of Benefits***

Participants may elect to receive either a lump-sum amount equal to the value of their account, or installments over a period not more than the participant’s assumed life expectancy or the assumed life expectancy of the participant and his beneficiary. Annuity contracts are no longer benefit payment options.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,003 and \$15,959, respectively. These accounts will be used to offset plan expenses, reduce future employer contributions, or reinstate or reallocate to participants in the same manner as employer contributions. In 2024 and 2023, there were no plan expenses that were reduced from forfeited nonvested accounts. In 2024 and 2023, employer contributions were reduced by \$8,757 and \$0, respectively, from forfeited nonvested accounts. From time to time, the forfeited nonvested accounts are reinstated or reallocated to the participants at the Company's discretion. In 2024 and 2023, \$0 and \$28,735 of forfeitures were reallocated to participants, respectively.

***Notes Receivable from Participants***

The plan document with Ascensus Trust Company includes provisions authorizing loans from the Plan to active, eligible participants. Loans are made to any eligible participant. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If any payment of principal and interest, or any portion thereof, remains unpaid for more than 90 days after due, the loan will be considered to be in default. Outstanding loan balances in default will be treated as the outstanding balance of the loan, including accrued interest, and will be treated as a deemed distribution subject to federal income tax regardless of whether or not a distributable event has occurred.

Participants who have a severance of employment prior to the end of the loan term will be required to pay off the loan immediately after the severance of employment or when they are no longer a party in interest. Nonpayment will force a deemed distribution and reporting of taxable income for the year the deemed distribution occurs.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Registered separate accounts and general accounts are valued at estimated fair value as provided by VALIC.

The group annuity contract is recorded at contract value, as reported by VALIC, which represents contributions made under the contract, plus interest at the contract rate, less withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Loans***

VALIC issued loans to plan participants outside the scope of the Plan. Participants pledge as security a portion of their VALIC account balance, which represents 100% of the outstanding loan balance. The pledged assets are invested in the Loan Collateral and Escrow Funds and earn an effective interest rate equal to 3% below the adjustable rate charged for the loan. The amount pledged as collateral at December 31, 2024 and 2023, was \$30,016 and \$35,705, respectively. Of the amounts pledged as collateral, \$30,016 and \$35,705, respectively, related to loans that are considered in default by VALIC at December 31, 2024 and 2023. As the Plan still holds the assets of the participants associated with the defaulted notes, these amounts are considered to be plan assets and continue to accrue interest at rates ranging between 4.25% and 9.50%. When the participant has a distributable event, the amount of the defaulted collateral balance plus any accrued interest will be deducted from their account prior to distribution.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

The Plan has established a nonallocated revenue sharing plan account to pay necessary and reasonable plan-related expenses or to be allocated to participants in accordance with the Department of Labor's guidance. The Company is responsible for determining what expenses the third-party administrator will reimburse from the account and what amounts will be reallocated to the participants. Increases (decreases) to the account from revenue sharing were \$4,165 and (\$28,904) at December 31, 2024 and 2023, respectively. During the years ending December 31, 2024 and 2023, the Plan received \$42,041 and \$37,147, respectively, of revenue sharing funds. During the years ending December 31, 2024 and 2023, the Plan reallocated revenue sharing funds of \$38,418 and \$67,321, respectively, to the participants. No administrative expenses were paid from the account in 2024 and 2023. The account balance at December 31, 2024 and 2023, was \$42,583 and \$38,418, respectively, and is included in the investments account on the statement of net assets available for benefits.

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

### **Note 3. Certification of Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus and VALIC, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### **Note 4. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of investments managed by Ascensus and VALIC, which are custodians of the Plan.

The Plan paid no record keeping fees to VALIC during 2024 and 2023. The Plan paid \$5,655 and \$3,094 of record keeping fees to Ascensus Trust Company during 2024 and 2023, respectively. The Company pays certain accounting and auditing fees relating to the Plan and provides certain administrative services at no cost to the Plan.

### **Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets.

**Note 6. Group Annuity Contracts with Insurance Companies**

In 1996, the Plan entered into a group annuity contract with VALIC. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive, therefore, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3% for the VALIC contract. Such interest rates are reviewed on a monthly basis for resetting. At December 31, 2024 and 2023, there were total assets of \$9,148 and \$8,649 invested in the group annuity contract with VALIC.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 10. Tax Status**

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and custodial document sponsored by Ascensus, LLC. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.
