**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of TAYLOR TRUCK LINE, INC. 401(K) PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

#### NOTE A. DESCRIPTION OF THE PLAN

The following description of the TAYLOR TRUCK LINE, INC. 401(K) PLAN (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution profit-sharing plan with 401(k) features. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

#### Eligibility

Eligible employees of the Plan Sponsor may participate after reaching the age of 19 and completing a minimum of one year of service and 1,000 hours. Employees will begin participation in the Plan either January 1st or July 1st following the date the eligibility requirements are met.

#### Contributions

Each year, participants may contribute pretax and/or post-tax annual compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The employer may make matching contributions equal to a discretionary percentage to be determined by the employer. The employer has made matching contributions of \$102,932 and \$91,338 for the years ended December 31, 2024 and 2023, respectively.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the employer's matching contributions, the employer's discretionary profit sharing contributions, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investments

Participants direct the investment of their contributions and the employer's matching contributions into any of the 48 different investment funds.

### NOTES TO FINANCIAL STATEMENTS

#### **NOTE A. DESCRIPTION OF THE PLAN (Continued)**

##### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The Plan applies a five year graduated vesting schedule for employer discretionary matching contributions and profit sharing contributions. Participants will be 100% vested in their matching contributions five years from the date of their hire or at the time of death, disability, or retirement, provided the person has reached normal retirement age.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate published in the Wall Street Journal.

Loans require repayment within six to sixty months from the loan date, unless the loan is for the purchase of the participant's primary residence, in which case the repayment term is sixty one to one hundred eighty months.

##### Payment of Benefits

If employment terminates for reasons other than death, disability or early or normal retirement, participants are entitled to receive only the vested percentage of their account balance. If the account balance does not exceed \$5,000, a distribution will be made regardless of whether the participant consents to receive it.

##### Forfeitures

Forfeited nonvested accounts are used to either reduce the Company's matching contributions or to pay plan expenses in accordance with the provisions of the Plan. The balance of forfeited nonvested accounts as of December 31, 2024 and 2023 was \$1,781 and \$0, respectively. The balance of the forfeiture account is kept in the Fidelity Investments Money Market Fund. For the years ended December 31, 2024 and 2023, administrative expenses of \$654 and \$1,695, respectively, were paid with forfeitures.

##### Significant Costs

Taylor Truck Line Inc. absorbs significant costs for the Plan audit fees.

#### **NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### Basis of Accounting

The accompanying financial statements and supplemental schedule of the Plan were prepared in accordance with accounting principles generally accepted in the United States of America.

##### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect amounts reported on the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

##### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

##### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the Federated Capital Preservation Fund valued at contract value, as disclosed in Note F. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value was determined using the net asset values of mutual funds, which was determined by the net asset value of the underlying shares.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as received.

##### Excess Contributions Payable

The Plan had excess contributions payable of \$66,924 and \$46,034 for the years ended December 31, 2024 and 2023, respectively. This was a result of contributions in excess of the Code's limits.

##### Payment of Benefits

Benefits are recorded when paid.

##### Administrative Expenses

A portion of the Plan administration costs were paid through forfeited balances in 2024 and 2023.

##### Tax Positions Interest and Penalty

Interest recognized on underpayment of income taxes is recorded to interest expense. Penalties recognized on tax positions are recorded to income tax expense. During the years ended December 31, 2024 and 2023, there were no underpayment interest or penalties to recognize.

#### **NOTE C. INCOME TAX STATUS**

The Plan Prototype obtained its latest opinion letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan Prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

The Plan has been amended since receiving the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

#### **NOTE D. CERTIFICATION BY THE TRUSTEE**

The plan administrator obtained and agreed to certifications as to the completeness and accuracy of investment assets and notes receivable from participants aggregating \$8,646,107 and \$7,354,730 as of December 31, 2024 and 2023, respectively, and the related net investment income, including the net appreciation (depreciation) in fair value of such assets, of \$1,143,843 and \$1,143,843 for the years ended December 31, 2024 and 2023, respectively. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule of the Plan based on such certifications from the Trustee (Trust Point Inc.) as being complete and accurate.

#### **NOTE E. FAIR VALUE MEASUREMENTS**

FASB ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of fair value hierarchy under FASB ASC 820 are described below:

##### *Events that Limit the Ability to Transact at Contract Value*

Amendments to the Plan Documents (including complete or partial plan termination of merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the participants are probable of occurring.

#### **NOTE G. PARTY-IN-INTEREST TRANSACTIONS**

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption applies. The Trustee is a party-in-interest as a result of providing trustee services to the Plan and investment of Plan assets in its investment funds. However, such transactions are exempt under Section 408(b)(8) and are not prohibited by ERISA.

The Plan sponsor provides administration services for the Plan at no fee.

#### **NOTE H. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company's contributions.

#### **NOTE I. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through July 25, 2025, the date which the financial statements were available to be issued, and has determined that there were no material events requiring recognition or disclosure.
