## INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the  
Gelia Wells & Mohr, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Gelia Wells & Mohr, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

**NOTE 1. DESCRIPTION OF THE PLAN**

The following is a brief description of the Gelia Wells & Mohr, Inc. 401(k) (the Plan) provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution retirement plan with salary reduction features as permitted under Section 401(k) of the Internal Revenue Code. The Plan is funded by participant and employer contributions and covers substantially all eligible employees of Gelia Wells & Mohr, Inc. (the Company or Plan Sponsor). The assets of the Plan are maintained in a trust fund held by Nationwide Trust Company, FSB and Nationwide Life Insurance Company (collectively, Nationwide). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan trustees are responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

**Eligibility:** All employees with the exception of nonresident aliens, leased, and/or employees covered by a collective bargaining agreement are eligible to participate in the Plan after completing six months of service and attaining the age of 21. Employees may enroll into the Plan on the first day of the quarter following the completion of the service requirements.

**Participant Contributions:** Participants may authorize an elective deferred contribution rate not to exceed the maximum annual limitations as provided by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Eligible employees must complete an enrollment form prior to participating in the Plan and indicate the deferral rate at which they wish to contribute. Participants direct the investment of all contributions into the various investment options offered by the Plan and may change their investment allocation on a daily basis subject to Nationwide limits.

**Employer Contributions:** Upon enrolling into the Plan, employees are entitled to employer matching contributions. The Company will match 25% of deferrals up to 8% of participants' compensation.

In addition, the Plan allows the Company to make a discretionary profit-sharing contribution. The discretionary profit-sharing contribution will be allocated among participants eligible to share in the contribution for the Plan year. For the years ended December 31, 2024 and 2023, the Company did not make any such contributions.

**Participant Accounts:** Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately fully vested in participant contributions. Participants become fully vested in employer contributions in accordance with the following schedule:

**Forfeitures:** Forfeitures of employer matching contributions that are not fully vested are used to reduce employer matching contributions. Forfeitures of employer contributions other than matching contributions can be used to reduce any employer contributions, added to any employer matching or discretionary contribution, or allocated to participants eligible to share in profit sharing contributions. There was \$4,573 in forfeitures used to reduce employer matching contributions during the year ended December 31, 2024 (\$3,625 – 2023). There was \$10,203 in unused forfeitures as of December 31, 2024 (\$538 – 2023).

## NOTES TO THE FINANCIAL STATEMENTS

### NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

**Payment of Benefits:** On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The normal retirement date a participant becomes eligible is when a participant reaches age 65. Distributions in excess of \$5,000 require written consent from the participant before distribution may be made. Upon death of a participant, their estate or beneficiary will be entitled to a single lump-sum distribution of 100% of the vested account balance. The spouse or beneficiary of a deceased participant may make certain legally-defined elections to defer distribution of the vested account balance.

**Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years or up to a reasonable period of time for purchase of a principal residence. The loans are secured by the participant's account balance and bear interest at a rate commensurate with local prevailing rates. Principal and interest is paid ratably through bi-weekly payroll deductions. Participants are not allowed to refinance their loan and are allowed one outstanding loan.

**Excess Contributions Payable:** Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

**Subsequent Events:** The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation on investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses on the accompanying statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation on investments.

## NOTES TO THE FINANCIAL STATEMENTS

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits:** Benefit payments to participants are recorded when paid.

### NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820: Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of Registered Investment Companies:** Shares of registered investment companies are valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

**NOTE 4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Nationwide Life Insurance Company totaling \$1,224,832 at December 31, 2024 (\$1,402,541 – 2023). Nationwide Life Insurance Company maintains the contributions in a general account. The account is credited with interest based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate quarterly. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. There is no minimum interest rate and there is no scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 5. PARTY - IN - INTEREST TRANSACTIONS**

Certain Plan investments are shares of registered investment companies managed by Nationwide. Nationwide is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. P&A Administrative Services, Inc. (P&A) is the third-party administrator for the Plan. Fees paid by the Plan for services provided by Nationwide and P&A for the year ended December 31, 2024 amounted to \$38,224 (\$48,359 – 2023).

**NOTE 6. FINANCIAL CERTIFICATION**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, as well as earnings and transactions for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by Nationwide and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Nationwide that information provided to the Plan Administrator by the custodian related to the following assets and transactions is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedule related to the following assets and transactions:

**NOTE 7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9. TAX STATUS**

The IRS has determined and informed the Company by a letter dated March 31, 2014 that the volume submitter Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
