INDEPENDENT AUDITORS' REPORT

To the Board of Trustees  
IBEW/Western Utilities Health & Welfare Trust Fund

**Opinion**

We have audited the financial statements of IBEW/WESTERN UTILITIES HEALTH & WELFARE TRUST FUND, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. ### NOTES TO FINANCIAL STATEMENTS

For the Years Ended December 31, 2024 and 2023

(1) Description of Fund

The following description of the IBEW/Western Utilities Health & Welfare Trust Fund (Fund) provides general information only. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General - The Fund was established January 1, 1991, pursuant to the terms of the Collective Bargaining Agreements entered into between the International Brotherhood of Electrical Workers Local No. 57 of Salt Lake City, Utah and Local No. 125 of Portland, Oregon and PacifiCorp dba Rocky Mountain Power and Pacific Power. Effective December 1, 2012 the Fund has been administrated by the Fund Administrator, BeneSys, Inc. On January 5, 2000, the Fund's Trustees authorized establishing a multi-employer trust agreement and participation agreement. As of December 31, 2024 and 2023, there were no other employers participating in the Trust; therefore, the Trust continues to be reported as a single-employer Plan. The Trust is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits - The Fund provides medical, dental, vision, life insurance, prescription drugs and mental health and substance abuse benefits, for PacifiCorp dba Rocky Mountain Power and Pacific Power employees and Local 125 staff employees as covered under the bargaining agreements. Medical and dental benefits under the Fund are provided from Fund assets accumulated under the provisions of the Collective Bargaining and Trust Agreement and are held in Trust for the purpose of providing benefits to covered participants and defraying reasonable administrative expenses. In addition, the Fund offers continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured benefits - The Fund offers to the participants medical coverage through a health maintenance organization (HMO). In addition, the Fund pays premiums towards life insurance coverage provided through a policy based on participant compensation and mental health and substance abuse.

Self-insured benefits - The Fund offers medical and vision claims through a self-insured program. Claims are processed through their third party administrator, but the Fund has the ultimate responsibility to the parties involved with the services. Prescription drug and dental claims are processed through Sav-RX and Delta Dental, respectively.

A Flexible Spending and Dependent Care Reimbursement Plan is also an available benefit of the Fund. Participants electing coverage are allowed to have salary reductions transferred to the Fund, which are then used to pay allowable expenses for medical and dependent care incurred by the participants with pre-tax dollars. Salary reductions may

not exceed \$5,000 for dependent care reimbursements and \$2,400 for health care reimbursements. A cash account of the Fund is restricted to pay for these benefits. The restricted balances at December 31, 2024 and 2023 were \$465,200 and \$376,552, respectively. Any forfeitures are used to reduce administrative costs of the Fund.

The Fund has no provision for postretirement benefits or continuation of eligibility upon retirement or termination of employment.

Contributions to the Fund are made by both the employees and PacifiCorp dba Rocky Mountain Power and Pacific Power (Employer). The amount of contributions is calculated as stipulated in the Collective Bargaining Agreements.

Any deficit in Fund assets may cause an increase in contributions, subject to negotiation, in the next collective bargaining agreement.

(2) Summary of Significant Accounting Policies

Valuation of investments - If available, quoted market prices are used to determine the fair value of investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Fund's management determines the Fund's valuation policies utilizing information provided by its investment custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Fund's gains and losses on investments bought and sold as well as held during the year.

Basis of accounting - These financial statements have been prepared utilizing the accrual method of accounting. Under this method of accounting, additions and deductions to net assets available for benefits are identified with specific periods of time and are recorded as earned and incurred, respectively, without regard to the date of receipt of payment.

The Fund maintains its financial records using the modified cash method of accounting, under which additions and deductions to net assets available for benefits are recognized when measurable and available to finance expenditures of the current period. Expenditures are generally recorded when the liability is paid. Adjustments are prepared at each year-end to adjust the financial records to the accrual method of accounting.

Contributions - Contributions are recorded during each year based upon information reported by the employer. Employees' contribution receivable is based upon actual contributions received subsequent to December 31, for hours worked prior to December 31; therefore, there is no allowance for uncollectible receivables. No provision has been

made for subsequent receipt of additional delinquent moneys covering hours worked during December or prior months, as the financial effect is expected to be immaterial.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the Fund Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Claims incurred but not reported – Claims incurred but not reported is a reserve for pending and unreported claims and claims in process for payment. The claims obligation has been determined based on actual claims paid experience of the Fund.

Insurance experience refunds – At termination, any excess life insurance premiums received from the Fund will be reduced by any accumulated monthly claim maximum and claims incurred prior to termination with any remaining amounts refunded to the Fund.

Reclassification – Certain reclassification of amounts previously reported have been made to the accompanying financial statements to maintain consistency between periods presented. The reclassifications had no impact on previously reported net assets available for benefits.

Prescription rebates receivable – Prescription rebates earned but not received prior to December 31, are recorded as receivables. These rebates are netted against prescription benefit payments on the accompanying statements of changes in net assets available for benefits.

Stop loss – Premiums for stop loss insurance are included in medical insurance premiums in the accompanying statements of changes in net assets available for benefits. Stop loss refunds totaling \$0 and \$0 for the years ended December 31, 2024 and 2023, respectively, have been netted with claims paid in the accompanying statements of changes in net assets available for benefits.

Subsequent events – Management has evaluated subsequent events for the Plan through September 22, 2025, the date the financial statements were available to be issued.

#### (3) Income Taxes

The Fund is exempt from Federal income taxes under the provisions of section 501(c)(9) of the Internal Revenue Code. The Fund is also exempt from state income taxes.

The Fund has been amended since receiving its exempt status. However, the Fund Administrator believes that the Fund is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Fund is qualified and the related trust was exempt from income taxes as of the financial statement date.

Tax years 2022 and forward remain subject to examination for federal income tax purposes. The Fund uses a loss contingency approach for evaluating uncertain tax positions. The Fund continually evaluates expiring statutes of limitations, audits, changes in tax laws and new authoritative rulings.

#### (4) Fund Termination

Although there has not been any expressed intent to do so, in the event the Fund terminates, any and all assets remaining in the Fund after the termination shall be used solely to provide benefits to participants, their families and dependents, and for expenses of administration incident thereto.

#### (5) Fair Value Measurements

Accounting Standards Codification (ASC) No. 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC No. 820 are described as follows:

- 1) Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Fund has the ability to access.
- 2) Level 2 - Inputs to valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- 3) Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

(5) Fair Value Measurements (continued)

The assets or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value.

- A) Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Fund are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Fund are deemed to be actively traded.
- B) Cash and Cash Equivalents - Valued at the closing price reported in the active market in which the individual security is traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Fund believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

(8) Concentration of Credit Risk

The Fund maintains its trust and checking accounts at one financial institution.

The Fund's cash is held at a financial institution that is insured up to \$250,000 by the Federal Deposit Insurance Corporation (FDIC). The Fund's uninsured cash balances at December 31, 2024 and 2023 were approximately \$3,813,000 and \$2,200,000, respectively.

(9) Risk and Uncertainties

The Fund invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The estimated liability for claims incurred but not reported is based on historical trend information which is subject to change. Due to uncertainties inherent in the estimation process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
