NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Diamond Paper Box Company, Inc. Section 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan containing both profit-sharing and 401(k) components. Unless otherwise indicated, the Plan provisions are the same for both components. The Plan covers substantially all of the employees of Diamond Paper Box Company, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the Plan sponsor and Plan administrator and pays certain administrative expenses of the Plan. Certain employees of the Company serve as the trustees of the Plan. Voya Retirement Insurance and Annuity Company (Voya), is the custodian and third-party administrator of the Plan and provides record-keeping services for the Plan.

Eligibility

Employees of the Company that are not independent contractors are eligible to participate in the employee contribution and employer match portions of the 401(k) component of the Plan upon completion of thirty days of continuous service. Participants are eligible for profit-sharing contributions upon completion of one year of service and attainment of age eighteen. Participant contributions and matching contributions begin on the first day of the month following completion of the eligibility requirements. Profit-sharing contributions begin on the first day of the quarter following completion of the eligibility requirements.

Contributions

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate. Prior to January 1, 2024, the default deferral rate was 2% of eligible pretax compensation. Effective January 1, 2024, the Plan was amended to increase the default deferral rate to 3% of eligible pretax contributions, as well as allow for Roth contributions. Participants may contribute a percentage of pretax annual compensation, as defined in the Plan, on a pretax basis or Roth after tax basis (collectively, Elective Deferrals), not to exceed the maximum contribution limits established by the Internal Revenue Code (IRC). Participants may also rollover contributions from other qualified retirement plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company may make matching contributions on a discretionary basis. During the 2024 and 2023 Plan years, the Company made matching contributions equal to 55% of the first 4% of each participant's eligible compensation, as defined by the Plan. The Company may also elect to make profit-sharing contributions on a discretionary basis. There were no profit-sharing contributions during 2024 and 2023.

Participant Accounts

Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investment options daily.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts (Continued)

Each participant's account is credited with his or her contributions, Company matching contributions and actual earnings and losses thereon. Profit-sharing contributions, profit-sharing earnings and losses, certain Plan expenses and forfeitures of non-vested account balances are allocated to each participant's account based on his or her compensation or account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferrals and Company matching contributions plus actual earnings thereon. Profit-sharing contributions plus earnings thereon become 20% vested upon completion of two years of service and continue to vest at the rate of 20% for each successive year of service until 100% vested after six years of service. Participants are considered to have completed one year of service for vesting purposes upon completion of 1,000 hours of service at any time during the plan year.

Forfeitures

Forfeitures of non-vested accounts are used to offset any administrative expenses of the Plan, reduce Company matching contributions, or be reallocated to participants' individual accounts as discretionary profit-sharing contributions.

During 2024 and 2023, forfeitures of non-vested accounts and earnings on unused amounts totaled \$2,594 and \$758, respectively. During 2024, the Company used \$4,563 to offset administrative expenses. During 2023, the Company did not utilize any forfeitures to offset administrative expenses, reduce Company matching contributions, or to be reallocated to participants' individual accounts as discretionary profit-sharing contributions.

At December 31, 2024, there were no forfeitures available to offset administrative expenses, reduce Company matching contributions, or to be reallocated to participants' individual accounts as discretionary profit-sharing contributions. Forfeitures available to offset administrative expenses, reduce Company matching contributions, or to be reallocated to participants' individual accounts as discretionary profit-sharing contributions totaled \$1,969 at December 31, 2023.

Notes Receivable from Participants

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Notes receivable are payable over a period not to exceed 5 years, except when used to acquire a principal residence. Participants may have up to three loans outstanding from the Plan. The notes receivable are secured by the remaining vested account balance and bear interest at rates available for similar loans from commercial lending institutions. Principal and interest are paid ratably through weekly payroll deductions over the term of the loan.

Benefit Payments

The Plan provides for benefit payments upon termination of service due to death, disability, or attainment of retirement age. Participants may elect disbursement of their vested account balance in either a lump-sum amount, in installments or direct rollover into an individual retirement account or another qualified plan. The normal retirement age is the date a participant reaches the age of 65. Participants whose vested account balance is \$5,000 or less at time of termination are subject to involuntary cash-out provisions of the Plan.

In-Service Withdrawals

Participants may elect disbursement of all or part of their vested account balance upon the attainment of age 59 ½.

1. DESCRIPTION OF PLAN (Continued)

In-Service Withdrawals (Continued)

Participants may also withdraw any of their rollover contribution balance at any time.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from elective deferral accounts. All hardship withdrawals must comply with specific rules relating to hardships, which are uniformly applicable to all participants.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

Administrative Expenses

The majority of administrative expenses of the Plan are paid by the Company. Investment-related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurements - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to participant contributions.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amount reported in the accompanying financial statements.

Reclassifications

Certain reclassifications have been made to the prior year's financial statements in order to enhance comparability with the current year's presentation.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates and such differences may be significant.

There were no changes to the valuation methodologies used during 2024 and 2023. The following is a description of the valuation methodology used for assets measured at fair value.

Fixed annuities: valued based on observable inputs of existing contracts and readily available financial information of the issuing financial institutions.

Pooled separate accounts: valued at fair value using the NAV per share practical expedient. The pooled separate accounts are valued using Accumulation Unit Value (AUV). AUV represents the underlying fund's daily performance, plus any applicable dividend income, less the daily separate account charge. The investment strategies of the pooled separate account funds are to invest in underlying funds with the goal of producing favorable long-term returns and growth, depending on the overall fund objectives. There are no restrictions on redemption of the pooled separate accounts. There are no unfunded commitments.

Common collective trust funds: valued at the NAV of units of the trust as determined by the trustee. The NAV is used as a practical expedient for fair value and is based on the fair value of the underlying investments held by the trust less its liabilities.

4. FAIR VALUE MEASUREMENTS (Continued)

The objective of the common collective trust funds is to provide long-term capital growth and appreciation consistent with the respective investment strategies. Participant transactions (purchases and sales of units) may occur on a daily basis at the NAV per unit. This practical expedient is not used when it is determined that it is probable the Plan would sell an investment at an amount different from NAV. If the Plan were to initiate a full redemption of its interest in a collective trust, the trustee reserves the right to delay withdrawal to allow for the orderly liquidation of the underlying assets.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Voya serves as the custodian of the Plan's investment assets. As such, transactions between the custodian and the Plan qualify as party-in-interest transactions. Additionally, Plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.

6. INCOME TAX STATUS

The Plan adopted a pre-approved plan offered by Voya. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain classifications may differ between the financial statements and Form 5500. Net assets available for benefits per the financial statements agreed to Form 5500 in total as of December 31, 2024 and 2023 and change in net assets available for benefits per the financial statements agreed to Form 5500 for the year ended December 31, 2024 and 2023.
