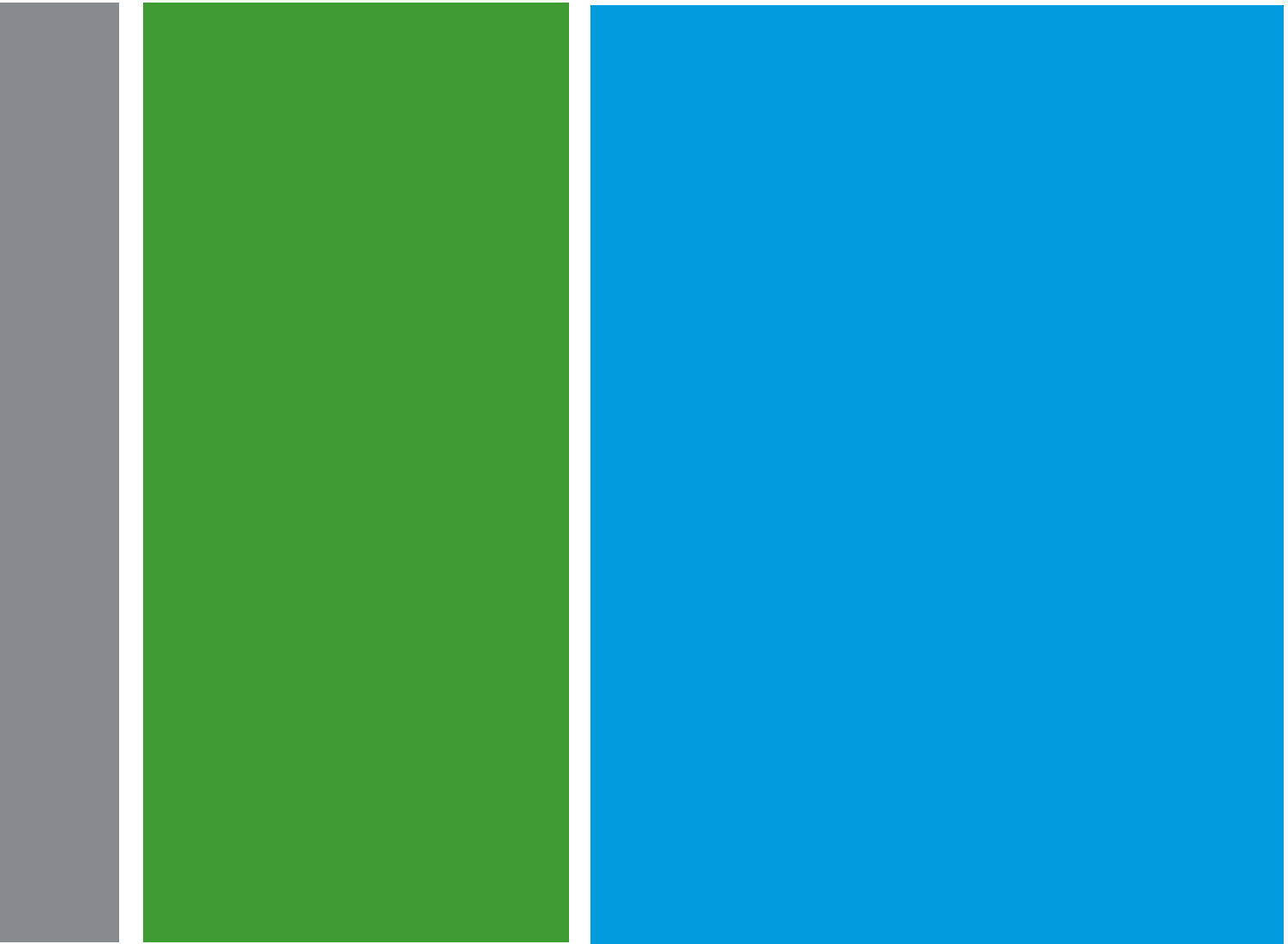

INDEPENDENT AUDITORS' REPORT

To: The Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Terumo Puerto Rico, LLC Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS December 31, 2024 and 2023

1) Plan Description:

The following brief description of Terumo Puerto Rico, LLC Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a complete description of the Plan’s provisions.

- A) General – The Plan was established on January 1, 2017 as a cash or deferred arrangement profit sharing plan covering all employees of Terumo Puerto Rico, LLC, Terumo Latin American Corporation and St. Jude Medical Puerto Rico LLC (together the “Employer”). The Plan covers all regular employees who have worked at least three (3) months during such year. Employees hired by contract, leased employees, and independent contractors are not eligible to participate in the Plan.

The Plan is administered by the Employer. The Plan qualifies under Section 1081 of the Puerto Rico Internal Revenue Code (the “Code”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

- B) Contributions – The Plan provides for contributions to be made by the Employer and by participants as follows:
- i) Employee pre-tax contributions – Pre-tax contributions are limited to \$15,000.
 - ii) Employee after-tax contributions – Voluntary after-tax contributions are not permitted.
 - iii) Catch-up contributions – Are limited to \$1,500.
 - iv) Rollover contributions – Rollover contributions are permitted.
 - v) Employer’s contributions – The Employer, at discretion, may match up to four (4) percent of participant compensation of the pre-tax contributions to the Plan on behalf of participants.
 - vi) Employer’s profit sharing contributions – The Employer may contribute a discretionary amount during each Plan year.

For the year ended December 31, 2024, total annual contributions made by the Employer and participants are limited to the lesser of \$69,000 or the total compensation paid by the Employer to the participant during the Plan year.

- C) Participant accounts – Individual accounts are maintained for each of the Plan’s participants to reflect the participants’ and Employer’s contributions as well as the participants’ share of the Plan’s income and any related expenses. Allocations are based on the proportion that each participant’s account balance bears to the total of all participants’ account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested accounts.
- D) Investment options – The Plan allows participants to direct the investment of their contributions into various investment options available under the Plan.
- E) Vesting – Participants are vested immediately in their contributions and Employer’s contribution, plus actual earnings thereon.

F) Retirement dates –

- i) Normal retirement date – The latest of: a participant reaching age of 65, or the five (5) year anniversary of the date of commencement of participation in the Plan.
- ii) Early retirement date – The Plan does not provide for early retirement.

G) Payments of benefits – The distribution of benefits to which a participant or beneficiary may become entitled to in case of retirement, disability or termination of employment shall be distributed under whichever of the following methods the participant or beneficiary shall elect:

- i) A single lump-sum or more payments within one taxable year of the participant or beneficiary;
- ii) Payments in equal monthly, quarterly, semiannual or annual installments over a period of certain years not to exceed the life expectancy of the participant or the life expectancy of the participant and his/her beneficiary(ies).

H) Hardship withdrawals – Participants may elect to make withdrawals from his/her pre-tax contribution account in the event of a financial hardship. If a participant makes a hardship withdrawal, such participant cannot make future pre-tax contributions for a period of 12 months following the in-service withdrawal.

I) Forfeited accounts – Participants in the Plan are immediately vested in their balances. As such, there are no forfeited balances.

2) Summary of Significant Accounting Policies:

The most significant accounting policies followed by the Plan are summarized below:

- A) Basis of accounting – The accompanying financial statements are prepared on the accrual basis accounting.
- B) Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C) Investment valuation and income recognition – Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

For investments in mutual funds that are registered with the Securities and Exchange Commission, fair value is determined using net asset values (“NAV”). The NAV per share of the registered investment companies is published daily and is calculated by each fund based on the market value of the underlying securities within each fund.

Net depreciation in fair value of investments includes the Plan’s realized gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

- D) Contributions – Employer and participants’ contributions are recorded in the Plan year in which the Employer makes the payroll deductions.
- E) Payment of benefits – Benefit payments to participants are recorded when paid.

F) Administrative expenses – Certain administrative expenses of the Plan are paid by the Employer as provided in the Plan’s Agreement. Expenses that are paid by the Employer are excluded from these financial statements. Expenses paid by the Plan are recorded as incurred.

3) Information Certified by Hand Benefits and Trust Company (the “Custodian”):

Plan’s assets information as of December 31, 2024 and 2023, and for the year ended December 31, 2024 included throughout the Plan’s financial statements and supplemental schedules, was prepared by or derived from information provided by the custodian and furnished to the plan administrator.

The plan administrator has obtained certifications from the custodian that information provided to the plan administrator by the custodian related to the Plan’s assets is complete and accurate. Accordingly, as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedules related to the following assets:

The custodian also certified the completeness and accuracy of \$674,964 of net appreciation on fair value of investments and \$297,543 of interest and dividends related to the aforementioned assets for the year ended December 31, 2024.

4) Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The valuation techniques are based upon observable or unobservable inputs. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan’s market assumptions. These two types of inputs create the following fair value hierarchy:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan or Master Trust has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

As of December 31, 2024 and 2023, investments held by the Plan represent mutual funds that are registered with the Securities and Exchange commission ("SEC"), all of which are considered level 1 type investments within the fair value hierarchy.

5) Party-in-Interest Transactions:

The Employer and Hand Benefits and Trust Company are party-in-interest, as defined by ERISA. There were no prohibited party-in-interest transactions during the year ended December 31, 2024.

6) Tax Status:

The Plan is intended to be a tax qualified arrangement that complies with the provisions of the Employee Retirement Income Security Act of 1974, as amended, and with the PRIRC of 2011, as amended. The latest determination letter received from the Puerto Rico Treasury Department was dated May 5, 2023, covering amendments up to February 1, 2022.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of taxing authorities. The plan administrator evaluated the tax positions taken by the Plan and concluded that as of December 31, 2024, the Plan had maintained its tax exempt status and had taken no uncertain tax positions that would require adjustment or disclosures to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

7) Risk and Uncertainties:

The Plan's investments may be exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8) Plan Termination:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

9) Subsequent Events:

The plan administrator has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.
