Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Filtration Group 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

1. Description of the Plan

The following brief description of the Filtration Group 401(k) Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan for the employees of Filtration Group Corporation and related companies (collectively, the Company). The Company established the Plan effective July 1, 1995, and was restated January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective April 1, 2022, Empower Annuity Insurance Company of America (Empower) acquired the retirement business of Prudential Financial, Inc. Pursuant to this transaction, business written and administered by Prudential Financial, Inc. is reinsured by Empower. Accordingly, the certified information, as described in Note 3, was certified by Prudential for the period January 1, 2023 to March 31, 2023, and by Empower for the period April 1, 2023 to December 1, 2023.

Eligibility

Under provisions of the Plan, all active employees of the Company, excluding members of a collective bargaining unit, Puerto Rican employees, leased employees, temporary employees, and intern employees, who have completed 1 month of service and are at least 18 years of age, are eligible to participate in the Plan. Participants become eligible to participate on the first of each month coincident with or after meeting all eligibility requirements (Plan entry date).

Contributions

Eligible employees may elect to contribute, on a pre-tax basis and after-tax basis (Roth deferral contributions), up to 90% of their eligible compensation to the Plan, not to exceed the limit under the Internal Revenue Code (IRC). In addition, eligible Participants are permitted to make catch-up contributions, which are eligible for matching contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby certain newly eligible employees, as defined by the Plan, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled Participants have their deferral rate set at 3% with automatic annual increases equal to 1%, not to exceed a total of 10% of eligible compensation. Effective October 1, 2023, the limit for the automatic annual increases was increased to 15%.

The Company provides a safe harbor matching contribution (Company matching contributions) equal to 100% of the first 2%, and 50% of the next 4% of the eligible Participant's compensation to the Plan. In addition, the Company, at its discretion, may elect to make additional non-elective contributions to the Plan (Company non-elective contributions). Participants, excluding those who reached normal retirement age (65), or became deceased or disabled during the Plan year, must be employed on the last day of the Plan year to be eligible for any Company non-elective contributions for that Plan year. Company non-elective contributions, if any, will be allocated to eligible Participants in a method elected by the Company. No Company non-elective contributions were made in 2023.

Participant Accounts

Each Participant's account is credited with the Participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on Participant earnings (losses), account balances, or specific Participant transactions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

Notes to Financial Statements

1. Description of the Plan (cont.)

Notes Receivable from Participants

A Participant may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the Participant's vested account balance. Loans are secured by the Participant's account balance and bear interest at a reasonable rate of interest as determined by Plan management based on prevailing interest rates charged for similar loans in the loan market. Repayments of the loans are made in substantially equal payroll deductions amortized over the life of the loan. The loan must be repaid within five years unless the loan is used to purchase a primary residence, in which case the repayment period may not extend beyond ten years from the date of the loan. The principal amount of the loan, together with all accrued interest, shall immediately become due when the Participant is no longer employed by the Company.

Payment of Benefits

Participant accounts may be withdrawn upon retirement, death, disability, attainment of age 59½, or termination of employment as a lump-sum or in the form of installments as specified by the Plan. Upon termination of service due to any other reason, the Participant may elect to receive a lump-sum or rollover to an eligible retirement plan in the amount equal to the value of the Participant's vested interest in his or her account. In-service and hardship distributions are available to Participants provided certain requirements are met. In-service distributions are limited to withdrawals from 100% vested accounts. Hardship distributions are limited to withdrawals not exceeding a Participant's salary deferrals. Any Participants with a vested balance of \$5,000 or less will receive a lump-sum distribution automatically upon death, disability, termination, or retirement.

Vesting

Participants are fully vested in their payroll deferral contributions and rollover contributions. Participants vest in all Company matching and non-elective contributions plus actual earnings following 2 years of service in which the Participant completed 1,000 hours.

Forfeited Accounts

Forfeitures resulting from any portions of Company contributions may first be used to reduce certain future Company contributions, as defined by the Plan, and then may be used to pay Plan fees. Forfeited non-vested accounts totaled \$268,866 and \$225,398 at December 31, 2023 and 2022, respectively. During the year ended December 31, 2023, forfeited funds in the amount of \$308,757 were used to offset Company contributions and the amount of \$164,194 were used to pay Plan fees.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Accounting Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (cont.)

Investment Valuation and Income (Loss) Recognition

The investments of the Plan are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a Participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to Participants are recorded upon distribution.

Plan Expenses

Certain administrative expenses of the Plan are paid by the Plan. Certain other administrative expenses of the Plan are paid by the Company. Investment fees are paid by the Plan in the form of reductions of net investment income earned by Plan Participants.

The Plan participates in a revenue credit program. Income from the revenue credit program can be used to pay Plan administrative expenses. The revenue credit program account balance was \$4,032 and \$14,930 at December 31, 2023 and 2022, respectively. During the year ended December 31, 2023, \$11,183 of program funds were used to pay administrative expenses.

3. Certified Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Prudential certified that the financial information included in the financial statements and supplemental schedule as of as of December 31, 2022, and for the period from January 1, 2023 to March 31, 2023, provided to the Plan is complete and accurate. Additionally, Empower has provided a certification that the financial information included in the financial statements and supplemental schedule as of December 31, 2023, and for the period from April 1, 2023 to December 31, 2023, provided to the Plan is complete and accurate. The information as to investment assets and transactions therein, and investment income (loss) included in the accompanying financial statements and supplemental schedule as of December 31, 2023 and 2022, and for the year ended December 31, 2023, are covered by such certifications.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund - Valued using the amortized cost method of valuation or penny-rounding method of pricing as permitted by Rule 2a-7 under the Investment Company Act of 1940, as amended, which approximates their fair value.

Common Collective Trust Funds - Valued at the net asset value using NAV as the practical expedient based on the last reported sales price of the underlying investments held. The Plan's interest in the collective trusts was based on information reported by the Empower using the audited financial statements of the collective trust at year-end. The investment income (loss) was allocated to Participants based on their proportionate share of the net assets of the fund.

5. Income Tax Status

The Plan is based on a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) sponsored by The Prudential Insurance Company of America (PICA), which received an opinion letter from the Internal Revenue Service (IRS) dated December 4, 2020, stating that the Pre-Approved Plan was designed in accordance with the provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any part rendering service to the Plan, the Company, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses are paid directly by the Company. Certain investments are managed by the by Prudential Investments and Putnam Investments. Putnam Investments is a related party to Great-West Life Co., the parent company of Empower Investments. These transactions, as defined by the Plan, qualify as party-in-interest transactions. Notes receivable from participants are also defined by ERISA as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules.

7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, Participants will become 100% vested in their accounts.

8. Risks and Uncertainties

The Plan's investments include funds which invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

9. Delinquent Participant Contributions

During 2023 and 2022, employee withholdings of \$5 and \$67,830, respectively, were not remitted within the appropriate time period by the Company. The Company remitted \$66,382 of the 2022 delinquent contributions to the Plan during 2022 and remitted the remaining \$1,448 during 2023. The Company remitted \$5 of the 2023 delinquent contributions to the Plan during 2023. All related lost earnings will be calculated and remitted to the Plan during 2024. These transactions constituted prohibited transactions as defined by ERISA.

10. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, October 08, 2024, and has determined that no significant events occurred after December 31, 2023, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.
