## INDEPENDENT AUDITORS' REPORT

To the 401(k) Plan Steering Committee  
of **Resolve Marine Group 401(k) Plan**:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of Resolve Marine Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS

#### ( 1 ) Description of plan

The following description of the Resolve Marine Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** - The Plan is a defined contribution plan sponsored by Resolve Towing & Salvage, Inc. (the "Company") for the benefit of its employees and the employees of Resolve Fire & Hazard Response, Inc. and Resolve Salvage, Inc. dba Resolve Operations Services who have completed at least 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan administrator and plan trustee have the overall responsibility for the operation and management of the Plan. The plan administrator and plan trustee determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Employees who have satisfied the eligibility requirements may begin participating in the Plan. The Plan entry dates are January 1 and July 1.

**Contributions** - Participants may contribute up to the maximum permissible amount established by law, as pre-tax or Roth contributions, as defined in the plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older who are making contributions to the Plan are allowed to make catch-up contributions as defined in the plan document.

The Plan is a safe harbor plan and the Company matches 100% of the first 3% of compensation that a participant contributes to the Plan, plus 50% of the amount between 3% to 5% of compensation that a participant contributes to the Plan. For the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions totaling approximately \$497,000 and \$434,000, respectively. Approximately \$99,000 and \$101,000 of the safe harbor matching contributions were included in employer contributions receivable at December 31, 2024, and 2023, respectively. In addition to the safe harbor matching contributions, the Company may make discretionary non-elective contributions. In order to be eligible for a non-elective contribution, the participant must be employed on the last day of the plan year and have completed at least 500 hours of service. For the years ended December 31, 2024 and 2023, the Company did not make any discretionary non-elective contributions. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Participant investment account options** - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and a self-directed brokerage account as investment options. Participants may purchase shares of mutual funds, exchange traded funds, common stocks, and corporate and government bonds, not offered by the Plan through the brokerage account.

### NOTES TO FINANCIAL STATEMENTS

#### ( 1 ) Description of plan (continued)

**Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants' contributions and employer safe harbor contributions, plus actual earnings thereon, are 100% vested immediately.

All other employer contributions are subject to the following vesting schedule:

Notwithstanding the above, a participant shall become fully vested upon attainment of his or her normal retirement age, his or her date of death or upon becoming disabled while an employee.

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have no more than one note outstanding at any one time. Note terms are limited to five years from the date of the note. However, if the note is for the purchase of the participant's principal residence, the Plan permits a longer repayment term not to exceed fifteen years. The notes are secured by the balance in the participant's account. Notes receivable bear interest at prime rate plus one percentage point. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits** - On termination of service due to death, disability, retirement, other reasons, or qualifying under certain "hardship" rules as prescribed by the Internal Revenue Service ("IRS"), a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Active participants may also receive distributions upon the attainment of age 59 ½.

**Forfeited accounts** - Forfeitures of non-vested accounts are retained in the Plan and may be used to pay the Plan's administrative expenses or reduce employer contributions. There were no forfeitures used to pay administrative expenses or reduce employer contributions during the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, forfeited non-vested accounts were approximately \$2,000 and \$600, respectively.

### NOTES TO FINANCIAL STATEMENTS

#### ( 2 ) Summary of significant accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policy utilizing information provided by the investment custodians. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions** - Contributions from the Plan's participants and matching contributions made by the Company are recorded in the year in which the participants' contributions are withheld from compensation.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### ( 3 ) Information prepared and certified by the custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.) ("John Hancock"), the custodian of the Plan, has certified that the following data included in the financial statements and supplemental schedule are complete and accurate with respect to the investments:

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### ( 4 ) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at the Net Asset Value ("NAV") of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds (included within the self-directed brokerage account):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Exchange traded funds ("ETF") (included within the self-directed brokerage account):* Valued at the NAV as reported by the fund and are available for intra-day trading at the NAV at the time of the trade and are considered actively traded.

*Common stocks (included within the self-directed brokerage account):* Valued at the closing price reported on the active market on which the individual securities are traded.

*Interest bearing cash (included within the self-directed brokerage account):* Stated at cost, which approximates fair value.

*Corporate bonds (included within the self-directed brokerage account):* Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

*U.S. government securities (included within the self-directed brokerage account):* Valued using pricing models maximizing the use of observable inputs for similar securities.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### ( 5 ) Related party transactions and party-in-interest transactions

The Plan's investments are in units in pooled separate accounts managed by John Hancock and a self-directed brokerage account managed by Charles Schwab & Co, Inc. ("Charles Schwab"). John Hancock and Charles Schwab, (collectively, the "Custodians"), are the Plan's Custodians as defined by the Plan. John Hancock is also the recordkeeper for the Plan. Therefore, these transactions qualify as party-in-interest transactions.

( 5 ) **Related party transactions and party-in-interest transactions (continued)**

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. Aggregate fees paid to service providers during the years ended December 31, 2024 and 2023 amounted to approximately \$94,000 and \$82,000, respectively. These fees were not covered by revenue sharing. The Company directly pays all other expenses related to the Plan's operations.

( 6 ) **Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their employer contributions.

( 7 ) **Tax status**

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing Plan that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

( 8 ) **Risks, uncertainties and concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. At December 31, 2024 and 2023, approximately 22% and 27%, respectively, of the Plan's investments were invested in one fund.

**( 9 ) Reconciliation of financial statements to Schedule H of Form 5500**

Certain investment and investment income line items reported on Schedule H of Form 5500 as of December 31, 2024 and 2023 and for the years then ended, have been reclassified on the accompanying statements of net assets available for benefits and statements of changes in net assets available for benefits. These reclassifications have no impact on net assets available for benefits at December 31, 2024 and 2023 or changes in net assets available for benefits for the years then ended.

**( 10 ) Subsequent events**

The Plan has evaluated subsequent events through October 14, 2025 which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
