INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the accompanying financial statements of Vision Management Services, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Vision Management Services, LLC 401(k) Plan (the Plan) as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. The Plan Sponsor's operations are subject to a variety of federal, state, and local regulations. Failure to comply with one or more of those regulations or changes in these regulations or their enforcement could impact the Plan. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

December 31, 2024 and 2023

1. Description of Plan

The following description of the Vision Management Services, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General – The Plan was established on August 1, 2019, as a defined contribution plan covering employees of Vision Management Services, LLC (the Company) and all affiliated service groups defined by the Plan who are 18 years of age after 30 days of service. The Plan excludes employees who are union employees, certain non-resident aliens, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Each year, participants may elect to defer a portion of their compensation, on a pre-tax or Roth basis, as defined by the Plan. The maximum contribution to the Plan in any year is determined by provisions in the Plan and the Internal Revenue Code (IRC) and Income Tax Regulations. As of December 31, 2024 and 2023, the Plan offered various mutual funds and money market funds as investment options for participants. The funds are held by Fidelity Investments through SaveDaily, the provider of an electronic trading platform to PCS Retirement LLC, the 401(k) administrator of the Plan.

Effective January 1, 2022, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan along with an automatic deferral increase of 1 percent (maximum of 5 percent). Automatically enrolled participants have their pre-tax deferral rate set at 1 percent of eligible compensation and their contributions invested in a default fund until changed by the participant.

The Company may make discretionary profit-sharing or matching contributions into the Plan. Employees are eligible for company contributions after one year of service (1,000 hours). No company contributions were made for the year ending December 31, 2024.

Participant Accounts – Each participant's account is credited with the participant's contribution, if any, and allocations of (a) company contributions, (b) administrative expenses, and (c) plan earnings, net of investment fees. Allocations are based on participant earnings, account balances, or other participant events, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in company contributions into their account plus earnings thereon is based on years of service and a participant is 100 percent vested after four years of credited service.

Payment of Benefits – On termination of service, for any reason, a participant will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. The Plan provides for an automatic lump-sum distribution of account balances of \$5,000 or less. The Plan allows for in-service distributions, normal retirement (age 62) distributions, and financial hardship withdrawals of all or part of the participant’s deferral contributions, if the participant can prove financial hardship and is unable to meet their financial needs another way.

Forfeited Accounts – Forfeited amounts, if any, may be used to reduce company contributions, pay plan expenses, or be allocated to participant accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,451 and \$17,002.

Notes Receivable from Participants – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 (reduced by the excess, if any, of the participant’s highest outstanding note balance during the one-year period ending on the day before the date on which such note is made over the participant’s outstanding balance of notes on the date such note was made) or 50 percent of their vested balance for reasons as defined by the Plan. Participants may have only one outstanding loan at a time. The minimum amount of a loan is \$1,000. Loan terms range from 1 to 5 years except for the purchase of a primary residence, which is a longer term not to exceed 15 years determined by the plan administrator. The loans are secured by the vested balance in the participant’s account and bear interest at prevailing rates. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

Investment and Administrative Expenses – The Plan’s expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain fees are charged to the Plan for services provided to the Plan. When applicable, these fees and fees charged by mutual funds are netted with investment earnings.

Payment of Benefits – Benefits are recorded when paid for financial statement purposes.

Subsequent Events – The Plan has evaluated subsequent events through September 26, 2025, the date on which the financial statements were available to be issued.

3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10 establishes a framework for measuring fair value under generally accepted accounting principles. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

- *Money Market Funds* – Valued at the total of the invested deposit plus earnings thereon, which approximates fair value.
- *Mutual Funds* – Valued at quoted market prices, which represent net asset value (NAV) of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. **Administrative Expenses and Party-in-Interest Transactions**

A transaction with a plan service provider or a participant of the Plan qualifies as a party-in-interest transaction. Service provider fees, either directly or indirectly, are paid to the investment custodian, third-party administrator, investment advisor, record keeper, and auditor. Of these fees, \$249,823 is included in administrative expenses on Exhibit B for the year ended December

31, 2024. Other investment fees are netted with investment earnings. Expenses, net of any revenue sharing credits (if any), incurred in the administration of the Plan were also paid by the plan sponsor.

Notes receivable from participants are considered to be both party-in-interest and a related-party transaction.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in company contributions.

6. Tax Status

On June 30, 2020, the IRS stated that the pre-approved plan adopted by the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the advisory letter. However, the plan administrator and the pre-approved plan provider believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has undertaken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor's operations are subject to a variety of federal, state, and local regulations. Failure to comply with one or more of those regulations or changes in these regulations or their enforcement could impact the Plan. The plan administrator has analyzed the Plan's tax positions and concluded as of December 31, 2024 and 2023, and through September 26, 2025, that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require recognition of a liability or disclosure in the financial statements.

7. Prohibited Transactions

Contributions totaling \$129,619 in 2024 and \$273,847 in 2023 were not remitted timely to the Plan. As of September 26, 2025, these amounts have been remitted to the Plan, and corrections for lost earnings have been made for the untimely contributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
