INDEPENDENT AUDITORS' REPORT

To the Plan Trustees of the
United Methodist Manor of the Pee Dee 401(k) Plan

SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT

We have performed audits of the financial statements of United Methodist Manor of the Pee Dee 401(k) Plan (the "*Plan*"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

OPINION

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information pre-

pared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

December 31, 2024

NOTE A -- GENERAL DESCRIPTION OF THE PLAN

The following description of the United Methodist Manor of the Pee Dee (the “Employer” or “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all employees of the Company, other than union employees, those covered by a collective bargaining agreement and nonresident aliens. The Plan was originally effective May 1, 2001, and amended and restated effective January 1, 2009. Each employee is eligible to participate on the first plan entry date following the completion of three consecutive months of services and the attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan Fiduciary Committee is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Effective July 1, 2016, the Plan allows participants to elect to transfer any amount not otherwise distributable under the Plan, to a designated Roth elective deferral account maintained for the participant within the Plan. The Plan was also restated to include an auto-enrollment contribution agreement. Automatic contributions are made on behalf of the participant at 2% pre-tax deferral contribution rate under the Plan until the participants specifically elects a different percentage or not to elect at all. If an investment election is not made by the participant, the Plan will invest the participants deferral in the designated John Hancock fund.

Contributions: Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan, subject to the limitations as defined in the Internal Revenue Code (IRC). Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a discretionary match up to a percentage of pay determined by the Company. The Company made a matching contribution of 40% of the participant’s elective deferral not in excess of 4% of compensation for eligible participants as defined by the Plan. The Company made matching contributions of \$44,245 and \$41,196 for the years ended December 31, 2024 and 2023, respectively.

Qualified non-elective contributions may be made by the Company in order to satisfy the non-discrimination tests described in IRC. Qualified non-elective contributions are allocated to every non-highly compensated Plan participant who was active in the Plan during the year. The allocation is based upon the participants proportionate share of the total compensation paid during that year. The Company did not make any qualified non-elective contributions for the years ended December 31, 2024 and 2023.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions, as well as allocations of Plan earnings, Plan expenses, and the Company’s non-elective contributions. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE A -- GENERAL DESCRIPTION OF THE PLAN-- Continued

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after one year and is vested on a graduated basis until completion of five years of continuous service. Upon reaching the minimum retirement age (65) or if termination is due to death or disability, the participant becomes 100% vested in all contributions.

Payment of Benefits: On termination of service, if a participant's vested account balance does not exceed \$1,000, the participant will receive the value of the vested interest in his or her account as a lump sum distribution. If a participant's vested account balance exceeds \$1,000 but is less than \$5,000, the participant may elect to receive a lump sum or roll over the vested account balance to an individual retirement account (IRA) or other qualified plan. However, if no election is made by the participant, the Plan will automatically roll over the vested balance into an IRA with an affiliate of the Plan's custodian. If a participant's vested account balance exceeds \$5,000, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum, installment payments over a specified period of time, part lump sum and part installments, or roll over the vested balance into an IRA or other qualified plan.

Notes Receivable from Participants: Participants may borrow from their account up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and accrue 1% interest over the Prime Rate, in effect, at the beginning of the month in which the loan is approved. No participant may have more than one loan outstanding at any one time. Principal and interest payments are made ratably through direct, after-tax, payroll deductions.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$82 and \$5,781, respectively. Forfeitures are used to offset administrative expenses or reduce any employer contributions. In 2024 and 2023, there were no offsets to administrative expenses. In 2024 and 2023, employer contributions were reduced by \$6,082 and \$9,884, respectively.

Plan Termination: Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. If a participant ceases to make repayments and the Plan administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contributions Payable: Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the processing of participant withdrawals are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events: The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

NOTE C -- INFORMATION PREPARED AND CERTIFIED BY THE PLAN TRUSTEE & CUSTODIAN
- (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (trustee from January 1, 2023 through September 3, 2024) and Empower Retirement (custodian from September 4, 2024 through December 31, 2024), has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment activity and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the footnotes for the years ended December 31, 2024 and 2023, and supplemental schedules of assets (held at end of year and acquired and disposed of within year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

NOTE D -- RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as the interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE E -- FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability; and
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in methodologies used at December 31, 2024 and 2023.

Collective trust funds: The fair value of the investments in collective trust funds is determined by each fund's trustee based on the fair value of the underlying securities within the fund, which represent the NAV of shares held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective investment trust, the issuer reserves the right to require 1 business day notification in order to ensure that the securities will be carried out in an orderly business manner. There are no unfunded commitments as of December 31, 2024.

Fixed annuities: The Plan's investment in a fixed annuity contract is valued at the contract value, which represents contributions made under the contract, plus earnings, less withdrawals, and approximates fair value. The contract is backed by the general account of the insurance company and provides a guaranteed return of principal and a stated interest crediting rate. The fixed annuity is valued using the contract's surrender value as provided by the insurance company. The surrender value represents the amount the Plan would receive if it were to terminate the contract at the reporting date. Because this value is based on observable inputs provided by the issuer but is not quoted in an active market, the investment is classified as Level 2 in the fair value hierarchy.

Pooled Separate Accounts: Stated at estimated fair value as determined by the fair value of the underlying assets of the account. The account values of separate accounts are not publicly quoted and are therefore classified as level 2 investments.

NOTE F -- RELATED PARTY TRANSACTIONS

John Hancock, the trustee (from January 1, 2023 through September 3, 2024), and Empower Retirement, custodian (from September 4, 2024 through December 31, 2024) may have received revenue shared by certain mutual fund companies based on the dollar amount of assets or number of participant accounts invested with the fund. These amounts compensate the trustee for administrative and disclosure services performed on behalf of the fund. These fees are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Company pays directly to the trustee the Plan's recordkeeping and administrative service fees.

NOTE G -- TAX STATUS

The Company adopted a Non-Standardized Pre-Approved Profit-Sharing Plan (the Plan) sponsored by Third Party Administrators. The Internal Revenue Service (IRS) has determined and informed the third-party administrator by a favorable opinion letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (the Code). The Plan's opinion letter is being relied on by the Plan. Although the Plan has been amended since receiving the determination letter, Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
