December 31, 2024 and 2023

1. Plan Description

The following brief description of the First National of Nebraska, Inc. Welfare Benefit Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined benefit health and welfare plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide health benefits covering substantially all active and eligible retired employees of First National of Nebraska, Inc. and its Affiliates (the Sponsors). The restated Plan and related Trust were established effective January 1, 2009. The liability for plan obligations under the predecessor plan was transferred into this Plan effective in January 2009.

Benefits

The Plan provides self-insured health benefits (medical, hospital, surgical, major medical, prescription, dental and short-term disability) to eligible participants and covered dependents. Employees are eligible to participate on the first day of the month that coincides with or follows the employee's date of hire or change to an eligible status. The Plan also provides fully insured benefits (vision, life insurance, accidental death and dismemberment insurance and long-term disability) to eligible employees. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Benefits are recorded when paid.

Stop Loss Coverage

The Plan maintains a stop-loss insurance policy with Sun Life Assurance Company of Canada (Sun Life) whereby maximum Plan benefit payments per participant are \$500,000, after which the insurance provider reimburses the Plan for covered benefit payments.

Contributions

The Plan's benefit payments, premiums and other costs are funded through a combination of employer and participant contributions. Participants pay an annually predetermined premium for coverage. The Sponsors pay the cost of the coverage in excess of the employee contributions.

Other

Although it has not expressed any intention to do so, the Sponsors have the right under the Plan to modify the benefits provided and to terminate the Plan subject to the provisions set forth in ERISA.

Upon termination of the Plan, claims incurred prior to the termination date will be settled. The remaining or deficient funds, if any, will be returned to or paid for by the Sponsors.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amount of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments

Investments are stated at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Interest income is recorded on the accrual basis.

Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employees' rendered service. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Sponsors. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

Prior to January 1, 2015, retirees were eligible to receive postretirement benefits if they were age 55, had completed 10 years of service and were hired prior to July 1, 2006 or if they were age 65, had completed 5 years of service and were hired prior to July 1, 2006. Effective January 1, 2015, the Plan was amended whereby employees that were not age 60 by January 1, 2015 will no longer be eligible to receive postretirement benefits from the Plan. Retirees with a retirement date prior to January 1, 2015 are not affected by this amendment. Additionally, the Plan no longer covers retirees who are eligible for Medicare.

The actuarial present value of the expected postretirement benefit obligation is the amount that results from applying certain assumptions to historical claims-cost data to estimate future annual incurred claims costs per retiree and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

As of December 31, 2024 and 2023, the Plan’s estimated liability for postretirement benefits was \$74,101 and \$143,494, respectively. If the assumed health care cost-trend rate increased by one percentage point, it would increase the obligation as of December 31, 2024 and 2023, by \$1,060. The obligation considers Medicare Part D Federal subsidies expected to be received on prescription expenditures.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Expenses

Claim administration fees are paid by the Plan. Investment management, actuarial and other fees are paid by the Sponsors.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 7, 2025, noting no items requiring disclosure.

3. Interest in Master Trust

The Plan's investment assets are held in a trust account at First National Bank of Omaha (FNBO) and consist of an interest in an investment account of the First National of Nebraska, Inc. Welfare Plan Trust (the Master Trust), which is a master trust established by the Sponsors and administered by FNBO. Use of the Master Trust permits the commingling of trust assets of the Plan and the Lauritzen Corporation Welfare Benefit Plan (a related party, see Note 7) for investment and administrative purposes. The net investment income of the investment assets is allocated by FNBO to each participating Plan based on the relationship of each interest of each individual Plan to the total of the interests of the participating plans.

4. Benefit Obligations

Plan benefit obligations at December 31, 2024 and 2023, for health claims incurred by active participants and their covered dependents, reported at that date to the plan administrator or claims processor have been accrued and recorded as health claims payable in the accompanying statements of plan benefit obligations. Also, plan benefit obligations for health claims incurred by active participants, and their covered dependents, but not reported at December 31, 2024 and 2023, have been reported in the accompanying statements of plan benefit obligations as estimated by the Sponsors taking into consideration prior claims history and the expected time period from the date such claims are incurred to the date that the related claims are submitted and paid.

5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund: Valued at the daily closing price as reported by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Trust established under the Plan to hold the Plan’s assets is intended to qualify pursuant to Section 501(c) of the Internal Revenue Code (IRC), and, accordingly, is exempt from income taxes. The Sponsors believe that the Plan and related Trust, as amended, continue to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Related Party Transactions

A certain Plan investment in the Master Trust is a money market fund managed by FNBO. FNBO is the custodian and a sponsor of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Additionally, included in other receivables are amounts due from the Lauritzen Corporation Welfare Benefit Plan to cover the Plan’s shortfall in its interest in the Master Trust balance of the money market fund (related to claims payments primarily) totaling approximately \$490,000 and \$660,000 as of December 31, 2024 and 2023, respectively. As this Plan is included in the same Master Trust, the amounts qualify as party-in-interest transactions.

Lutz
