## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of  
Bella International Employee Retirement Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of Bella International Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year as of December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**1. DESCRIPTION OF THE PLAN**

The following brief description of the Bella International Employee Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**Plan Description** – The Plan is a defined contribution plan covering substantially all employees of Bella International, LLC (the “Plan Sponsor”, the “Plan Administrator” or the “Company”) and affiliated companies who have completed six months of service and are age twenty-one or older. The Retirement Committee of the Board of Directors of the Company controls and manages the operation and administration of the Plan. Banco Popular de Puerto Rico serves as the Plan trustee, custodian, and recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions** – Contributions to the Plan include (i) salary-deduction contributions authorized by participants, (ii) matching contributions made by the Sponsor, (iii) discretionary contributions made by the Sponsor; and (iv) participant rollovers from other qualified plans.

Participants may elect to contribute a percentage of their compensation or any other amount, up to the maximum amount in accordance with the provisions of the Puerto Rico Income Tax Code (\$15,000 for the years ended December 31, 2024 and 2023). In addition, participants who will attain age 50 at any time during the plan year and who has elected to make the maximum allowable elected deferral contribution, may elect to make additional pre-tax contributions (“catch-up contributions”) per plan year of up to \$1,500 for the years ended December 31, 2024 and 2023. Such contributions are excluded from the participant’s taxable income for income tax purposes until received as a withdrawal or distribution from the Plan.

The participants start their pre-tax contributions upon meeting the eligibility criteria.

Effective on January 1, 2022, employer matching contribution was increased to 90% of the first 10% base compensation of participant contributions to the Plan and will be determined annually as per approval of the Plan Sponsor Retirement Committee of the Board of Directors. No discretionary contributions were made by the Sponsor for the years ended December 31, 2024 and 2023.

Participants may also make post-tax contributions to the Plan up to 10% of their total compensation, as well as amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain Puerto Rico law limitations.

**Participant Accounts and Forfeitures** – Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contribution and related matching and non-elective contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. When certain terminations of participation in the Plan occur, the portion of a participant account not vested at the date of his termination of employment is forfeited immediately. The Plan document permits the use of forfeitures to either reduce future employer contributions or Plan administrative expenses for the plan year. However, if a participant is reemployed and fulfills certain requirements, as defined in the Plan document, the account will be reinstated. At December 31, 2024 and 2023, forfeited non vested accounts totaled \$112,021 and \$93,630, respectively. These accounts will be used to reduce future employer contributions or administrative expenses. During the years ended December 31, 2024 and 2023, administrative expenses amounting to \$60,270 and \$54,223, respectively, were paid from forfeited non-vested funds.

**Vesting** – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

The Plan's vesting schedule is as follows:

**Plan Expenses and Administration** – Banco Popular de Puerto Rico ("BPPR") serves as the Plan recordkeeper and custodian.

The Plan Sponsor is responsible for the Plan general administration for carrying out the provisions thereof. The Plan Sponsor has established a committee to discharge the administration and fiduciary duties under the Plan.

Administrative expenses are borne by the Plan and by the Plan Sponsor. Custodian, recordkeeping and investment advisory fees are paid by the Plan. During the years ended December 31, 2024 and 2023, administrative expenses charged to the Plan amounted to \$107,794 and \$96,900, respectively. Other costs for administering the Plan such as audit, legal

advice, use of other specialists, among other charges are borne by the Plan Sponsor. Up to March 31, 2019, agreement between the Plan and BPPR as the recordkeeper and custodian provided for the collection by BPPR of certain service compensation, such as 12B-1 fees, from each of the underlying Plan investments funds. Starting April 1, 2019, the fees are credited to the participant's account. The collected service fees then used to pay the custodian and recordkeeping charges by BPPR. Differences between the service fees collected from the mutual or investment funds and the actual custodian and recordkeeping charges are accrued by the Plan. The unpaid portions at December 31, 2024 and 2023, amounted to \$27,303 and \$24,408, respectively, and are included as accrued plan expenses in the accompanying statements of net assets available for benefits.

**Investments Options** – Upon enrollment in the Plan, a participant may direct the investment of their contributions into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan currently offers funds with registered investment companies as investment options for participants. Contributions to a participant account that has not chosen an investment option are invested in default portfolios of funds based on estimated target retirement date.

**Payment of Benefits** – Upon termination of service with the Company, including termination of service due to death, disability, or retirement, a participant or his/her beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodical payments (monthly, quarterly, semiannual or annual installments of substantially equally amounts), not to exceed a 10-year period.

**Hardship Withdrawals** – Under the provisions of the Plan, participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships. Following a hardship withdrawal, participants are not allowed to contribute to the Plan for a period of twelve months.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The Plan's financial statements are prepared on the accrual basis of accounting. A summary of the significant accounting policies used by the Plan follows:

**Use of Estimates in the Preparation of Financial Statements** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting periods. Actual results could differ from those estimates.

**Cash** – Cash represents amounts in non-interest earning account that will be used for benefit and administrative payments.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note 3 to the Financial Statements for additional disclosure related to fair value measurements.

The Plan investment return includes interest income, gains and losses on sales of investments and unrealized appreciation or depreciation of investments. The financial statements reflect the net appreciation or depreciation in the fair value of the Plan’s investments. This net appreciation or depreciation consists of realized gains and losses calculated as the difference between proceeds from a sales transaction and cost, and unrealized gains and losses calculated as the change in the fair value between beginning of the year (or purchase date if later) and the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits** – Benefit payments to participants are recorded upon distribution. There were no benefit payments pending to be disbursed at December 31, 2024 and 2023.

**Transfer of Assets from/to Other Plans** – Terminated employees or retirees may transfer their savings from/to other plans qualified by the Puerto Rico Treasury Department (“PRTD”).

**3. FAIR VALUE MEASUREMENTS**

The FASB’s authoritative guidance on Fair Value Measurement and Disclosures establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under this guidance are described below:

*Level 1*            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active market that the plan has the ability to access.

*Level 2*            Inputs to the valuation methodology include:

- Quoted prices for identical or similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* Inputs to this valuation methodology are based on unobservable data and are significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1.

*Interest Earning Deposit* – Valued at the daily closing price as reported by the fund. The Non-interest Earnings Deposit's net assets value ("NAV") is maintained at \$1 per unit and the units are redeemable at NAV on a daily basis. Due to the short-term nature in which shares can be redeemed at NAV, the NAV is considered a fair approximation of an observable exit price. The Plan's investment in the fund has been classified as Level 1.

*Money Market Fund* - It is stated at amortized cost, which approximates fair value. The Money Market Fund's net assets value ("NAV") is maintained at \$1 per unit and the units are redeemable at NAV on a daily basis. Due to the short-term nature in which shares can be redeemed at NAV, the NAV is considered a fair approximation of an observable exit price. The Plan's investment in the fund has been classified as Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Transfers between Levels** – The availability of observable market data is constantly monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no such transfers during 2024 and 2023.

**4. INFORMATION CERTIFIED BY THE TRUSTEE**

Banco Popular de Puerto Rico, the custodian for the Plan has provided a certification to the Plan Administrator as to the completeness and accuracy of the following financial data included in the financial statements and the supplemental schedules as of and for the years ended December 31, 2024 and 2023:

- All investments significant transactions and corresponding fair values
- Transfers in/out
- Net depreciation or appreciation in fair value of investments
- Interest income and dividends
- Reportable transactions
- Number of shares

**5. TAX STATUS**

The Plan obtained a determination letter dated August 31, 2023, in which the Department of Treasury of the Commonwealth of Puerto Rico (the "Department") stated that the Plan meets the requirements of Section 1081.01 of the Puerto Rico Internal Revenue Code of 2011, as amended, and the regulations thereunder. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Puerto Rico income tax laws and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In Puerto Rico, the tax laws permit examination of the Plan Sponsors' income tax returns for up to four years after the initial return is filed. The tax years of the Plan Sponsors with respect to the Plan that remain open for examination are 2020 and 2024.

**6. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Plan Sponsors have the right under the Plan to reduce, suspend or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan terminates, the interest of each participating employee in the Plan shall be fully vested and such termination shall not reduce the interest of any participating employee, or their beneficiaries accrued under the Plan up to the date of such termination.

**7. RISK AND UNCERTAINTIES**

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and level of uncertainty related to changes in the values of investments, it is possible that changes in market values in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits. Individual participants' accounts bear the risk of loss resulting from fluctuations in fund values.

**8. PARTY-IN-INTEREST**

Certain Plan investments consists of funds administered by an affiliate of Popular Fiduciary Services, the Plan's custodian, recordkeeper and trustee and therefore, these transactions qualify as allowable party-in-interest transactions.

**9. PROHIBITED TRANSACTIONS**

During the year ended December 31, 2024, the Sponsor inadvertently failed to deposit participant deferral contributions totaling \$98,225 within the timeframe required by the Department of Labor (DOL). As of December 31, 2024, lost earnings totaling \$141, calculated in accordance with DOL guidelines, remained pending remittance to the Plan Assets.

**10. NON-DISCRIMINATION TESTS**

For the year 2024 and 2023, the Plan failed the non-discrimination tests. In order to correct the excess contributions corresponding to those years ended December 31, 2024 and 2023, the Plan opted to return excess contributions in the amount of \$3,446 and \$25,636, respectively, to certain Highly Compensated Employees. Such amounts are disclosed as excess contribution payable in the Statement of Net Assets Available for Benefits.

**11. SUBSEQUENT EVENTS**

Effective January 1, 2025, the Plan was amended to include Marca Rental, LLC, Marca Automotive del Sur, LLC, and Marca Automotive del Norte, LLC as adopting employers, each a member of the Company's controlled group. On September 9, 2025, the Department of the Treasury of the Commonwealth of Puerto Rico issued a favorable determination letter confirming that the Plan, as amended, satisfies the requirements of Section 1081.01 of the Puerto Rico Internal Revenue Code of 2011, as amended, and the regulations thereon.

On October 7, 2025, the Plan Sponsor contributed \$141 of lost earnings to the Plan related to the untimely deposit of participant deferral contributions.
