**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of the Franklin Primary Health Center, Inc. 403(b) Tax Deferred Annuity Plan (the Plan) only provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan is a defined contribution plan covering generally all employees of Franklin Primary Health Center, Inc. (the Company). The Company established the Plan to provide employees with a systematic means of saving and investing for the future. Employees are eligible to participate in the Plan upon hire. However, restrictions are placed on the right to receive employer matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

*Contributions and Funding.* Each year, participants may contribute up to 100 percent of his or her pretax compensation, as defined by the Plan, not to exceed the maximum allowed by law. Participants who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. A discretionary matching contribution may be made by the Company at the option of the Company's directors. During 2024 and 2023, the Company matched 3 percent when the employee contributes 3 percent, 3.5 percent when the employee contributes 4 percent, and 4 percent when the employee contributes 5 percent. Participants are eligible for the Company match provided the participant contributes at least 3 percent of his or her salary, is 21 years of age or older, has obtained one year of credited service, works more than 20 hours per week, and is not a physician, dentist, optometrist, or other highly compensated employee.

*Participant loans.* Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the one-year period prior to the new loan application date, or 50 percent of the participant's vested account balance less any outstanding loan balance. Loan terms cannot exceed five years, unless the loan qualifies as a home loan, as defined in the Plan documents. The loans are secured by the balance in the participant's account. Interest rates ranged from 2.70% to 9.50% for the year ended December 31, 2024 and 2.70% to 9.50% for the year ended December 31, 2023. Principal and interest is paid ratably and payments are made directly to Voya Retirement Insurance and Annuity Company, the custodian.

*Participant accounts.* Each participant's account is credited with the participant's contribution, allocations of the Company's discretionary matching contributions, if applicable, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting.* Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of credited service. A participant is 100% vested after six years of credited service. A participant will always be 100 percent vested if employed on or after attaining the normal retirement age of 65, becoming disabled, or upon death.

*Custodian and TPA.* The Plan uses Voya Retirement Insurance and Annuity Company as Custodian and Third-Party Administrator (TPA).

*Payment of benefits.* On termination of service due to death, disability, or attainment of age 59 1/2, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution or, at the participant's election, in annual installments. Participants may elect to receive a distribution of his or her vested account balance prior to the date the funds become distributable, because of immediate and heavy financial need or hardship.

*Forfeited Accounts.* At December 31, 2024 and 2023, forfeited, nonvested accounts totaled \$1,072 and \$13,387, respectively. During 2024 and 2023, \$28,192 and \$64,469, respectively, of forfeited non-vested amounts were used to reduce employer matching contributions.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### *Basis of accounting*

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

### *Use of estimates*

The preparation of financial statements in conformity with United States generally accepted accounting principles ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment valuation and income recognition*

The Plan's investments are stated at fair value (except for fully-benefit responsive investment contracts, which are stated at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Custodian did not provide a breakdown of investment income between appreciation in fair value and interest and dividends, as is required by accounting principles generally accepted in the United States of America (GAAP). The effect of this departure from GAAP is not considered to be material.

### *Payment of benefits*

Benefits are recorded when paid.

### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

*Administrative expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses and loan fees are included in net appreciation (depreciation) of fair value investments.

*Subsequent events*

The Plan has evaluated events and transactions that occurred between December 31, 2024 and October 15, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. Fair values of assets measured on a recurring basis are as follows:

**NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)**

FASB ASC 820, Fair Value Measurements and Disclosures establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of quoted market prices for similar or identical assets in a market that is not active, or other significant observable inputs, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

Level 1 Fair value measurements

The fair value of mutual funds is based on the closing price reported on the active market on which the individual securities are traded. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACTS**

The Plan entered into a traditionally fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (VRIAC) totaling \$766,422 for 2024 and \$697,887 for 2023. Voya Retirement Insurance and Annuity Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obliged to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer and the Plan has one fund that is subject to a minimum rate of 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfers of all or a portion of their investment at contract value.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 4 – FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACTS (CONTINUED)**

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 5 - UNAUDITED INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

At December 31, 2024 and 2023, the Plan's investments were held by Voya Retirement Insurance and Annuity Company. The following information included in the accompanying financial statements and supplemental schedules have been prepared and certified as complete and accurate by Voya Retirement Insurance and Annuity Company in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company (VRIAC). VRIAC was the custodian of the Plan's assets for the years ended December 31, 2024 and 2023, and therefore, any transactions with Voya qualify as party-in-interest transactions. Certain administrative functions and transactions are performed by the Plan sponsor, Franklin Primary Health Center, Inc. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than direct payment. Certain administrative functions are performed by officers or employees of the Plan sponsor. No such officer or employee receives compensation from the Plan.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)**

Fees in the amount of \$45,244 were paid by the Plan for the year ended December 31, 2024. No fees were directly paid the by Plan for administrative services for the year ended December 31, 2024. Voya received eligible indirect compensation. The Plan sponsor absorbed the remaining costs of Plan administration, including Plan audit fees.

All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

**NOTE 8 - INCOME TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (“Code”) for tax deferred status. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (“IRS”) in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for the Plan participants under Section 403(b). The Plan administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of the IRC, and therefore, believes the Plan is qualified and the related accounts are tax-exempt. Therefore, no provision for income tax has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. There are no uncertain tax positions taken or expected to be taken that would require recognition as a liability or asset for disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to IRS examination of its Form 5500 filings for years before 2021.

**NOTE 9 - RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500**

Any discrepancies that exist between totals on the financial statements and Schedule H of Form 5500 relate to differences in classification of investment returns and rounding differences of \$1 or less.

**NOTE 10 - RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
