## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator of the  
Stamford Marriott 401(k) Savings Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Stamford Marriott 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTES TO THE FINANCIAL STATEMENTS**  
**December 31, 2024 and 2023**

**1. Description of the Plan**

The following description of the Stamford Marriott 401(k) Savings Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution 401(k) plan covering all eligible employees of Stamford Employment Services, LLC (the Employer or Plan Sponsor) who have attained the age of 21 and complete 90 days of eligible service as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participation in the Plan is voluntary. Employees are eligible to enter the Plan on the first day of the next quarter of the Plan year, following completion of eligibility requirements.

The Employer is also the administrator of the Plan. As Plan Administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. John Hancock Trust Company LLC (John Hancock), the appointed trustee of the Plan, acts at the direction of the Plan Administrator.

***Contributions***

Participants may contribute a minimum of 1% up to a maximum of 35% of their pretax annual compensation, as defined, to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows for elective Roth deferrals by participants. On January 1, 2023, the Plan was amended to add an in-plan Roth rollover provision. In addition, participants have the option to make in-plan Roth rollover contributions. The minimum amount that may be transferred is \$1,000 and no more than two total transfers may be made during a Plan year.

Plan participants entering the Plan are automatically enrolled into the Plan with their deferral pre-tax rate set at 2% of eligible compensation and their contributions are invested in a designated fund until the rate and/or investment fund designation is changed by the participant.

The Employer may make discretionary matching or profit-sharing contributions to the Plan. To be eligible a participant must have attained the age of 21 and completed 90 days of eligible service. Matching contribution compensation excludes bonus compensation as defined in the Plan document. For the year ended December 31, 2024, the Employer made a discretionary matching contribution equal to 1% of the first 4% of a participant's compensation. During the year ended December 31, 2024, the Employer made matching contributions to the Plan of approximately \$31,000. No employer discretionary profit-sharing contributions were made to the Plan for the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, any rollover contributions made by the participant, the Employer's matching, other Employer discretionary contributions if applicable, and allocations of Plan earnings and losses and expenses incurred.

Allocations are based upon participants' compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

***Vesting***

Participants become fully vested in their contributions and the allocation of Plan earnings on those contributions after six (6) years of service. Participants are vested in their contributions as follows: 20% after 2 years, 40% after 3 years, 60% after 4 years, 80% after 5 years, and 100% after 6 years. Each participant shall be 100% vested in their Employer contribution accounts upon death, disability, or attainment of normal retirement age.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants can only have one loan outstanding at any given time. Loans are due within 5 years, unless it is for the purchase of a primary residence, for which the Plan administrator may permit a longer repayment period. The notes are secured by the vested balance in the participant's account and bear interest at 1% above the prime rate. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

Upon death, disability, retirement or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the value of his or her account. Participants who have reached the age of 59½, may elect to withdraw all or a portion of their vested account balance while still employed. In addition, participants may request a financial hardship withdrawal from their vested account balance, subject to limitations by the Internal Revenue Code (IRC).

If a participant terminates employment for any reason and their vested account balance does not exceed \$1,000, the Plan Administrator may distribute such amount as a lump-sum payment. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$5,000, the amount may be rolled over to an individual retirement plan designated by the trustee, unless otherwise directed by the participant.

***Forfeitures***

Participants in the Plan who terminate employment before completing the applicable vesting requirements forfeit the non-vested portion of their accounts. Forfeited non-vested accounts may be used to reduce Employer contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$18,425 and \$13,864, respectively. During the year ended December 31, 2024, no forfeited non-vested accounts were used.

***Plan Termination***

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment in the insurance company general account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited (Note 4). The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors, the trustee, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Fully Benefit-Responsive Investment Contract***

Authoritative guidance defines the circumstances in which an investment contract is considered fully benefit-responsive and provides certain reporting and disclosure requirements for fully benefit-responsive investment contracts held by defined contribution, health and welfare and pension plans.

The Plan has an investment in the John Hancock Stable Value Guaranteed Income Fund (SVGI Fund), which is fully benefit-responsive. The SVGI Fund invests in a broadly diversified, fixed-income portfolio within John Hancock Life Insurance Company's general account. The portfolio is primarily invested in domestic fixed income securities. The Plan's investment in this fund, which represents contributions and reinvested interest income, less withdrawals and expenses, plus or minus net participant directed transfer activity with the Plan's other investment funds, is recorded at contract value.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within the stated terms. Delinquent participant notes receivable are reclassified as distributions based on terms of the Plan document.

***Contributions***

Participants deferrals and Employer discretionary matching contributions are recorded bi-weekly, coinciding with the dates employees are compensated, when the Employer remits the payroll deductions for investment into the Plan.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Plan Sponsor, unless the Plan Sponsor directs that the expenses be paid by the Plan. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Participant maintenance fees are paid directly by the participants through a reduction in their account and are included in the participants' balance. Investment management and recordkeeping fees are paid by the Plan through a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in three mutual funds and an insurance company general account investment that accounted for approximately 50% and 13%, respectively, of total Plan investments as of December 31, 2024. As of December 31, 2023, the Plan invested in three mutual funds and a common/collective trust fund that accounted for approximately 47% and 21%, respectively, of total Plan investments.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

The Plan Administrator has evaluated subsequent events through October 14, 2025, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust Fund:* The Plan invested in the Lincoln Stable Value Fund, an investment vehicle that invests in benefit-responsive investment contracts, fixed income securities and money market funds. It was valued at NAV of units held by the Plan. The NAV, as provided by Lincoln, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. Participant transactions (purchases and sales) may occur daily.

There were no unfunded commitments or redemption restrictions for the individual participants within the Plan, however, there was up to a 12-month redemption for this investment at the Plan level.

**4. Investment Contract with Insurance Company**

The Plan has entered into a fully benefit-responsive investment contract, the John Hancock Stable Value Guaranteed Income Fund, with John Hancock Life Insurance Company (U.S.A.) (Insurance Company). Amounts held in connection with this contract are held in Insurance Company’s general account. Contributions allocated to the contract are guaranteed by Insurance Company. The value of this contract included in the financial statements, as reported to the Plan by Insurance Company, is equal to the sum of contributions made, less withdrawals and administrative expenses, plus interest credited.

The insurance company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The minimum crediting rate under this contract is 1.00%, and the crediting rate is reviewed on a quarterly basis, which was 3.05% for 2024. There are no reserves against contract value for credit risk of a contract issuer or otherwise.

The guarantee of value provided for investments made with the Insurance Company under the Plan’s contract are based on the financial strength and claims-paying ability of the Insurance Company. As described in Note 2, because the guaranteed insurance contract is fully benefit-responsive, contract value is the relevant measurement attributable for that portion of the net assets available for the benefits attributable to the guaranteed insurance contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include but are not limited to total or partial plan termination, mergers, spin-offs, lay-offs, early retirement incentive programs, sales or closings of all or part of the Plan Sponsor's operations, bankruptcy or receivership and the failure of the Plan to qualify under Section 401(a) or Section 401(k) of the IRC. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**5. Income Tax Status**

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, followed the applicable sections of IRC. The Plan has been amended since receiving the opinion letter in order to comply with the latest applicable tax laws and regulations. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Summary of Financial Data Certified by the Trustee**

The following is a summary of financial information and data certified by the trustee, John Hancock:

**7. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

**8. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by John Hancock, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to John Hancock and its affiliates for administrative services totaling \$39,710 for the year ended December 31, 2024. Participant notes receivable also qualify as party-in-interest transactions.

**9. Non-exempt Transactions**

During 2024, the Employer failed to remit participant contributions of \$23,020 and loan repayments of \$666 to the Plan on a timely basis as prescribed in the applicable Department of Labor Regulations 29 CFR 2510.3-102. Defined contribution plans must remit employee contributions to the Plan as soon as they can be reasonably segregated from the Employer's general assets and are withheld or received by the Employer.

During 2024, the Employer remitted untimely participant contributions of \$23,020 and loan repayments of \$666 due to the Plan for the year ended December 31, 2024. Lost earnings and employer match associated with these late remittances will be corrected during 2025.
