Notes to the Financial Statements

Note 1 - Plan Description

The following description of Western Industrial Contractors, Inc. 401(k) Plan Employee 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all qualifying employees of Western Industrial Contractors, Inc. (the "Company") who have completed two months of service, excluding union employees and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Company is the plan administrator, and is responsible for the oversight of the Plan. The Standard Insurance Company is the custodian of the Plan.

On December 29, 2022, the Securing a Strong Retirement Act of 2022 (SECURE 2.0 Act) was signed into law. The SECURE 2.0 Act introduces numerous provisions intended to improve retirement savings opportunities and administration for retirement plans. There are both optional and required provisions as a result of the Act which become effective at various dates through 2028. As of December 31, 2024, the Plan Sponsor has evaluated the provisions of the SECURE 2.0 Act and has adopted or intends to adopt certain provisions as outlined below:

Required Minimum Distributions - Effective January 1, 2023, the Plan adopted the required minimum distribution age of 73.

Mandatory Distribution Threshold - Effective January 1, 2024, the Plan increased the mandatory distribution threshold to \$7,000.

Catch-Up Contributions - Effective January 1, 2025, participants aged 60 to 63 may be eligible to make higher catch-up contributions.

The Plan Sponsor is working with its Plan partners and advisors to ensure timely compliance with relevant SECURE 2.0 Act provisions as they become effective. The impact on the Plan's financial position, changes in net assets, and plan operations is not expected to be material as of the date of this report.

Note 1 - Plan Description (continued)

Contributions

Each year, participants may contribute annual compensation up to the amount allowed by law, as defined in the Plan, on a pre-tax basis or after tax basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distractions from other qualified defined benefit or contribution plans (rollovers.) The Plan is a Qualified Automatic Contribution Arrangement (QACA) Safe Harbor plan in which the Company matches 100% of the first 4% of base compensation that a participant contributes to the Plan. The Company may also make discretionary profit sharing contributions. For the year ended December 31, 2024, no discretionary profit sharing contributions were made.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's QACA Safe Harbor matching contribution and allocations of plan earnings (losses). Participant accounts may also be charged with an allocation of certain administrative fees that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and a fixed account under a guaranteed investment contract as investment options for participants. Participants may change their investment options at any time.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Company's QACA Safe Harbor matching contributions portions of participant accounts, plus actual earnings (losses) thereon, is based on years of service. A year of service is credited for which 1,000 hours or more are worked in a plan year. Participants are fully vested after two years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate comparable to the rates being charged by lending institutions in the same geographic locale as the Company. Principal and interest are paid ratably through weekly payroll deductions.

Note 1 - Plan Description (continued)

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments as required by minimum distribution rules. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows for in-service distributions upon attaining age 59 1/2. Hardship withdrawals are permitted if the participant meets certain criteria.

Forfeited Accounts

Forfeitures are used to pay administrative expenses for the Plan and/or reduce future Company contributions. At December 31, 2024 and 2023, there were no forfeited nonvested accounts. For the year ended December 31, 2024, no forfeitures were used to pay administrative expenses of the Plan.

Note 2 - Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for the fully benefit-responsive investment contract (FBRICs) which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the asset custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Investment Valuation and Income Recognition (continued)

FBRICs are reported at a contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are reclassified as benefits paid to participants based upon the terms of the Plan's participant loan policy.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net change in fair value of investments.

Subsequent Events

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued. Plan management has not identified any material subsequent events that require reporting or disclosure.

Note 3 - Information Prepared and Certified by the Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Standard, the custodian of the Plan, has certified that the following unaudited data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants at December 31, 2024 and 2023.
- Interest on the guaranteed investment contract, net change in fair value of investments and interest income on notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits.
- The schedule of assets held at end of year included as supplemental information.

This information has not been audited by the Plan's independent auditors.

Note 4 - Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Pooled Separate Accounts: Fair value is estimated using the Net Asset Value (NAV) per unit by the issuer of the pooled separate accounts. Fair value is based on the fair value of underlying investments held by the pooled separate accounts. The underlying investments consist primarily of mutual funds.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation method if appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Investment Contract with Insurance Company

The Plan offers a fully benefit-responsive investment contract with Standard. Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contributions to the guaranteed investment contract become part of the Standard's general account. The contract is credited with interest in accordance with the interest crediting rate established and periodically adjusted by the issuer. The contract is charges for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract is a traditional guaranteed investment contract and is presented in the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Standard, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment as contract value. The crediting interest rate is based on a formula determined by the issuer, but it may not be less than 1.00%. Such interest rates are reviewed on a quarterly bases for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) termination of the contract, (2) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (3) plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with participants is not probable. The insurance company may terminate the contract with thirty days written notice to the contract owner for reasonable cause, which includes failure by the contract owner to meet contract requirements.

Note 6 - Related-Party Transactions and Party in Interest Transactions

Certain plan investments are managed by Standard. Standard is the custodian, recordkeeper and provides third party administration services to the Plan. Lockton Investment Advisors serves as the investment advisor and Olson, Reyes & Sauerwein, LLC performs the annual audit of the Plan. Transactions with these entities qualify as party-in-interest transactions. Fees incurred by the Plan for the investments management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment. The Plan made total direct payments of \$42,466 to parties in interest for the year ended December 31, 2024, which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8 - Tax Status

The Plan has adopted a volume submitter plan with an IRS Determination letter dated June 30, 2020, which states the volume submitter plan is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed, and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provisions for income taxes has been included in the Plan's financial statements.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
