Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the financial statements of Hanover Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. Description of Plan

The following description of the Hanover Company 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of the Plan sponsor, Hanover R. S. Limited Partnership (the "Company").

The Plan was established January 1, 1995 and has been amended and restated from time to time. The most recent restatement, effective January 1, 2022, incorporates all previous amendments to reflect the most recent statutory and regulatory changes applicable to plans maintained under Code Section 401(a) and 401(k) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Plan Administration

The Company is responsible for the administration and operation of the Plan. Certain selected employees of the Company serve as trustees of the Plan. Ascensus Trust Company (the "Custodian") and Ascensus, Inc., on behalf of Vanguard Retirement Plan Services, (the "Recordkeeper") serve as the Plan's custodian and recordkeeper, respectively.

Eligibility

An employee is eligible to participate in the Plan immediately following completion of one month of service, except for (i) employees whose employment is governed by a collective bargaining agreement in which retirement benefits were the subject of good faith bargaining unless such agreement expressly provides for coverage in the Plan, (ii) non-resident aliens who do not receive earned income from the Company which constitutes income from sources within the United States of America, (iii) employees resulting from a transaction described in Section 410(b)(6)(C) of the IRC, (iv) leased employees, and (v) courtesy/security officers, social directors, or fitness directors.

Contributions

Each year, participants may contribute up to 90% of their eligible compensation as pre-tax elective deferrals not to exceed the limitation (\$23,000 in 2024 and \$22,500 in 2023) set forth in Section 402(g) of the IRC. Participants may make catch-up contributions, pre-tax contributions that exceed the annual elective deferral limit, during any calendar year ending on or after the participant's 50th birthday. During both the years ended December 31, 2024 and 2023, participants' total catch-up contributions cannot exceed \$7,500 per year. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions, if any, equal to a percentage of the participant's elective salary deferral contributions to the Plan. Such discretionary matching contribution amounts are to be determined each year by the Company. During the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions totaling \$1,577,981 and \$1,657,200, respectively.

The Company may also elect to make a discretionary profit-sharing contribution in any amount determined by the Company. Such profit-sharing contributions are allocated to eligible participants, as defined in the Plan document, based on the ratio of the eligible participant's compensation to the total compensation of all eligible participants. Participants must complete 1,000 hours of service and be employed by the Company on the last day of the Plan year to be eligible to receive Company profit-sharing contributions. The Company made no discretionary profit-sharing contributions during the years ended December 31, 2024 and 2023.

1. Description of Plan, continued

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) Company contributions and, (b) Plan earnings. Participants accounts are charged with an allocation of administrative expenses that are paid by the Plan. Earnings and losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. Upon the occurrence of a distribution event, the benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions to their accounts plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon is based on years of continuous service. Participants vest 33% per year of service and are 100% vested after three years of service. A participant becomes 100% vested in all Company contributions upon death, disability, or attainment of normal retirement age, as defined in the Plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts any amount greater than \$1,000 up to a maximum amount equal to the lesser of (a) \$50,000 minus the participant's highest outstanding note balance during the prior twelve-month period, or (b) 50% of the participant's vested account balance. Loan terms range from one to five years, except for notes used for the purchase of a principal residence, which may be repaid over a longer term as determined by the Plan administrator. Principal and interest payments are made by payroll withholdings according to the terms of the promissory note. Loans are secured by the vested balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates ranged from 4.25% to 9.50% on participant loans outstanding at both December 31, 2024 and 2023 .

Payment of Benefits

Upon termination of service, participants may elect to receive a lump-sum amount equal to the vested value of his or her account, a non-recurring partial payment of his or her vested account balance, or recurring installment payments equal to the vested value of his or her account.

Prior to termination of employment, participants over the age of 59 ½ may elect to receive a distribution of his or her vested account balance. The Plan also allows hardship withdrawals subject to Internal Revenue Service ("IRS") regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

Forfeited Accounts

All Company contributions credited to a participant's account, but not vested, are forfeited by the participant upon distribution of the full vested value of his or her account. Forfeitures are used to pay Plan expenses or reduce the Company's future contributions. As of December 31, 2024 and 2023, forfeitures available to pay future Plan expenses or reduce future Company contributions totaled \$105,431 and \$49,874, respectively. During 2024 and 2023, \$57,773 and \$45,611 of forfeited non-vested amounts were used to reduce Company contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

2. Summary of Significant Accounting Policies

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transactions between market participants at the measurement date. See Note 3 for discussion of the fair value measurements.

Net appreciation in fair value of investments includes realized gains and losses on investments sold during the year and unrealized appreciation and depreciation of investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the loan to be in default, upon a distributable event the loan balance is reduced, and the delinquent loan is recorded as a benefit payment based on the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

Accounting Standards Codification Topic 820 ("ASC 820"), Fair Value Measurement, establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques that are used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

3. Fair Value Measurements, continued

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining fair value, the Plan generally uses the market approach, which uses prices and other relevant data based on market transactions involving identical or comparable assets and liabilities.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Money market fund: Valued at the daily closing price as reported by the money market account.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Exchange-traded funds: Valued based on observable market quotations and priced daily at the close of business.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by the Custodian (Unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income from notes receivable from participants for the years then ended, was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by the Custodian of the Plan.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and exchange-traded funds managed by Vanguard Group Inc. ("Vanguard"). Vanguard and the Recordkeeper have entered into an agreement whereby the Recordkeeper provides certain plan recordkeeping and administrative services on behalf of Vanguard and charges certain administrative fees to the Plan. The Plan also holds notes receivable from participants. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

6. Tax Status

The Plan adopted by the Company is based on a non-standardized prototype plan. The IRS has determined and informed the sponsor of the prototype plan by a letter dated June 30, 2020, that the prototype Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

9. Subsequent Events

Subsequent to the plan year-end, the Plan Sponsor adopted an amendment to the Plan, effective January 1, 2025, to modify the definition of eligible compensation for purposes of employee deferrals and employer contributions. Under the revised definition, certain forms of compensation will be excluded from eligible plan compensation beginning in the 2025 plan year.

Plan management has evaluated all subsequent events through October 14, 2025, which is the date the financial statements were available to be issued, and has concluded that there are no additional significant events to be reported.
