NOTE A – DESCRIPTION OF THE PLAN:

As a controlled group, Vizion Health - Oklahoma, LLC, Brookhaven Hospital, Inc. Willow Crest Hospital, and Community Neuro Rehab of Iowa, Inc. (hereafter also referred to as “the Companies”) sponsor the Vizion Health 401(K) Plan (hereafter referred to as “the Plan”) for the benefit of their employees. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution, 401(k) plan, covering employees of the Company who are at least twenty-one (21) years of age and have completed at least sixty (60) days of service, as defined. Days of service need not be contiguous, but there can be no more than a one-year break in service. Plan entrance is available on the first day of the month after the employees becomes eligible. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (“IRC”) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and for monitoring investment performance.

Contributions

Participants may contribute a dollar amount or percentage of compensation, up to the current pre-tax 401(k) contribution limits permissible under the Internal Revenue Code, as defined in the Plan document. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make “catch-up” contributions. Participants may also contribute amounts representing distributions or rollovers from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. All participant contributions are invested according to the allocations as determined by each individual Plan participant. Participants are allowed to stop their elective deferrals to the Plan and may change their elective deferrals to the Plan on any date during the year.

The Company may make an annual discretionary contribution, for participants who are still employed by the Companies on the date of the discretionary contribution, up to a percentage of each eligible participant’s compensation and elective deferrals for the Plan year. The Company’s Members determine, on an annual basis, if the Company chooses to make a discretionary percentage what the amount will be. The Company made a discretionary profit-sharing contribution for calendar year 2024 totaling to \$208,300.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Companies’ contributions, and allocations of Plan earnings, including gains and losses on investments with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Corrective Distributions

During the year ended December 31, 2024 the Plan identified and corrected certain compliance issues related to participant contributions. As a result, the Plan made corrective distributions totaling \$10,115 to affected participants.

Vesting

Participants are immediately 100% vested in their contributions plus or minus any earnings or losses thereon, and the employer profit sharing contributions plus or minus any earnings or losses thereon. Vesting of employer matching and discretionary contributions are based on years of service according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than two	0%
Two, but less than three	20%
Three, but less than four	40%
Four, but less than five	60%
Five, but less than six	80%
Six or more	100%

Participants automatically become 100% vested in the employer discretionary contributions upon (a) normal retirement age, i.e. attainment of age 65, (b) disability, (c) partial Plan termination or (d) death. Participants who terminate for any other reason are entitled to the vested portion of their accounts.

Notes Receivable from Participants

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of their vested account balance. Participants may not have more than one loan outstanding at any time. Loans will only be granted if the participant incurs a financial hardship or for the purchase of a personal residence. Notes receivable are secured by the balance in the participant's account, evidenced by a promissory note. Notes receivable from participants accrue interest at a reasonable rate that is determined by the Plan administrator. The interest rate for new notes receivable, determined annually, is currently set at 9.00%. Older, pre-existing notes receivable have an interest rate of 7.5%. Repayment terms for notes receivable from participants are five (5) years or less for hardship loans and fifteen (15) years for personal residence related loans. Principal and interest are paid ratably through payroll deductions. At the end of the calendar quarter following termination of employment, outstanding loan balances are treated as distributions and are subject to applicable federal and state income taxes and penalties, if applicable.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum distribution or periodic installments equal to the vested balance of his or her account, under the terms of the Plan. For termination of service due to other reasons, a participant may receive the value of their account balance as a lump-sum distribution. Participants who have reached age seventy-three (73) must take required minimum distributions ("RMD") as required by the Internal Revenue Service.

Forfeitures

On December 31, 2024 and 2023 forfeited non-vested accounts totaled \$6,426 and \$2,463, respectively. Forfeitures of employer matching contributions resulting from participants withdrawing prior to becoming fully vested are allocated to offset employer matching and profit-sharing contributions. Forfeitures are to be used in the year in which the forfeiture occurred. No forfeitures were allocated to employer matching deposits or to pay Plan administrative expenses during the year ended December 31, 2024.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from the estimates that were used.

Investment Valuation and Income Recognition

Investments are reported at fair value (see Notes C and D). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note C for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. At December 31, 2024, there were no employees who had terminated employment with the Company who had requested distributions from the Plan that had not yet been received.

Hardship Withdrawals

The Plan allows hardship withdrawals subject to account balance limits and applicable laws.

Expenses

All expenses of maintaining the Plan are paid by the Plan. Fees related to the administration of withdrawals by participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Date of Management's Review and Subsequent Events

Management of the Plan has evaluated subsequent events through October 14, 2025, the date that the financial statements were available for issuance, noting additional events that required recognition or disclosure in the accompanying financial statements and footnotes.

NOTE C – CERTIFIED INVESTMENTS:

On December 31, 2024, the Plan's investments were held by the insurance company, American United Life Insurance Company. The Plan investments that are included in the accompanying financial statements are based on information certified by the insurance company as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$328,421, as follows:

NOTE D – FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (“Level 1”) and the lowest priority to unobservable inputs (“Level 3”). The three levels of the fair value hierarchy under The Financial Accounting Standards Board’s (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The Plan held investments determined to be “Level 1” investments as of December 31, 2024 and 2023.

Level 2

Inputs to the valuation methodology include quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The Plan did not hold any “Level 2” investment as of December 31, 2024 and 2023.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan did not hold any “Level 3” investments as of December 31, 2024 and 2023.

Explanation of the Fair Value Hierarchy

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Plan investments are held in custody by American United Life Insurance Company (“One America”) the insurance company of the Plan. Certain Plan investments are managed by Farmer & Betts (“F&B”). F&B is the recordkeeper for the Plan and, therefore these transactions qualify as party-in-interest transactions.

F&B provides certain administrative services to the Plan pursuant to the Plan Services Agreement (“PSA”) between the Company and F&B. F&B receives revenue from mutual fund service providers and a group annuity with One America, for services F&B provides to the funds and annuity contract. This revenue is used to offset certain amounts owed to F&B for its administrative services of the Plan.

Fees paid by the Plan to F&B for investment management and contract administration services amounted to \$12,280 for the year ended December 31, 2024. All party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE F – EMPLOYER ABSORBED COSTS:

The Companies pay for certain administrative expenses of the Plan, such as professional fees. During the year ended December 31, 2024, The Companies paid administrative expenses of the Plan in the amount of \$7,565 for other administrative expenses.

NOTE G – TAX STATUS:

The Internal Revenue Service has determined and informed the Companies by an opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that “more likely than not” would not be sustained upon examination by the Internal Revenue Service. Plan management has not taken any uncertain tax positions as of December 31, 2024.

NOTE H – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the accompanying “Statements of Net Assets Available for Benefits”.

NOTE J – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY:

The Plan has a traditional fully benefit-responsive group annuity contract with American United Life Insurance Company. American United Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value.

Contract value, as reported to the Plan by American United Life Insurance Company, represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$20,884 and \$9,016, respectively. The crediting interest rate is based on an agreed-upon formula with the issuer but may not be less than 1%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with American United Life Insurance Company. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the Plan participants or the issuer is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.
