Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of DEMA Engineering Co. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following brief description of the DEMA Engineering Co. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by DEMA Engineering Co. (the Company or Plan Administrator). The Plan is a multiple employer plan; DEMA Engineering Co. and Viking LLC are adopting employers. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

The Plan covers all employees of DEMA Engineering Co. and Viking LLC who have completed 6 months of service and have attained age 21. Employees enter the Plan on January 1, April 1, July 1 or October 1 after initial eligibility requirements are satisfied.

Contributions

Participants can contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The Plan provides for automatic enrollment. Eligible employees will be automatically enrolled in the Plan at a 6% automatic deferral rate, unless the employee affirmatively elects otherwise. Deferral rates are increased automatically each year by 1% up to a maximum of 10% unless the eligible employee elects a different percentage.

The Plan provides for qualified non-elective contributions (QNEC) of 3%, which the Company chooses to make during the year. The Plan allows for discretionary contributions for employees who were active participants on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the Company made a discretionary contribution of \$581,069 and \$561,536, respectively.

Notes To Financial Statements *(Continued)*

Vesting

Participants are 100% vested in their deferral contributions, QNEC and participant rollover contributions, plus actual earnings (losses) thereon. Vesting in Company discretionary contributions is based on years of service. Participants vest 20% for each year of service, becoming fully vested after five years of service. Participants also become 100% vested upon reaching normal retirement age (age 62), becoming disabled or upon death.

Forfeitures

Forfeited balances of terminated participants' nonvested account balances are applied against plan administrative expense or to offset Company discretionary contributions. Forfeitures used to offset administrative expenses for the years ended December 31, 2024 and 2023 amounted to \$1,221 and \$6,326, respectively. Unallocated forfeitures available for future use at December 31, 2024 and 2023 were \$1,330 and \$1,175, respectively.

Participant Accounts

Each participant's account is credited with the participant's deferral contributions, Company contributions and an allocation of Plan earnings. The allocation of earnings (losses) is determined by the earnings of the participant's investment selection based on each participant's account balance, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment Of Benefits

Participants are entitled to receive the balance of their accounts upon death, total disability, retirement, or termination of employment in the form of a lump-sum or annuity.

In-Service Withdrawals

Participants who reach retirement age (62) may withdraw any portion of their vested account balance. In certain circumstances, a participant may elect a hardship distribution, as defined in the Plan Document.

Notes To Financial Statements *(Continued)*

Notes Receivable From Participants

A participant may borrow a minimum of \$1,000 from his or her account with a maximum of one loan outstanding at any given time. In no event can the participant borrow more than \$50,000 or 50% of his or her vested account balance, whichever is less. Loans are for a period not to exceed five years, unless used to acquire a personal residence in which case the loan is not to exceed 10 years, and bear interest at a reasonable fixed rate of interest based on prevailing market rates. All loans are secured by the participant's vested account balance and are payable in installments of principal and interest through payroll deductions.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. A significant portion of the administrative expenses of the Plan are paid by the Company. The Plan pays certain expenses related to transaction and recordkeeping fees. Investment related expenses are included in net change in fair value of investments.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any of a variety of investment options available.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are maintained on an accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Notes To Financial Statements *(Continued)*

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Investment Valuation And Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment Of Benefits

Benefit payments are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net change in fair value of investments, interest, and dividends for the years then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Trust Company (Principal). This information has not been audited by the Plan's independent auditor.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Notes To Financial Statements *(Continued)*

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts

Valued at the NAV of units held by the Plan at year end. The NAV as provided by Principal, is used as a practical expedient to estimate fair value. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are primarily comprised of shares of mutual funds held through subaccounts of a separate account of an insurance company at December 31, 2024 and 2023. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. All pooled separate accounts have daily redemption frequencies at NAV with no redemption notice periods, and file annual reports on Form 5500 as direct filing entities. There are no capital commitments related to any of the Plan's pooled separate accounts.

Collective Investment Trusts

Valued at the NAV of units of the individual fund. The NAV, as provided by the trustee of the invested fund, is used as a practical expedient to estimate fair value and is calculated daily by the trustee. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Withdrawals from the collective investment trusts for benefit payments are made within 30 days after the request for distribution. The collective investment trusts file annual reports on Form 5500 as direct filing entities, and there are no capital commitments related to the collective investment trusts.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The Plan has adopted the Principal Financial Group Pre-Approved Basic Savings Plan, for which a favorable opinion letter was issued to Principal Life Insurance Company by the IRS on June 30, 2020. The Plan itself has not received a determination letter. The Plan has been amended since the date of the opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC). Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

7. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Party In Interest Transactions

The Plan invests in pooled separate accounts and collective investment trusts managed by an affiliate of Principal. In addition, certain participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions are considered party in interest transactions allowable under ERISA.
