Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Melwood Horticultural Training Center, Inc. Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a health and welfare benefit plan established as of January 14, 1997, for the exclusive purpose of providing health and other benefits to eligible employees of Melwood Horticultural Training Center, Inc. (the Sponsor). Employees are eligible to participate in the Plan beginning on the first day of the month following 30 consecutive days of employment. Certain assets of the Plan are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits: The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, short and long-term disability benefits, and accidental death and dismemberment benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). The Plan also reimburses participants for eligible health-related expenses and dependent care expenses through flexible spending accounts.

Insured benefits: The Plan fully insures the vision, dental, life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), and disability benefits (short-term and long-term). The premiums for these insured benefits premiums are paid from the assets of the VEBA trust.

Self-insured benefits: The medical and prescription drug benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Stop-loss coverage: The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Contributions: In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. The Sponsor pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop loss insurance. The Sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Sponsor on a pay-as-you-go basis.

The Plan's flexible spending benefit allows employees to defer income on a pretax basis into health or dependent care flex spending accounts (FSA) subject to certain annual limitations. Participants who elect the flex spending benefit can pay allowable expenses incurred by the employee and any covered dependents that are not paid by the Plan or any other health plan. All claims must be submitted to the Plan for reimbursement no later than April 30 of the following year. Any amounts remaining in the FSA after all claims have been processed are forfeited. Forfeited amounts are used to offset Sponsor contributions in the year forfeited.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Plan obligations for claims incurred but not reported (IBNR) are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Payment of benefits: Premiums paid by either the Sponsor or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor.

Claims reserve deposit: The Plan's third-party claims processor holds a deposit from the Plan in a claims reserve account. Amounts due to the claims processors that have yet to be reimbursed by the Plan reduces the balance in the claims reserve account in the accompanying statements of net assets available for benefits.

Stop-loss: Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop loss refunds of \$972,089 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Refunds: Refunds due from the Plan's PBM are recorded when earned. For the year ended December 31, 2024, pharmacy rebates totaling \$1,112,194 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Investment valuation and income recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies and procedures and reports to the Plan's Board of Trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits. From time to time, the Plan may maintain deposits with financial institutions in amounts in excess of federally insured limits. The Plan has not experienced any losses on such deposits and believes it is not exposed to any significant credit risk on these deposits.

Expenses: As provided the by the Plan agreement, administrative expenses related to Plan assets and recordkeeping are paid by the Plan and other administrative expenses are paid by the Sponsor. Expenses of maintaining the Plan paid directly by the Sponsor are excluded from these financial statements.

Note 2. Summary of Significant Accounting Policies (Continued)

Subsequent events: The Plan has evaluated subsequent events (events occurring after December 31, 2024) through October 14, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liabilities.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Interest-bearing cash: Valued at amortized cost which approximates fair value.

Note 3. Fair Value Measurements (Continued)

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

Note 4. Related Party and Party-in-Interest Transactions

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

Note 5. Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 6. Tax Status

The VEBA trust funding health and welfare benefits was established under the Plan to hold the Plan's assets and is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (the IRC) and, accordingly, the trust's net investment income is exempt from income taxes. The trust has obtained a favorable tax determination letter from the IRS, and the Sponsor believes that the trust continues to qualify and to operate in accordance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more than likely would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
