The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

1. Description of the Plan

The following description of the ValSource, Inc. 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provision. The Plan is a defined contribution covering eligible employees of the following participating employers (the “Company”):

- a) ValSource, Inc. (VS)
- b) Concordia Valsource, LLC. (CV)

General

The Plan is a defined contribution plan covering all employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate in the Plan after 2 months of service and the participant’s entry date can be the 1st day of the month coinciding with or next following the date of eligibility.

While the Company has not expressed any intent to do so, the Company may terminate the Plan at any time.

Compensation

A participant may contribute up to 90% of pre-tax and post-tax eligible compensation, subject to certain IRC limitations. Bonuses are excluded from eligible compensation which is generally defined as total compensation subject to income tax and paid by the Company.

Contributions

In 2024 and 2023, the Company contributed 3% of eligible compensation to all eligible employees who were excluded from the ValSource, Inc. Employee Stock Ownership Plan (ESOP). Employees in the Company who are excluded from the ESOP are special work visa employees, former stockholders and their relatives.

The Plan has a discretionary employer profit sharing contribution option which is a uniform percentage of eligible Plan compensation. No Company profit sharing contributions were made in 2024 and 2023.

Effective, January 1, 2020, the Plan has an auto-enrollment provision whereby all employees becoming eligible are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a deferral rate set at 3% of eligible compensation. Auto enrollment contributions are automatically invested in a designated balance fund until changed by the participant.

Participant Accounts

Participants may elect to invest their contributions in any of the funds selected by the Company in accordance with the objectives stated in the Plan. Each participant's account is credited with the participant's contributions and allocations of the Company contributions, Company matching contributions and Plan earnings and losses, if any.

Vesting

Participants are immediately vested in all participant and employer contributions plus actual earnings thereon. Forfeitures of old non-vested account balances, if any, can be used to reduce the Company's contributions to the Plan. The total forfeitures unused at December 31, 2024 and 2023 were \$1,674 and \$1,626, respectively, and there have been no forfeitures used in 2024 or 2023.

Distributions and withdrawals

In the event of retirement, death, permanent disability or attainment of age 65, participants may make distributions either in a lump sum or in periodic payments over a period not to exceed life expectancy, as defined. A participant may also elect to receive in service distributions upon attainment of age 59 ½.

Participants may withdraw the sum of their salary reduction contributions due to hardship, medical care expenses, costs related to the purchase of a principal residence, payment of certain eligible tuition fees and certain other immediate and heavy financial needs as published by the Internal Revenue Service.

All distributions and withdrawals are subject to approval by the trustee.

Loans to participants

Participants may have up-to 5 loans outstanding and borrow from their fund accounts a minimum of \$500 up-to a maximum equal to the lesser of \$50,000 or 50% of the value of the participant's vested interest in the participant's account. Loan duration can range from 1 to 5 years, unless the loan is for the purchase of a primary residence. All loans are due in full on termination. The loans are secured by the balance in the participant's account and bear interest at Prime plus 1% fixed. As of December 31, 2024, the loan rates vary from 4.15% to 8.64%. Principal and interest are paid ratably through payroll elections.

Administrative Expenses

The Plan pays for substantially all of the administrative expenses of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on an accrual basis in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options by the participants in any of several combinations of stocks, bonds and mutual funds. Investments in mutual funds are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain mutual funds and the level of uncertainty related to changes in the value of the mutual funds, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Payment of Benefits

Benefits are recorded when paid.

Related Party Transactions

From May 31, 2023 through December 31, 2024, Plan investments include shares of funds sold and managed by Empower Trust Company, LLC (Empower). Transactions in those funds qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

From January 1, 2023 through May 31, 2023, Plan investments include shares of funds sold and managed by Transamerica Life Insurance Company (TLIC). Transactions in these funds qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value. Variable annuity investments are valued at the annuity provider's calculated valuation according to contract terms. The Reliance stable value fund is valued at the net asset value (NAV) as reported by the custodian at the Plan's year end.

Equity and bond mutual funds are valued at the net unit value as reported by the Trustee at the Plan's year-end. Shares of registered investment companies are valued at quoted market prices, which represent net asset value as of the Plan's year-end. Money market funds are valued at cost, which approximates fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

3. Information Certified by the Trustee

All Plan assets and investment transactions and participant loan balances, except for contributions received and contributions receivable, have been certified by Empower as being complete and accurate as of December 31, 2024 and for the year ended December 31, 2024.

All Plan assets and investment transactions and participant loan balances, except for contributions received and contributions receivable, have been certified by Empower and TLIC as being complete and accurate as of December 31, 2023 and for the year ended December 31, 2023.

As permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, no auditing procedures were performed on the above information other than comparison with the information contained in the financial statements and schedules.

4. Tax Status

The Internal Revenue Service has determined and informed the Plan's administrator, Pentegra Services Inc., by a letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan is designed in accordance with applicable sections of the Internal Revenue Code.

The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any

uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

6. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs are observable for substantially the full term of the asset and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of the mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The variable annuity investments are valued at the annuity provider's calculated valuation according to contract terms.
