Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Arkansas Urology, P.A. Profit Sharing Plan and 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis - as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis - for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material

misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the

audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Notes to Financial Statements
December 31, 2024 and 2023**

(1) Description of the Plan

The Arkansas Urology, P.A. Profit Sharing Plan and 401(k) Plan (the “Plan”) was established January 1, 1987. The Plan is administered by Arkansas Urology, P.A. (the “Company”). The following is a description of the major provisions of the Plan.

General: The Plan is a defined contribution plan established by the Company under the provision of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company who have completed one year of service, as defined by the Plan document, are eligible to participate, provided they are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Employee Contributions: Participants may elect to defer up to 30% of their annual compensation that does not exceed the dollar limit contained in Section 401(g) of the Internal Revenue Code. Participants who attain the age of 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with, and subject to the limitations of, Section 414(v) of the Internal Revenue Code.

Employer Contributions: The Company may, at its discretion, make an employer profit sharing contribution to the Plan. Employees must have met the eligibility requirements to participate during the year to receive this contribution. In addition, the Company may, at its discretion, make a qualified non-elective contribution to the Plan. Employees are 100% vested in the qualified non-elective contribution. The Company does not make any matching contributions.

Participant Accounts: Each participant’s account is credited with the participant’s contribution, the Company’s contributions, and an allocation of Plan earnings or losses. Earnings or losses of the Plan are allocated based upon the percentage that each participant’s account for a particular investment option bears to the total of all participant accounts for that same investment option. Terminated participants’ non-vested account balances are used to pay administrative expenses or to reduce Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting: Participants are immediately vested in their elective and employer qualified non-elective contributions plus earnings thereon. Vesting in the Company’s profit sharing contributions is determined based on years of service under the following schedule. Participants are considered fully vested in all accounts upon retirement, death, or disability.

Investment Options: Participants are permitted to direct the Trustee as to the investment of all of the assets in their individual account balances in specific assets or other investments allowed under the Plan. Participants may request details of the investment options from the Plan Administrator. Participants can change their option elections prospectively at any time.

Notes Receivable from Participants: Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) notes receivable from participants. Loan terms range from one to five years, or longer if for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at the prevailing rate for loans having similar terms and conditions, as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions with payments not less frequently than quarterly. As of December 31, 2024 and 2023, management believes all amounts are fully collectible.

Payment of Benefits: For termination of service due to any reason or upon reaching the required minimum distribution age established by the IRS, a participant may receive the value of the balance of his or her account as a lump-sum distribution or installment distributions. Partial withdrawals are allowed from an active participant's vested account only in the event of proven financial hardship.

(2) **Summary of Significant Accounting Policies**

The following is a summary of the significant accounting policies used by the Plan in the preparation of the accompanying financial statements.

Basis of Accounting: The Plan prepares its financial statements on the modified cash basis of accounting. Under this method, revenues are recognized when received and expenses are recognized when paid. The modified cash basis of accounting differs from accounting principles generally accepted in the United States of America primarily because the effects of contributions and investment income earned but not received and Plan expenses incurred but not paid are not reflected in the financial statements.

Investments: Investments are reported at fair value. Fair value is the price received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 11 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statements of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

Use of Estimates: The preparation of financial statements on a modified cash basis requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Payments of Benefits: Benefits are recorded when paid.

(3) **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan document to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participant account balances would become 100% vested.

(4) **Forfeited Accounts**

\$69,840 of forfeited balances were used to pay administrative fees during the year ended December 31, 2024. \$7,971 and \$10,132 was available in the forfeiture account as of December 31, 2024 and 2023, respectively.

(5) **Trust Expenses**

The Company absorbs a portion of the administrative expenses of the Plan. The Plan pays for administrative expenses related to investment management, trust/custody, and recordkeeping fees. The expenses paid directly by the Plan for the year ended December 31, 2024 were \$144,824.

(6) **Tax Status**

The Internal Revenue Service has issued an opinion letter dated June 30, 2020 on the Friday Eldredge & Clark volume submitter Profit Sharing Plan document stating that the form of the plan is acceptable under section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the plan administrator and the Plan's counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

The Plan's information returns are subject to examination by the Department of Labor and the Internal Revenue Service generally for three years after they are filed.

(7) Annuity Contracts

As of December 31, 2024 and 2024, the Plan held a fully benefit-responsive annuity contract with Jackson National Life (Jackson). The contract is maintained in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at fair value, which approximates contract value. Contract value represents contributions made under the respective contracts, plus earnings, less participant withdrawals and administrative expenses. The participant may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contracts have certain restrictions that impact the ability to collect the full contract value, such as withdrawal fees charged on certain withdrawals. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. Jackson may terminate their contract at any amount less than contract value. The annuity contract has both fixed and variable interest rate options. This account is held by a participant in a self-directed account that is separate from the other investments held by the Plan, therefore the earnings and expenses related to the annuity are allocated to the respective participant.

(8) Risk and Uncertainty

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

(9) Party-In-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

(10) Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedules that was certified by Matrix Trust Company, the trustee, and furnished to the plan

administrator. The plan administrator has obtained certifications from the trustee that such information is complete and accurate.

- Total investments of \$17,967,669 and \$15,361,576 as of December 31, 2024 and 2023, respectively
- Related investment income of \$2,303,652 for the year ended December 31, 2024. This related income includes realized and unrealized gains (losses), interest, and dividends.

(11) Fair Value Measurement

Under FASB ASC 820-10, three prioritized valuation inputs are used to determine the fair value at the measurement date: Level 1 – quoted prices (unadjusted) in active markets for identical assets or liabilities; Level 2 – observable inputs other than the quoted prices included in Level 1; Level 3 – unobservable inputs. There have been no changes in the methodologies used during the periods under audit, therefore no recognition of gain or loss is required for these financial statements.

Following is a description of the valuation methodologies used for assets measured at fair value:

Level 1 Fair Value Measurements

Money market funds, mutual funds, common stock, and bonds are valued based on current prices for identical assets.

Level 2 Fair Value Measurements

Annuity contracts and non-publicly traded equities are valued based on market prices but are not traded on an established market.

Investments Measured at Net Asset Value:

Common/collective trust funds are valued at the daily net asset value (NAV) of units of the collective trust, as provided by the trustee. These funds are measured at fair value using the NAV per share practical expedient and have not been classified in the fair value hierarchy. The fair value amounts presented in the tables below are intended to permit reconciliation of the fair value of investments in the fair value hierarchy to the amounts presented in the statements of net assets available for benefits. Participant transactions may occur daily. There were no unfunded commitments or relevant redemption restrictions on such investments held by the Plan for the years ended December 31, 2024 and 2023. The investment strategies for these funds are not presented as the funds file as direct filing entities.
