INDEPENDENT AUDITOR'S REPORT

To the Board of Directors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Arc of Blackstone Valley Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Arc of Blackstone Valley Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of The Arc of Blackstone Valley Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Arc of Blackstone Valley Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all

material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to, or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF PLAN:

The following description of the Arc of Blackstone Valley Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL:

The Plan was established on January 1, 1986 for the benefit of qualifying employees of The Arc of Blackstone Valley (the "Employer"). Qualifying employees are all those employed by the Employer other than those that are covered under a special worker certificate, residents of Puerto Rico, or leased employees. The Plan is a noncontributory single-employer defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

ELIGIBILITY:

Qualifying employees become participants in the plan on the first day of the plan year immediately preceding the date they attain age 21 and complete one year of eligibility service. One year of eligibility service is defined as completing at least 1,000 hours of service in the 12-month period beginning with an employee's first day of employment. Participants are eligible to receive profit sharing contributions if they have met the eligibility requirements and are employed on the last day of the Plan year. An employee who terminates employment during the Plan year due to death, disability, or attainment of normal retirement age (later of age 65 or fifth anniversary of Plan participation) is eligible to receive a contribution regardless of whether the employee meets the service and employed on last day of year requirements. An employee may elect in writing to waive participation in the Plan for any Plan year.

Employees who incur a one-year break in service (a 12-month computation period in which an employee fails to complete more than 500 hours of service) and return to employment, shall retain credit for their pre-break years of service for eligibility, vesting and accrual purposes, subject to certain rules.

CONTRIBUTIONS:

Participant contributions are not allowed under the Plan, except for certain transfers of amounts from other qualified plans in which the participant was vested (referred to hereinafter as "rollovers").

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED):

CONTRIBUTIONS (CONTINUED):

Employer contributions are discretionary and are equal to a percentage of the eligible participants' annual compensation. Effective January 1, 2016, the Employer discretionary profit sharing contribution, as negotiated in the collective bargaining agreement, ranges from 1.0% to 6.5% of annual compensation, depending on the participant's age and/or years of service as described in the following table.

VESTING:

Participants are fully vested in their own rollover contributions to the Plan and the earnings thereon.

Participants are vested in Employer contributions and the related allocated gains and losses as follows:

A year of vesting service is equal to at least 1,000 hours of service in a plan year. An employee who incurs a break in service of less than five years and returns to employment retains credit for his pre-break years of service subject to certain rules.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED):

FORFEITED ACCOUNTS:

Forfeitures of nonvested Employer contributions, including allocated investment gains and losses, are first used to reduce Employer contributions and then may be used to pay Plan expenses. In the event that the Employer does not make a discretionary contribution for a Plan year, unallocated forfeitures are allocated to eligible participants as an Employer contribution for that Plan year. Forfeitures of \$3,604 and \$3,739 were held in unallocated accounts at December 31, 2024 and 2023, respectively, and will be/were used to reduce Employer contributions for the respective year then ended.

PARTICIPANT ACCOUNTS:

Each participant's account is credited with allocations of (a) the Employer discretionary contribution, (b) Plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of any administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

PAYMENTS OF BENEFITS:

On termination of employment by reason of normal or early retirement (as defined by the Plan), death or disability, participants will be entitled to 100% of the amounts credited to their accounts. On termination of employment for other than normal or early retirement, death or disability, participants will be entitled to the vested amounts credited to their accounts. Payments are either in a lump-sum payment or in equal installments over a period of not more than the participant's individual life expectancy.

The Plan administrator may direct a distribution to a terminated participant whose vested account balance is \$1,000 or less without the consent of the participant.

The Plan provides that terminated participants must take required minimum distributions from the Plan upon the attainment of age 72 (if born after June 30, 1949) or age 70-1/2 (if born before July 1, 1949).

EXPENSES:

The Employer pays certain professional fees and other expenses related to the Plan; therefore, such expenses are not included in the accompanying financial statements. Investment-related expenses and certain other administrative expenses paid by the Plan total \$9,471 and are included in "Net appreciation in fair value of investments."

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING:

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

USE OF ESTIMATES:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("US GAAP") requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

PAYMENT OF BENEFITS:

Benefits are recorded when paid.

NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN:

The following tables summarize information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Reliance Trust Company, the trustee, without audit, and Nationwide Trust Company, FSB and furnished to the Plan administrator. The Plan administrator has obtained a certification from the trustee that such information is complete and accurate.

NOTE 4 - FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Plan management is responsible for determining the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. All investments in the Plan are Level 1 Assets.

The fair value of the mutual funds are based upon quoted net asset values of the shares held by the Plan at year end. The fair values of mutual funds were determined using Level 1 inputs.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

NOTE 5 - RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 - PLAN TERMINATION:

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Employer may determine.

NOTE 7 - TAX STATUS/UNCERTAIN TAX POSITIONS:

The Plan has adopted the Angell Pension Group, Inc. Non-standardized Profit Sharing Plan (the "Prototype Plan"). The Prototype Plan has received from the Internal Revenue Service ("IRS") an opinion letter, dated September 30, 2014, indicating that the Prototype Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investment options consist of shares of mutual funds and are managed by the trustee; accordingly, the related transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.
