## INDEPENDENT AUDITORS' REPORT

To the Trustees of

### Opinion

We have audited the accompanying financial statements of Fresno Deputy Sheriff's Association Insurance Benefit Trust Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Fresno Deputy Sheriff's Association Insurance Benefit Trust Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Fresno Deputy Sheriff's Association Insurance Benefit Trust Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Fresno Deputy Sheriff's Association Insurance Benefit Trust Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Fresno Deputy Sheriff's Association Insurance Benefit Trust Fund's internal control. Accordingly, no such opinion is expressed.



**1. DESCRIPTION OF PLAN:**

The following description of the Plan provides only general information. Participants should refer to the Plan document for complete information.

**General**

The Plan provides health, dental, vision, life and accidental death and dismemberment insurance benefits covering substantially all members of the Fresno Deputy Sheriffs' Association (The Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") as amended.

**Benefits**

The Plan provides health, dental, vision, life and accidental death and dismemberment benefits to employees who work at least 30 hours per week and who are members of the Sponsor. Retired members are eligible for Supplemental and Optional insurance only. Benefit claims are provided under insurance policies with Standard, Anthem, EyeMed Vision, Delta Dental, and PORAC Insurance companies.

**Administration**

Plan administration costs were absorbed by the Plan Sponsor.

**Concentrations of Credit Risk**

The Plan maintains cash balances in several bank accounts. Some are in excess of the \$250,000 amount insured by the Federal Deposit Insurance Corporation. The Sponsor does not consider there to be a significant risk since there has not been any losses experienced in dealing with the financial institution.

The majority of the Plan's income is received from the County of Fresno in the form of negotiated employer contributions and the employees' portion of insurance withheld from payroll.

**Contributions**

The Sponsor is required to contribute funds to pay the participants premiums. Employees and retirees may contribute specified amounts, determined periodically by the Plan's insurance companies, to extend coverage to eligible dependents.

**Plan Changes and Termination**

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to the participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provision set forth in ERISA.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

**Accounting Method**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States ("GAAP") requires the Plan to make estimates that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedule. Actual results could differ from these estimates.

**Investments**

As of December 31, 2024, and 2023, investments of the Plan are stated at fair market value. Securities are valued at the closing price reported in the active market in which the securities are traded. Purchases and sales of investments are accounted for as of the trade date. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Investments listed in the statement of net assets are not the primary source of premium payments for the Plan. The investments were derived from prior years' excess contracted employer contributions. The investment account is used to buy down new benefits or reduce premium increases at the discretion of the Plan Sponsor.

**Contributions Receivable**

Employee, employer and retiree's contributions receivable represent amounts due under terms of the insurance plan agreements chosen by the participants. Receivable amounts are reviewed monthly and are written off by management when deemed uncollectible. No interest is charged on past due receivables. An allowance is provided for accounts estimated to be uncollectible. The allowance for doubtful accounts on December 31, 2024, and 2023 was \$3,245 and \$3,245, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):**

**Experience - Rating Reserves**

Standard Insurance is an experience-rated contract. However, the potential refund from any excess premiums is not recorded as an asset because it cannot reasonably be estimated. Occasionally, refunds are issued and are reflected as income in the Statement of Changes in Net Assets Available for Benefits.

**Fair Value of Financial Instruments**

The carrying amounts reported in the accompanying statements of net assets available for benefits for cash, accounts receivable and payable qualify as financial instruments and reflect reasonable estimates of fair value because of the short period of time between the origination of these financial instruments and their expected realization, and if applicable, the stated interest rates are similar to those currently available.

**3. INVESTMENTS:**

The Plan's investments held by UBS Financial Services, Inc., party-in-interest, (including investments bought, sold and held during the year) are stated at fair value. Fair values and appreciation (depreciation) in value are summarized as follows:

**4. FAIR VALUE MEASUREMENTS:**

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

1. quoted prices for similar assets or liabilities in active markets,
2. quoted prices for identical or similar assets or liabilities in inactive markets,
3. inputs other than quoted prices that are observable for the asset or liability,
4. inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Equity funds:* Valued at the net asset value of shares held at year-end.

*Fixed income assets:* Certain corporate bonds are valued at the closing price reported in the active market in which the bond is traded. Other corporate bonds are valued based on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, the bond is valued under a discounted cash flows approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks.

**4. FAIR VALUE MEASUREMENTS (CONTINUED):**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. INCOME TAXES:**

The Plan obtained its latest determination letter on January 21, 2003, in which the Internal Revenue Service stated that the Plan, as then designed, is qualified under Section 501(c)(9) of the Internal Revenue Code and, accordingly, the Plan's net income is exempt from income taxes. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

The exempt organization and employee benefit plan returns for the three prior years for federal and four prior years for state income tax purposes are subject to examination by appropriate tax authorities. Interest and penalties, if imposed from tax positions, are recognized in the financial statements as general and administrative expenses. No interest or penalties were recorded in the financial statements as of December 31, 2024.

**7. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

**8. RELATED PARTY TRANSACTION:**

The Plan pays for administrative services provided by the Fresno Deputy Sheriffs' Association, (the plan sponsor) whose members receive insurance benefits from the Plan. For the year ended December 31, 2024, the Plan paid administrative fees of \$55,107, which are included in administrative expenses.

**9. SUBSEQUENT EVENT:**

Management has evaluated subsequent events through October 7, 2025, the date at which the financial statements were available to be issued. No significant subsequent events were discovered by management.
