**Opinion on the 2024 Financial Statements**

We have audited the accompanying financial statements of the Retirement Income Plan for Salaried Employees of the Polish National Alliance of the US of NA, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Retirement Income Plan for Salaried Employees of the Polish National Alliance of the US of NA as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

**Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. **Other Matter-2023 Financial Statements**

Accordingly, no such opinion is expressed.

1. Description of Plan

General

This plan is a single employer benefit plan of the Polish National Alliance of the United States of North America and its wholly-owned subsidiaries (The Alliance). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Pension Benefits

The Plan covers employees who have attained age 21 and completed one year of service except those for which retirement benefits were the subject of good faith bargaining of a collective bargaining agreement. The plan was restated effective January 1, 2002. Plan participants are entitled to a benefit beginning at age 65 if termination occurs at age 65, at age 55 and the completion of 15 years of vesting service, at age 60 and the completion of 8 years of vesting service, or upon termination after completing at least 3 years of vesting service.

Effective December 31, 2013 the plan was frozen. Benefit accruals ceased for existing participants and they no longer allowed new participants to enter the plan.

Pension Protection Act

The Pension Protection Act (PPA) establishes minimum funding standards and limits benefit increases and accruals for underfunded plans. Plans with a funding percentage below 80 percent will be required to implement certain benefit limitations such as restricting lump sum payments and restricting the plan from amending the plan to enhance benefits. Further limitations such as freezing the accrual of all future benefits will be required for plans that are underfunded by more than 60 percent until such time as the percentage increases above 60 percent. Additionally, pursuant to the PPA, each year actuaries are required to certify to a plan's funded percentage. The plan received such certification for the 2021 plan year for the Adjusted Funding Target Attainment Percentage (AFTAP), which is one way of measuring the funded status of a plan using actuarial assumptions mandated by the IRS, and the actuary determined that the 2021 AFTAP for the plan is 123.23 percent.

Vesting

Participants are 40% vested after three years of service increasing by 15% for each year thereafter up to seven years.

Administrative Expenses

The Alliance pays for some of the administrative costs that are incurred by the Plan. The Plan does not reimburse The Alliance for these costs. In 2024, the Plan paid legal and actuarial costs related to the termination of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Retirement Income Plan for Salaried Employees of the Polish National Alliance of the United States of North America (The Plan) was terminated in 2023 as a standard termination and the plan has changed its basis of accounting to the liquidation basis used in presenting the 2023 financial statements in accordance with FASB ASC 205-30.

Correction of an Error

The 2023 financial statements overstated net assets by \$212,549 from the accrual of income. The beginning net assets available for benefits have been restated to correct this error.

Valuation of Investments

These investments are valued at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Concentrations of Credit Risk

The Alliance maintains cash deposits in a financial institution that is insured by the Securities Investor Protection Corporation (SIPC) up to \$250,000. The uninsured amount was \$1,555,582 at December 31, 2023.

Actuarial Present Value of Accumulated Plan Benefits

The final valuation was for December 31, 2022. The plan did not have a valuation performed as of December 31, 2023 since the plan assets were disbursed in 2024 to participants through lump sum payouts or to an insurance company to provide life annuity benefits.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. In 2023, as part of the termination, the Plan began making payments to participants. Payouts were completed in 2024.

3. Funding Policy

The Plan is funded entirely by contributions made by the Polish National Alliance of the United States of North America and its subsidiaries (The Alliance). The Alliance's funding policy is to make contributions to the Plan in the amount determined by the actuaries to be the maximum recommended employer contribution necessary to meet benefit payments and administrative expenses when due under the terms of the Plan. The Alliance's contribution for 2024 and 2023 satisfied the minimum funding requirements of ERISA.

4. Plan Termination

On July 18, 2023, the Alliance elected to terminate the Plan. The participants were offered their entitled benefits in a lump sum or various types of annuities as described in the plan document. The Plan's assets were sufficient to fund the distributions and after paying plan expenses the remaining balance of \$173,659 was returned to the Alliance.

5. Information Certified By Trustee

Under the Department of Labor's regulations, certain assets and related information held by a bank, trust company or similar institution, or an insurance company, that is regulated and subject to periodic examination by a state or federal agency does not have to be audited, provided the plan administrator exercises this option and the institution holding the assets certifies the required information. Charles Schwab has provided certification as to the completeness and accuracy of the investments presented in the accompanying statements of net assets available for plan benefits as of December 31, 2023.

6. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

U.S. Government & Agency Obligations: Valued using pricing models maximizing the use of observable inputs for similar securities.

Corporate debt instruments: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, the bond is valued under a discounted cash flows approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit or liquidity risks or a broker quote if available.

Mutual Funds and Exchange Traded Funds: Valued at the closing price as reported by the fund issuer. Funds held by the Plan are open-end Mutual Funds and Exchange Traded Funds (ETFs) that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The Funds held by the Plan are deemed to be actively traded.

7. Tax Status of the Plan

The Plan is exempt from federal income taxes under the Internal Revenue Code. The Plan obtained a letter, dated March 30, 2018, stating that the form of the plan is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees, and that an employer that adopts this plan may rely on this letter with respect to the qualification of its plan under code section 401(a). The Trustees of the Plan are not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax years in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

8. Plan Amendments

The Plan was amended to freeze accrued benefits effective April 30, 2012 for nonunion employees of the Alliance Printers and Publishers, Inc. In addition, effective October 1, 2012 the Plan froze accrued benefits for union employees of the Alliance Printers and Publishers, Inc.

Effective January 1, 2014 the Plan was amended to freeze accrued benefits for employees of the Polish National Alliance, PNA Bank and Alliance Communications, Inc.

9. Related Party and Party in Interest Transactions

The Alliance absorbs the cost of audit fees related to the Plan, some administrative fees and the cost of fidelity bonds. The Alliance provides administrative services on behalf of the Plan. As the Plan does not reimburse the company for the cost of such services, they are not included in these financial statements.

10. Insurance Contract

On February 2, 2024, the Plan purchased an insurance contract with Midland National Insurance to provide annuity benefits through a group annuity contract. The premium paid was \$9,347,093. Midland National is responsible for future pension plan payments to participants who did not take a lump sum payment..

11. Subsequent Events

Subsequent events were evaluated through October 8, 2025 which is the date the financial statements were available to be issued.

There are no other recognized or non-recognized subsequent events relevant for financial statement adjustment or disclosure.
