Note 1. Description of the Plan

General

The following description of Albany Area Primary Health Care, Inc. 403(b) Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Albany Area Primary Health Care, Inc. (Company) for the benefit of its employees. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Company. Participants are required to attain age 18 and have one year of service to qualify for Company contributions. One year of service is defined as having worked 1,000 hours during the year. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

American United Life Insurance Company (AUL) and Empower Trust Company, LLC (Empower), serves as plan custodians.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation subject to the maximum amount allowed by law. Employee rollover and employee Roth contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows for special code section 403(b) catch-up contributions for those participants with 15 years of service. The Company makes matching contributions of 100% of employees' salary deferral amounts up to 3% of employees' eligible compensation. Company profit-sharing contributions are discretionary as determined by the Company's Board of Directors. For 2024 and 2023, no profit-sharing contribution was authorized. The Company no longer contributes to the accounts held by Empower.

The plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise.

Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various annuity accounts and pooled separate accounts. Each participant has the option of directing contributions into any of the investment account options selected by the Company and may change the allocation daily or to the extent permitted by the individual agreements.

Participant Accounts

Each participant's account at AUL is credited with the participant's contribution, the Company's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Each participant's account at Empower is credited with plan earnings and is charged with an allocation of administrative expenses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants or their beneficiaries. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by promissory notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Loans granted shall bear a reasonable rate of interest.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Generally, a default occurs when any scheduled payment is not paid when due. However, there will be a grace period from the due date of the missed payment through the first day of the third month after the end of the quarter in which the required payment was due but not made. If the missed payment is not made during the grace period, then a distribution will be deemed to have occurred.

All interest accrued but not collected for loans that default past the grace period is reversed against interest income.

If a participant terminates employment, all outstanding loans must be repaid in full by the first day of the third month after the end of the quarter in which the participant terminates employment unless the plan administrator, at his discretion, allows the participant to continue making payments. If the participant does not repay the entire outstanding loan balance, the participant's vested account balance will be reduced by the remaining outstanding balance of the loan.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service.

Payment of Benefits

Upon termination of service, participants with account balances that do not exceed \$1,000 will receive a lump-sum distribution. Participants with account balances equal to or greater than \$1,000 but less than \$5,000 will have their balance directly rolled over to an individual retirement account as designated by the plan administrator, unless the participant elects a direct distribution or other eligible direct rollover. Participants with account balances of \$5,000 or more may elect to receive either a lump-sum amount equal to the value of his account, installments over a period not more than the participant's assumed life expectancy (or the assumed life expectancy of the participant and his beneficiary), or a different form of annuity.

Forfeited Accounts

Forfeited nonvested accounts totaled \$701 and \$98 at December 31, 2024 and 2023, respectively. In December 31, 2024 and 2023, employer contributions were reduced by \$47,094 and \$48,297 from forfeited nonvested accounts, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments.

Pooled separate accounts are valued at net asset value (NAV) as provided by AUL. NAV is a readily determinable fair value and is the basis for current transactions.

Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the contract, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Variable annuity accounts are valued at NAV daily by Empower based on the underlying value of the mutual fund which is adjusted by an expense factor that is disclosed in the annuity contract. This NAV is a readily determinable fair value.

The fair value of the fixed annuity accounts is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Custodians

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AUL, Empower, and Empower Annuity Insurance Company of America, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain of the Plan's investments are within a group annuity contract with AUL, one of the Plan's custodians. Certain other plan investments are units of annuity accounts with Empower, another of the Plan's custodians. Therefore, these transactions qualify as party-in-interest transactions.

The Plan incurs expenses related to general administration and record-keeping. The Company pays certain accounting and auditing fees related to the Plan and provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy and include pooled separate accounts and annuity accounts. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Investment Contract with Insurance Company

The Plan has entered into a fully benefit responsive investment contract with AUL. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal, or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Contract value of the AUL Stable Value Account at December 31, 2024 and 2023, was \$405,125 and \$411,221, respectively.

The Plan elected to adopt the provisions of the Department of Labor FAB No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*, which indicates that certain inactive contracts will not be required to be part of the employer's plan assets for purposes of the annual report Form 5500. Based on this adoption, the Plan has excluded the assets held at Empower from the Form 5500.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 10. Tax Status

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. The Plan operates under a volume submitter plan document sponsored by CCH Incorporated. This document has been filed with the appropriate agency and obtained an advisory letter for the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan has not requested or obtained a determination letter, however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax.

Accounting principles generally accepted in the United States of America require Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 11. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$22 were not remitted within the required time period for the year ended December 31, 2022. The Company calculated and remitted in 2024 lost earnings and interest following the DOL guidelines for the 2022 contributions.

Note 12. Subsequent Events

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Change in Custodian

Effective October 2, 2025, the Plan was transferred to Voya Financial and a new custodian and recordkeeper were appointed. The conversion initiated a "Black Out" period beginning on October 2, 2025, and continued through October 28, 2025. During this period, funds could not be applied to the employee selected funds with the custodian or withdrawn from the Plan until the custodian had time to accurately complete the conversion. During this period, employees' contributions continued to be made through payroll deductions and contributions were deposited and held until the completion of the Black Out period. At the end of the Black Out period, these funds were transferred to the new custodian and invested in funds as requested by each participant.
