### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of M1 HOLDINGS INC. 401(K) PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of M1 HOLDINGS INC. 401(K) PLAN's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## NOTES TO FINANCIAL STATEMENTS

**NOTE 1—PLAN DESCRIPTION**

The following description of the M1 Holdings Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution plan covering all employees of M1 Holdings Inc. (the Company) and was established January 1, 2022, and later restated with an effective date of March 22, 2022.

2. Contributions

*Employee Contributions*

Each year, participants may choose to make 401(k) or Roth contributions by payroll deductions, up to 100% of their compensation, as defined in the Plan, up to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Participants who are at least age 50 may make an additional "catch-up" contribution of \$7,500 for 2024 and 2023. Participants may also roll over amounts from certain qualified plans.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1% on the anniversary of their enrollment date until their deferral rate reaches 10%.

*Employer Contributions*

For the years ended December 31, 2024 and 2023, the Plan sponsor contributed 100% of eligible compensation up to 4%. Additional discretionary amounts may be contributed by the Company at the option of the Retirement Committee. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The Company made matching contributions to the Plan of \$749,370 for 2024 and \$1,284,505 for 2023.

3. Participant Accounts - Each participant's account is credited with the participant's and employer's contributions. Allocations are based on participant contributions, Plan compensation, or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts into a variety of mutual funds and/or an annuity fund and may change their investment elections as frequently as they like.
4. Vesting - Participants are 100% vested in their contributions plus actual earnings thereon. Participants' vesting in their other employer contributions accounts is determined in accordance with a schedule based on the participant's years of service. A participant is fully vested after two years of service.
5. Forfeitures of Company's matching accounts may be used to reduce employer contributions and/or to pay for various fees of the Plan, in accordance with the Plan provisions. Forfeitures totaled \$252,823 for 2024 and \$116,051 for 2023. Employer contributions were reduced by \$212,454 for 2024 and \$85,286 for 2023. Forfeitures used to offset plan expenses were \$45,503 for 2024 and \$21,971 for 2023. Forfeitures available for future use are \$66,228 as of December 31, 2024 and \$69,912 as of December 31, 2023.

**NOTE 1—PLAN DESCRIPTION (Continued)**

6. Payment of Benefits - On termination of service, death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of their vested interest in his or her account.
7. Plan Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation on fair value of investments. Fees related to the administration of notes receivable from participants and payments of benefits are charged directly to the participant's account.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES****BASIS OF ACCOUNTING**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments held by a defined contribution plan are required to be reported at fair value, except for those investments with contract values, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Investments other than the annuity fund are stated at fair value as of December 31, 2024 and 2023.

The Empower Investments Fixed Account group annuity contract is a general account product of the Empower Annuity Insurance Company of America (EAICA). The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The crediting interest rate was 1.45% for December 31, 2024 and 1.35% for December 31, 2023.

Net appreciation on investments held represents the change in market value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the year. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**BENEFITS**

Benefits are recorded when paid.

## NOTES TO FINANCIAL STATEMENTS

**NOTE 3—FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the year ended December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

The fair value of the mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

*Level 2 Fair Value Measurements**Level 3 Fair Value Measurements*

Level 2 and level 3 fair value measurements are not applicable to the Plan for 2024 or 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4—INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's trustee, Empower Trust Company, LLC, has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- Investments, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H - Line 4(i).

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 5—NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from the employee contribution portion of their account balance. The minimum loan amount is \$1,000. The maximum loan amount is the lesser of (i) 50% of your account balance, or (ii) \$50,000 (less the highest outstanding balance of your loans from the Plan for the 12-month period prior to the day a loan is made). Repayments of principal and interest are made in substantially equal installments (not less frequently than quarterly) over the specified loan period (generally five years, unless the loan is for the purchase of a home). Interest rates are determined at the Prime rate (7.5% at December 31, 2024) plus 1% at the time the loan is taken.

**NOTE 6—TAX STATUS**

The Plan has adopted the Empower Retirement LLC Prototype Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA. The Empower plan has obtained an opinion letter from the Internal Revenue Service dated November 14, 2022, stating that the prototype plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code (IRC) Section 401. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7—PARTIAL PLAN TERMINATION**

A partial plan termination is deemed to have occurred if approximately 20% or more of plan participants are terminated by the plan sponsor. The reduction can accumulate over one or more plan years and still be classified as a partial plan termination. Judgment is needed to determine whether a partial plan termination has occurred. All affected plan participants are to be fully vested in their accounts upon termination. As a result of the strategic redirection of the Company, the Company determined that a partial termination of the plan occurred from January 18, 2024 through December 13, 2024. The determination of the partial plan termination was made on October 6, 2025. Distributions were processed during 2024 without consideration for the partial plan termination and forfeitures were incorrectly applied to the balances of affected partial plan termination participants who were not otherwise 100% vested. Incorrectly applied forfeitures resulted in accruing a partial plan termination payable due totaling \$106,377 at December 31, 2024. The Company is in process of disbursing the incorrectly forfeited amounts to affected participants.

The Company will need to make a contribution to restore the accounts for the affected partial plan termination participants. A corrective employer receivable for \$106,377 is included in the total Employer Contribution on the Statements of Net Assets Available for Benefits.

**NOTE 8—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 9—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. In addition, the majority of the expenses of the Plan are paid by the Company.

Plan investments are managed by the trustee of the Plan. The Plan's third party administrator is Empower Trust Company LLC ("Empower"). Empower is considered a party-in-interest.

Empower Annuity Insurance Company and Empower Advisory Group, LLC are named the custodian and investment manager of the Plan, respectively. Therefore, transactions with Empower Annuity Insurance Company and Empower Advisory Group, LLC qualify as party-in-interest transactions. Administrative fees paid by the Plan were \$46,885 for 2024 and \$20,184 for 2023. Other fees are included in net depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

**NOTE 10—DELINQUENT PARTICIPANT CONTRIBUTIONS**

For the year ended December 31, 2024, the Company did not remit certain participant contributions to the Plan within the timeframe required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA totaling \$204,167. The Company remitted \$204,055 to the Plan during 2024. The Company is in process of calculating lost earnings in restoration of participants' lost earnings.

For the year ended December 31, 2023, the Company did not remit certain participant contributions to the Plan within the timeframe required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA totaling \$342,700. The Company remitted \$342,700 to the Plan during 2023. The Company is in process of calculating lost earnings in restoration of participants' lost earnings.

**NOTE 11—SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 14, 2025, the date in which the financial statements were available to be issued. Except as disclosed elsewhere in the financial statements, there were no subsequent events which require disclosure.
