## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
Prudential Center/NJ Devils 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Prudential Center/NJ Devils 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### NOTES TO FINANCIAL STATEMENTS

#### Note 1 - Description of Plan:

The following description of the Prudential Center/NJ Devils 401(k) Plan (the “Plan”) provides general information only. The Plan Sponsor of the Plan is New Jersey Devils, LLC (the “Company”). The Plan also allows employees from related employers, Devils Arena Entertainment, LLC, and WEH Presents, LLC, to participate in the Plan. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** - The Plan which became effective January 1, 1987, is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Administration** - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by Fidelity Management Trust Company, the Trustee, who is responsible for the custody and management of the Plan’s assets.

**Eligibility** - The Plan is available to the employees of the Company that obtained the age of 21 and, are not covered by a collective bargaining agreement, a leased employee, a nonresident alien, a part-time or seasonal employee, or an employee who is eligible for the NHL plan are eligible to participate in the Plan. There is no service requirement for employee deferral contributions. The date on which an employee is permitted to enter the Plan is on the first day of each month following the date an employee satisfies the eligibility requirements.

**Contributions** - Eligible employees may defer up to 92% of compensation as defined on a “pre-tax basis” or “Roth basis” subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 by the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for safe harbor matching contributions equal to 100% up to 5% of participant contributions, which amounted to \$1,401,149 for the year ended December 31, 2024. To receive safe harbor matching contributions, employees must obtain 1,000 hours within one year of service. Additionally, the Employer may make non-elective employer contributions and discretionary employer matching contributions. The participant must be employed at the end of the Plan year in order to receive the non-elective employer contributions. There were no non-elective employer contributions and discretionary employer matching contributions made to the Plan for the year ended December 31, 2024.

**Participant Accounts** - Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution, (b) Plan earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Forfeitures** - Forfeitures are created when participants terminate employment with the Company and are not fully vested in the discretionary employer matching contribution and non-elective employer contribution, the participant will forfeit the non-vested portion of these contributions. Forfeiture of these contributions will first be used to pay administrative expenses and then used to reduce future employer contributions. No forfeitures were utilized during the year ended December 31, 2024. The forfeiture balance at December 31, 2024 and 2023 was \$7,458 and \$105, respectively.

### NOTES TO FINANCIAL STATEMENTS

**Vesting** - Participants are vested immediately in their contributions, rollover contributions and safe harbor matching contributions plus actual earnings thereon. A participant's vested percentage in their actual balance attributable to the discretionary employer matching contribution and non-elective employer contribution is based on vesting years of service as set forth below. Service from a related employer, Philadelphia 76ers L.P. and Delaware 87ers LLC will be included when vesting is being calculated for participants.

**Payment of Benefits** - On termination of service due to death, disability, retirement, or hardship a participant will receive a lump-sum amount equal to the vested interest in his or her account. If the vested balance exceeds \$5,000 as of the date of distribution, the participant may receive a distribution from the Plan, as soon as administratively feasible, following the termination of employment. If the participant does not consent to a distribution, the balance will remain in the Plan. If the vested balance is between \$1,000 and \$5,000 and if the participant does not consent to the distribution, then the amount will be automatically rolled over into an IRA selected by the Plan Administrator. If the vested balance is \$1,000 or less, the entire amount will be distributed to the participant as a lump-sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If death occurs prior to retirement, the participant's account is paid to the designated beneficiary.

#### **Note 2 - Summary of Significant Accounting Policies:**

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustee. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Recordkeeping and investment management fees are also included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Payment of Benefits** - Benefits are recorded when paid.

**Hardship Withdrawals** - Under certain conditions, participants, while still employed by the Plan Sponsor, are permitted to withdraw, in a single-sum, the employee contribution portion of their account balance. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of postsecondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence, or to prevent eviction or foreclosure from the participant's principal residence.

**Cash and Equivalents** - Cash and equivalents includes money market funds with highly liquid short-term investments purchased with maturities of three months or less.

**Subsequent Events** - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024 through October 13, 2025, the date the financial statements were available to be issued. The effect of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

#### **Note 3 - Certified Investment Information:**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, as shown on the ERISA-required supplemental schedule of assets held (at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

#### Note 4 - Common Collective Trust:

The Plan invests in investment contracts through its common collective trust (“CCT”). The CCT’s fair value is a relevant measurement attribute. The CCT held by the Plan is a stable value investment which has an objective to preserve capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective, the fund invests primarily in synthetic guaranteed investment contracts and cash equivalents. Redemptions are allowed for participants daily, however, in the event of a complete redemption, the Plan is subject to a one-year redemption notice period which may be waived by the trustee. There are no unfunded commitments.

#### Note 5 - Fair Value Measurements:

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the closing price in the active market in which the fund is traded.
- *Cash and equivalents*: Valued at the closing price in the active market in which it is traded.
- *Common collective trust*: Investments in regulated investment companies or other trust pooled funds are valued at the net asset per share/unit on the valuation date. The net asset value is used as a practical expedient to estimate fair value. The underlying assets of the trust are normally valued based on their closing sales price or, in the absence of sales, at their reported bid price. (See Note 4).

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTES TO FINANCIAL STATEMENTS**

#### **Note 6 - Risks and Uncertainties and Concentration of Investment Risk:**

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

The Plan may invest in funds with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan's investment in one fund comprises approximately 15% of total investments for the year ended December 31, 2024. The Plan's investment in one fund comprises approximately 16% of total investments for the year ended December 31, 2023.

#### **Note 7 - Notes Receivable from Participants:**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested and non-forfeitable account balance, whichever is less, and may not have more than one loan outstanding at any time. Loans are secured by the balance in the participant's account and bear interest at a reasonable interest rate as reflected by local banks. Principal and interest are paid ratably through semi-monthly payroll deductions.

#### **Note 8 - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of Internal Revenue Code (IRC). In the event of Plan termination, participants' contributions remain fully vested and Company contributions, if any, become fully vested. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

#### **Note 9 - Tax Status:**

The Plan was written on an IRS Non-Standardized Pre-Approved Document, which obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **Note 10 - Party-in-Interest:**

The Trustee provides administrative and investment management services to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid for administrative, investment management and record keeping services totaled \$82,544 for the year ended December 31, 2024.

#### **Note 11 - Commitments and Contingencies:**

The Company has discovered certain instances whereby the Plan's operations are inconsistent with the terms of the Plan. The Company has consulted with legal counsel and is in the process of determining the proper methods of correction in accordance with the IRS under the Employee Plans Compliance Resolution System ("EPCRS"). The amount of the adjustment in question is not determinable at this time.

## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
Prudential Center/NJ Devils 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Prudential Center/NJ Devils 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### NOTES TO FINANCIAL STATEMENTS

#### Note 1 - Description of Plan:

The following description of the Prudential Center/NJ Devils 401(k) Plan (the “Plan”) provides general information only. The Plan Sponsor of the Plan is New Jersey Devils, LLC (the “Company”). The Plan also allows employees from related employers, Devils Arena Entertainment, LLC, and WEH Presents, LLC, to participate in the Plan. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** - The Plan which became effective January 1, 1987, is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Administration** - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by Fidelity Management Trust Company, the Trustee, who is responsible for the custody and management of the Plan’s assets.

**Eligibility** - The Plan is available to the employees of the Company that obtained the age of 21 and, are not covered by a collective bargaining agreement, a leased employee, a nonresident alien, a part-time or seasonal employee, or an employee who is eligible for the NHL plan are eligible to participate in the Plan. There is no service requirement for employee deferral contributions. The date on which an employee is permitted to enter the Plan is on the first day of each month following the date an employee satisfies the eligibility requirements.

**Contributions** - Eligible employees may defer up to 92% of compensation as defined on a “pre-tax basis” or “Roth basis” subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 by the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for safe harbor matching contributions equal to 100% up to 5% of participant contributions, which amounted to \$1,401,149 for the year ended December 31, 2024. To receive safe harbor matching contributions, employees must obtain 1,000 hours within one year of service. Additionally, the Employer may make non-elective employer contributions and discretionary employer matching contributions. The participant must be employed at the end of the Plan year in order to receive the non-elective employer contributions. There were no non-elective employer contributions and discretionary employer matching contributions made to the Plan for the year ended December 31, 2024.

**Participant Accounts** - Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution, (b) Plan earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Forfeitures** - Forfeitures are created when participants terminate employment with the Company and are not fully vested in the discretionary employer matching contribution and non-elective employer contribution, the participant will forfeit the non-vested portion of these contributions. Forfeiture of these contributions will first be used to pay administrative expenses and then used to reduce future employer contributions. No forfeitures were utilized during the year ended December 31, 2024. The forfeiture balance at December 31, 2024 and 2023 was \$7,458 and \$105, respectively.

### NOTES TO FINANCIAL STATEMENTS

**Vesting** - Participants are vested immediately in their contributions, rollover contributions and safe harbor matching contributions plus actual earnings thereon. A participant's vested percentage in their actual balance attributable to the discretionary employer matching contribution and non-elective employer contribution is based on vesting years of service as set forth below. Service from a related employer, Philadelphia 76ers L.P. and Delaware 87ers LLC will be included when vesting is being calculated for participants.

**Payment of Benefits** - On termination of service due to death, disability, retirement, or hardship a participant will receive a lump-sum amount equal to the vested interest in his or her account. If the vested balance exceeds \$5,000 as of the date of distribution, the participant may receive a distribution from the Plan, as soon as administratively feasible, following the termination of employment. If the participant does not consent to a distribution, the balance will remain in the Plan. If the vested balance is between \$1,000 and \$5,000 and if the participant does not consent to the distribution, then the amount will be automatically rolled over into an IRA selected by the Plan Administrator. If the vested balance is \$1,000 or less, the entire amount will be distributed to the participant as a lump-sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If death occurs prior to retirement, the participant's account is paid to the designated beneficiary.

#### **Note 2 - Summary of Significant Accounting Policies:**

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustee. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

*Administrative Expenses* - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Recordkeeping and investment management fees are also included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

*Payment of Benefits* - Benefits are recorded when paid.

*Hardship Withdrawals* - Under certain conditions, participants, while still employed by the Plan Sponsor, are permitted to withdraw, in a single-sum, the employee contribution portion of their account balance. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of postsecondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence, or to prevent eviction or foreclosure from the participant's principal residence.

*Cash and Equivalents* - Cash and equivalents includes money market funds with highly liquid short-term investments purchased with maturities of three months or less.

*Subsequent Events* - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024 through October 13, 2025, the date the financial statements were available to be issued. The effect of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

#### **Note 3 - Certified Investment Information:**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, as shown on the ERISA-required supplemental schedule of assets held (at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

### NOTES TO FINANCIAL STATEMENTS

#### Note 4 - Common Collective Trust:

The Plan invests in investment contracts through its common collective trust (“CCT”). The CCT’s fair value is a relevant measurement attribute. The CCT held by the Plan is a stable value investment which has an objective to preserve capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective, the fund invests primarily in synthetic guaranteed investment contracts and cash equivalents. Redemptions are allowed for participants daily, however, in the event of a complete redemption, the Plan is subject to a one-year redemption notice period which may be waived by the trustee. There are no unfunded commitments.

#### Note 5 - Fair Value Measurements:

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the closing price in the active market in which the fund is traded.
- *Cash and equivalents*: Valued at the closing price in the active market in which it is traded.
- *Common collective trust*: Investments in regulated investment companies or other trust pooled funds are valued at the net asset per share/unit on the valuation date. The net asset value is used as a practical expedient to estimate fair value. The underlying assets of the trust are normally valued based on their closing sales price or, in the absence of sales, at their reported bid price. (See Note 4).

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Transfers Between Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, respectively, there were no significant transfers in or out of levels 1, 2, or 3.

#### **Note 6 - Risks and Uncertainties and Concentration of Investment Risk:**

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

The Plan may invest in funds with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan's investment in one fund comprises approximately 15% of total investments for the year ended December 31, 2024. The Plan's investment in one fund comprises approximately 16% of total investments for the year ended December 31, 2023.

#### **Note 7 - Notes Receivable from Participants:**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested and non-forfeitable account balance, whichever is less, and may not have more than one loan outstanding at any time. Loans are secured by the balance in the participant's account and bear interest at a reasonable interest rate as reflected by local banks. Principal and interest are paid ratably through semi-monthly payroll deductions.

#### **Note 8 - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of Internal Revenue Code (IRC). In the event of Plan termination, participants' contributions remain fully vested and Company contributions, if any, become fully vested. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

#### **Note 9 - Tax Status:**

The Plan was written on an IRS Non-Standardized Pre-Approved Document, which obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **Note 10 - Party-in-Interest:**

The Trustee provides administrative and investment management services to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid for administrative, investment management and record keeping services totaled \$82,544 for the year ended December 31, 2024.

#### **Note 11 - Commitments and Contingencies:**

The Company has discovered certain instances whereby the Plan's operations are inconsistent with the terms of the Plan. The Company has consulted with legal counsel and is in the process of determining the proper methods of correction in accordance with the IRS under the Employee Plans Compliance Resolution System ("EPCRS"). The amount of the adjustment in question is not determinable at this time.
