We have performed audits of the accompanying financial statements of the Consolidated 401(k) Plan of the Baton Rouge Water Company and Louisiana Water Company, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Consolidated 401(k) Plan of the Baton Rouge Water Company and Louisiana Water Company's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Consolidated 401(k) Plan of the Baton Rouge Water Company and Louisiana Water Company's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Note 1-Description of Plan**

The following description of the Consolidated 401(k) Plan of the Baton Rouge Water Company and Louisiana Water Company (“Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**A. General**

The Plan is a defined contribution plan covering substantially all full-time employees of Baton Rouge Water Company and Louisiana Water Company (collectively referred to herein as “Employer”) hired on or after January 1, 2013, and is intended to be a qualified retirement plan under the Internal Revenue Code (IRC). Effective January 1, 2023, the Plan was amended to add Owen and White, Inc. as an Adopting/Participating Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan was established to provide employees with an opportunity to accumulate funds for retirement. Ascensus Trust Company (trustee) holds the Plan’s investment assets and executes investment transactions.

**B. Contributions**

*Participant*

An eligible participant may enter into a salary redirection agreement under which the Employer will redirect a portion of the participant’s compensation during the Plan year. Participants may elect to contribute 1% to 50% of annual earned compensation, not to exceed federal limits. The Plan also allows rollover contributions which represent distributions from other qualified plans.

*Employer – Matching Contributions*

Employer matching contributions are made to the accounts of participants who make employee salary deferrals and/or after-tax contributions to the Plan. The Employer matches 50% of the first 3% of each participant’s salary redirection amount. Employer matching contributions are credited to the Employer Matching Contribution Account.

*Employer – Base Contributions*

Employer base contributions are made to the accounts of eligible participants in the amount of 3% of each participant’s compensation for the payroll period. Employer base contributions are credited to the Employer Base Contribution Account of each eligible participant.

**C. Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer’s matching contributions, (b) the Employer’s base contributions, and (c) any plan earnings (losses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All funds are participant-directed. If a participant fails to elect an investment, a default investment will be chosen.

**D. Vesting**

Participants are immediately vested in their voluntary contributions and the Employer's contributions plus actual earnings thereon; therefore, forfeitures are not applicable.

**E. Payment of Benefits**

On termination of service due to retirement, death, or permanent disability, participants with vested account balances of greater than \$5,000 shall elect a lump sum distribution equal to the value of his or her account. If upon a participant's termination, the vested balance of the participant's individual account does not exceed \$1,000, the Plan shall distribute the vested portion directly to the participant, unless the participant elects to have such distribution paid directly to an eligible retirement plan. If the vested balance is greater than \$1,000 but does not exceed \$5,000, the Plan shall distribute the vested balance in the form of a direct rollover to an individual retirement account, unless the participant elects to have such distribution paid directly to an eligible retirement plan or receive the distribution directly.

**F. SECURE 2.0 Act Compliance**

Effective January 1, 2024, the Plan implemented required operational changes in accordance with the SECURE 2.0 Act of 2022. As a safe harbor 401(k) plan, the following mandatory provisions were applicable for the 2024 plan year:

- *Long-Term, Part-Time Employee Eligibility:* The Plan already allows part-time employees to participate after completing 12 months of service, regardless of hours worked. Therefore, the SECURE 2.0 provision requiring eligibility after three consecutive years of 500 hours of service did not result in a change to the Plan's eligibility criteria.
- *Roth Account RMD Elimination:* The Plan does not currently offer designated Roth accounts. However, in accordance with SECURE 2.0, when Roth accounts are added in the future, required minimum distributions (RMDs) from those accounts will not be mandatory.

These provisions were implemented operationally in accordance with IRS guidance. Formal plan amendments to reflect these changes are not required until the extended amendment deadline of December 31, 2026. The Plan Sponsor intends to adopt all required amendments within this timeframe.

**Note 2-Summary of Significant Accounting Policies**

**A. Basis of Accounting**

The accompanying financial statements are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**B. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from plan net assets during the reporting period. Accordingly, actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

The Plan's investments in shares of registered investment companies (mutual funds) and exchange traded funds are stated at fair value based on quoted market prices.

The Plan accounts for its investments in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*. As required by ASC 962, the accompanying statements of net assets available for benefits present the fair value of the Plan's investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**D. Payment of Benefits**

Benefits are recorded when paid.

**E. Operating Expenses**

Administrative expenses of the Plan are paid from the Plan; however, the Employer may elect to pay some or all such expenses. Fees specific to the participant's investment selections and accounts, such as managed account fees, are charged against that participant's account balance.

**Note 3-Fair Value Measurement**

FASB ASC 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Exchange Traded Funds:* Valued at the closing price reported on the active market in which the individual securities are traded.

**Note 4-Tax Status**

The Internal Revenue Service has determined and informed the Employer by a letter dated January 27, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5-Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100 percent vested in the employer contributions allocated to their accounts.

**Note 6-Financial Data Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Ascensus Trust Company (“Ascensus”) and was not subjected to any auditing procedures performed by the independent public accountants:

- Investments in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and dividends in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of assets (held at end of year) as of December 31, 2024.

**Note 7-Related Party Transactions**

Ascensus holds and manages investments for the Plan and these transactions qualify as party-in-interest transactions as defined by the Plan. During 2024, the Plan paid administrative expenses of \$2,205 to Ascensus, which were paid by the participants through the Plan.

**Note 8-Risks and Uncertainties**

The Plan invests in various investment securities which are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. It is not possible at this time to reasonably estimate the possible loss or range of loss, if any.

**Note 9-Subsequent Events**

Management of the Plan evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued. As a result, management noted no subsequent events which required adjustment to, or disclosure in, these financial statements.
