#### Note 1 - Plan Description

The following description of the Saltchuk Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan established by Saltchuk Resources, Inc. (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is a defined contribution plan covering employees of the Company and all subsidiaries of the Company.

**Plan Merger** - The Company acquired Naniq Global Logistics LLC (Naniq) during 2020. Naniq employees were eligible to participate in the Plan beginning January 1, 2024 and the Naniq Global Logistics LLC 401(k) Plan merged into the Plan March 1, 2024. Assets transferred into the Plan as a result of the merger included cash of \$968,507 and notes receivable from participants of \$7,572.

The Company acquired OSG Ship Management, Inc. (OSG) on July 10, 2024. As a result, the Company became the sponsor of the OSG Ship Management, Inc. Savings Plan (OSG Plan). Effective August 1, 2025, the OSG Plan was merged into the Plan. Assets transferred into the Plan as a result of the merger totaled approximately \$52,000,000.

**Eligibility** - The Plan excludes leased employees, nonresident aliens, certain residents of Puerto Rico and interns. Union employee participation is determined by the collective bargaining agreements and certain union employees are excluded. The Plan also excludes temporary, casual, or on-call employees (Temporary Employees) unless they are 18 and have completed one year of service and are employed on the last day of the plan year, at which point the Temporary Employees are eligible on the following day. All other employees who have attained age 18 become eligible to participate in the Plan upon commencing employment. Effective May 1, 2024, the Plan no longer excludes Temporary Employees.

**Employee Groups** - The Plan has certain provisions for employees that were previously in the Foss Maritime Company 401(k) Plan (the Foss Plan). Employees of the Foss Plan who are members of a collective bargaining unit and are employed at Saltchuk Marine, LLC (Saltchuk Marine) and employees at Young Brothers, LLC who are union employees and provided for in the collective bargaining agreement are referred to as Tier III Employees (Tier III Employees). Employees of Saltchuk Marine that are covered by the collective bargaining agreement with Inlandboatmen's Union of the Pacific, Columbia River Region are considered Tier IV Employees (Tier IV Employees).

**Contributions** - Employees may elect to defer up to 80% of their compensation as pre-tax or Roth contributions and up to 10% of their compensation for after-tax contributions. The Plan has adopted an automatic enrollment feature under which new employees (with the exception of employees of Hawaii Petroleum Inc., Naniq Global Logistics LLC and union employees covered by a collective bargaining agreement for which the agreement does not provide for auto enrollment) are enrolled with a 2% pre-tax deferral rate unless they formally waive participation or elect a different participation level. The rate for participant's automatically enrolled in the Plan increases by 1% per year to a maximum of 15%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover).

Foreign Vessel Officers (FVO's) are permitted only to make after-tax contributions.

The Company makes safe harbor matching contributions equal to 100% of employee pretax and Roth contributions up to 4% of eligible compensation. Matching contributions are not made on after-tax contributions with the exception of FVO's that have a safe harbor matching contribution equal to 100% of after-tax contributions up to 4% of eligible compensation. Tier III employees receive no matching contributions.

True-up contributions are at the discretion of each participating employer. All employers elected to make a true-up contribution for the year ended December 31, 2024.

The Company may also make discretionary nonelective contributions. In the event a nonelective contribution is approved, each participating employer has two options for the discretionary nonelective contributions. Employers can either elect 3% of eligible compensation plus 3% of eligible compensation in excess of social security wages (the Integrated Formula) or they can contribute up to 3% of eligible compensation for all employees that have ten years or more of service (the Service Based Formula).

**Participant Accounts** - Each participant's account is credited with the participant's contributions and matching contributions, as well as allocations of the Company's nonelective contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** - Participants are immediately vested in their salary deferral contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's nonsafe-harbor matching and nonelective contributions is based on years of continuous service. The Plan includes legacy vesting for certain contributions that were accumulated prior to merging into the Plan as defined in the plan document. Vesting for contributions other than salary deferral and safe harbor matching contributions vest on either a six year graded vesting schedule or a two year cliff vesting schedule in accordance with the plan documents.

**Forfeitures** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$250,000 and \$155,000, respectively. During 2024, approximately \$557,000 in forfeited accounts were used in accordance with the provisions specified in the Plan document.

**Payment of Benefits** - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive an installment, annuity or lump-sum distribution equal to the value of the participant's vested interest in their account. Participants who have attained the early retirement age of 55 may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan and after-tax contributions to the Plan. Additionally, the portion of the participant's account attributable to the nonelective contribution account transferred from the TOTE Services, Inc. Retirement Plan (the TOTE Plan) into the Totem Ocean Trailer Express, Inc. Retirement Plan are eligible for in-service withdrawal after 60 months from the participation date the participant first entered the TOTE Plan.

**Notes Receivable From Participants** - A participant may borrow the lesser of \$50,000 or 50% of their vested balance, with a minimum loan of \$1,000. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The interest rate is set at 1.0% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

#### Note 2 - Significant Accounting Policies

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments represents the change in fair value of assets from one period to the next and realized gains and losses on investments.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Investment Management and Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Administrative costs for investment consulting and recordkeeping services are paid by the Plan. Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements. Transaction based fees for loans and distributions are charged directly to participant accounts. The Company may elect to pay other expenses related to the Plan's administration.

**Subsequent Events** - The Plan's management has evaluated subsequent events through October 9, 2025, the date on which the Plan's financial statements were available to be issued.

#### Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - The funds are valued at the NAV of units of the collective trust funds. The NAV is used as a practical expedient to measure fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Self-Directed Brokerage Accounts - Accounts primarily consist of mutual funds and common stocks that are valued based on readily determinable market prices.

#### Note 4 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

#### **Note 5 - Party-in-Interest Transactions**

Certain plan investments are shares of mutual funds managed by the Fidelity and its affiliates. Transactions with such investments and fees charged by Fidelity and its affiliates for managing investments qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

#### **Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

During 2025, the Company sold StratAir, LLC and terminated employees of StratAir, LLC and determined there was a partial termination of the Plan. All affected participants became fully vested in their accounts.

#### **Note 7 - Tax Status**

The Plan obtained its latest determination letter dated October 17, 2018, in which the IRS states that the Plan, as then designed, was in compliance with applicable requirements of the IRC. The Plan also received an opinion letter from the Puerto Rico Treasury Department dated July 7, 2021 indicating the Plan meets the requirements of the Puerto Rico Revenue Code. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Risks and Uncertainties**

The Plan provides for various investment fund options, which in turn invest in a combination of investment securities such as stocks, bonds, and others. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **Note 9 - Delinquent Contributions**

Defined contribution plans are required to remit employee contributions (and loan repayments) to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$53,644 were not remitted within the required time period during 2024 and qualify as prohibited party-in-interest transactions under ERISA. Delinquent contributions also represent a related party transaction between the Plan and the plan sponsor. The Company restored lost earnings associated with delinquent deposits totaling \$53,644 during 2025.
