REPORT OF INDEPENDENT AUDITORS

To the Participants and Investment Committee of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Bobby Cox Companies, Inc. 401(k) Savings Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or was derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

A. Description of the Plan

General

The following brief description of the Bobby Cox Companies, Inc. 401(k) Savings Plan (the “Plan”) is provided for general information purposes only. The Plan is sponsored by Bobby Cox Companies, Inc. (the “Company”). Participants should refer to the Plan document for more complete information. The Company’s corporate offices are located in Fort Worth, Texas.

The Plan was effective January 1, 1996, and is a defined contribution plan available to substantially all employees of the Company and its controlled group. Eligible employees of the Company and its controlled group are permitted to make pre-tax contributions that are tax-deferred under Section 401(k) of the Internal Revenue Code (the “Code”) or post-tax contributions. The Plan is intended to satisfy the requirements for a qualified retirement plan under the appropriate provisions of the Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Controlled members include BDC Properties, Inc.; BDC Construction, Inc.; Southern Solar Franchise Systems, LLC; Flyaway, Inc.; CVA Advertising & Marketing, Ltd.; Cox Marketing, Inc.; Storm Guard Franchise Systems, LLC; Rosa’s Café and Tortilla Factory, Ltd.; Taco Villa, Ltd.; The Original Texas Burger, LLC; and Oregano’s AZ, LLC. Effective August 21, 2023, Oregano’s AZ, LLC was added as a controlled member and employees were eligible to participate in the Plan.

All employees of the Company and its participating affiliates are eligible to participate in the Plan on the entry date (first day of the month) coincident with or following the completion of one year of service, as defined by the Plan. A year of service is the completion of not less than 1,000 hours of service in a twelve consecutive month period (initially, beginning the day an employee first performs an hour of service and subsequently, the period ending December 31). Also, all employees must meet the minimum age requirement of twenty-one years old.

The purpose of the Plan is to encourage the Company’s employees to save and invest, systematically, a portion of their current compensation so that they and their families may have a source of additional income upon their retirement, or in the event of death.

Contributions

Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. In addition, participants may contribute designated Roth (after tax) contributions. All contributions are subject to limitations on annual additions and other limitations imposed by the Code as defined in the Plan document. Eligible participants may make rollover contributions to the Plan.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the year may make catch-up contributions in accordance with, and subject to, the limitations imposed by the Code.

A. Description of the Plan – continued

Contributions – continued

Employees contribute each period through authorized payroll deductions. The Company makes safe harbor matching contributions to Plan participants in an amount equal to 100% of a participant's first 3% of compensation and 50% of the next 2% of compensation that exceeds 3% for a maximum of 4% matching contribution.

The Company may also make additional discretionary matching contributions and profit sharing contributions. To receive a profit sharing contribution from the Company, participants must have worked 1,000 hours during the Plan year and be employed on the last day of the Plan year. These contributions are determined annually by the Company. The Company made no additional discretionary matching or profit sharing contributions during 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of: (a) the matching contributions and additional discretionary matching and profit sharing contributions and (b) Plan earnings, and charged with applicable administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and matching contributions, plus actual earnings thereon. Vesting in the Company's additional discretionary matching and profit sharing contributions is determined by years of continuous service. A participant is 20% vested after two years of credited service, 20% for each additional year, and is fully vested after six years of service. A participant is 100% vested, regardless of years of service, in the event of disability, attaining normal retirement age, or death.

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balances. Participants may have a maximum of three loans outstanding at any time, of which one may be for a primary residence. Loan terms range up to five years or longer for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Company. As of December 31, 2024 and 2023, interest rates ranged from 3.25% to 10.50%. Principal and interest are paid ratably through payroll deductions. Loans are due in varying amounts through November 2032. Participant loans are classified as notes receivable from participants in the Plan's financial statements.

A. Description of the Plan – continued

Benefit Payments

Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their vested account balances. Benefits are distributed in the form of lump-sum payments or periodic installments for required minimum distribution purposes only. Certain in-service withdrawals are allowed. A participant may also elect to withdraw all or a portion of his/her account balance while employed after reaching age 59 ½. If withdrawing participants are not entitled to their entire account balances, the amounts not received are forfeited.

The threshold for mandatory distributions is account balances greater than \$7,000. If a participant's non-forfeitable accrued benefit does not exceed \$7,000, then settlement occurs as a lump-sum payment made within 60 days after the December 31st following termination of employment. If a participant's non-forfeitable accrued benefit exceeds \$7,000, then the participant has the option to elect the method used to distribute their benefits.

A participant may receive a hardship distribution from salary reduction contributions if the distribution is: (1) on account of uninsured medical expenses incurred by the participant, his/her spouse, or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post-secondary tuition expenses for the participant, his/her spouse, or dependents; (4) for the payment of funeral or burial expenses for the participant's parent, spouse, or dependent; (5) needed to prevent eviction of the participant from his/her principal residence or foreclosure upon the mortgage of the participant's principal residence; or (6) for expenses relating to the repair of damage to the participant's primary residence.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts are used to pay administrative expenses that would be paid by the Company or to offset employer matching contributions for the year. No forfeitures were allocated to reduce matching contributions during the years ended December 31, 2024 and 2023. Additionally, there were no unallocated forfeitures outstanding as of December 31, 2024 and 2023.

Investment Options

Upon enrollment in the Plan, a participant may direct his/her salary deferrals into any of the Plan's investment options. Participants may change their investment options any time throughout the year via the internet or direct phone access to the Plan's third-party administrator.

A. Description of the Plan – continued

Plan Expenses

Employees of the Company perform certain administrative functions with no compensation from the Plan. In accordance with Plan provisions, the Company pays substantially all costs relating to recordkeeping. All significant administrative expenses are paid by the Company and are not reflected in the accompanying financial statements. Certain Plan expenses, such as transaction fees from receiving a loan, withdrawal, or distribution from the Plan, are deducted from individual participants' accounts or investment income.

B. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Contributions

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Investment Valuation and Income

The investments of the Plan are stated at fair value as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan's valuation methodologies.

Purchases and sales of securities are recorded on a trade date basis. The net realized and unrealized gains on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the fair value of investments held at year-end. Capital gain distributions from mutual funds that are reinvested are included with interest and dividends on the statements of changes in net assets available for benefits. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

B. Summary of Significant Accounting Policies – continued

Notes Receivable from Participants

Notes receivable from participants are recorded at the unpaid principal balance plus accrued but unpaid interest. Delinquent loans are treated as an asset on the statements of net assets available for benefits and continue to accrue interest until a distributable event takes place. Loans are considered to be in default and cancelled according to the terms of the loan policy. Loans in default are classified as benefits paid to participants on the statements of changes in net assets available for benefits. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Cash and Cash Equivalents

All highly liquid investments with a maturity of three months or less when purchased are treated as cash equivalents. At December 31, 2024 and 2023, the Plan held such investments in one financial institution, which did not exceed amounts covered by insurance provided by the U.S. Federal Deposit Insurance Corporation.

C. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities in active markets, based upon quoted prices for identical or similar assets or liabilities within inactive markets, inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

NOTES TO FINANCIAL STATEMENTS (continued)

C. Fair Value Measurements – continued

The methodologies used to measure the fair value of the Plan’s investments are as follows:

- Mutual funds: Mutual funds are valued based on quoted market prices in the active market in which they are traded and are classified within Level 1 of the valuation hierarchy.
- Collective investment trust: The collective investment trust is made up of a stable value fund that is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value (“NAV”) of shares held by the Plan based on the fair value of the underlying assets reported in the audited financial statements of the Morley Stable Value Fund. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following tables detail the Plan’s investments at fair value by level, within the fair value hierarchy, as of December 31, 2024 and 2023. As of December 31, 2024 and 2023, the Plan has no assets classified within Level 2 or 3 of the valuation hierarchy.

D. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net realized and unrealized gains on investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by BOKF, NA (the trustee of the Plan).

E. Tax Status

Effective January 1, 2019, the Plan was amended and restated by the adoption of the BOKF NA Non-Standardized Safe Harbor Profit Sharing Prototype Plan with CODA, which has a favorable opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020. This opinion letter states that the form of the prototype plan is acceptable under Section 401 of the Code. The Company may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Company believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, all amounts credited to participants’ accounts will become 100% vested.

G. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

H. Parties-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Notes receivable from participants to the Plan qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.
