INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Corrugated Supplies Company, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Corrugated Supplies Company, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Corrugated Supplies Company, LLC 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.



- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Corrugated Supplies Company, LLC 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

NOTE A--DESCRIPTION OF PLAN

The following description of the Corrugated Supplies Company, LLC 401(k) Plan (the "Plan") provides only general information. Users should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is sponsored by Corrugated Supplies Company, LLC (the "Company") for employees that meet specific eligibility requirements, as defined in the Plan's provisions. Affiliated company MiniMill Management, LLC is a participating employer under the Plan for the benefit of their employees and is bound by all elections selected by the Company. The Plan, designated as a defined contribution plan, was originally established on September 1, 1997, and most recently amended and restated January 1, 2023 (see Note J). The Plan provides for contributions to be made under salary deferral agreements pursuant to Section 401(k) of the Internal Revenue Code (the "Code"). Non-leased employees of the Company are eligible to participate after completing one month of service. Employees are eligible to enter the Plan on the first day of the month following satisfaction of the eligibility requirements.

The Plan is subject to the provisions of the Employee Retirement Income and Security Act of 1974 ("ERISA"). The Plan Administrator and Plan Trustees are responsible for oversight of the Plan, determining the appropriateness of investment offerings and monitoring investment performance.

Contributions

Eligible participants may elect to contribute Roth and pre-tax deferred compensation to the Plan by means of a salary deferral agreement up to the maximum limit permitted by law. Contributions are, thus, subject to limitations as provided in the Code and as described in the Plan's provisions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover) in accordance with Plan provisions.

The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in the investment option designated from time to time by the Plan Trustees as the default investment, until changed by the participant (see Note J).

The Company may make discretionary matching contributions to the Plan in accordance with Plan provisions. Eligibility requirements for matching contributions are the same as general Plan eligibility requirements. Employees are eligible to receive the matching contributions on the first day of the month coinciding with or next following satisfaction of meeting the eligibility requirements.

The Company may make a discretionary non-elective contribution to the Plan in accordance with the Plan provisions. Employees must have at least 1,000 hours completed during the year and be employed at the end of the Plan year in order to be eligible to receive an allocation of the non-elective employer contribution.

Salary deferral contributions are funded proximate to the withholding date. Discretionary contributions, if any, are funded annually after the close of the Plan year and within statutory time frames.

NOTE A--DESCRIPTION OF PLAN-continued

Participant Accounts

Each participant’s account is credited with the participant’s contribution, if any, and the Company’s discretionary contributions, if any, as well as allocations of (a) Plan earnings or losses, (b) forfeitures of terminated participants’ non-vested accounts, and (c) administrative expenses paid by the Plan. Allocations are based on participant account balances or compensation or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Upon enrollment in the Plan, participants may elect the way in which contributions are invested in a variety of investment choices within the Plan as more fully described in the Plan’s literature. The investment elections will apply to both participant and employer contributions. Participants may change their investment options at any time. During any period in which there is no participant direction on file with the Custodians as to the investment of a participant’s account, 100 percent of that participant’s account will be invested in the investment option designated from time to time by the Custodians as the default investment. The Plan currently offers various registered investment companies, pooled separate accounts and a fixed annuity contract as investment options for participants.

Vesting

Participants are immediately vested in their contributions and the discretionary match plus actual earnings thereon. Vesting in the Company’s discretionary profit-sharing contributions portion of their accounts plus actual earnings thereon is based on years of credited service, as presented below. Participants who attain the normal retirement age of 65 or who terminate employment due to death or disability become 100 percent vested in their account balances.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested interest in the Plan, reduced by the participant’s highest outstanding loan balance in the previous twelve months and any existing loan balance. The loans are collateralized by the participant’s account balance and bear interest at a reasonable rate commensurate with local prevailing rates as determined by the Plan Administrator. The interest rates applied to current loans outstanding are 4.25 to 9.50 percent. Principal and interest are paid ratably through payroll deductions.

NOTES TO FINANCIAL STATEMENTS

NOTE A--DESCRIPTION OF PLAN-continued

Payment of Benefits

Upon termination of employment due to death, disability, normal retirement age of sixty-five, or Plan termination, a participant is entitled to 100 percent of their account balance. Upon termination of employment due to early retirement age of sixty, a participant is entitled to 100 percent of the participant's contributions and discretionary matching contributions and subject to the Plan's vesting provisions in their discretionary profit-sharing contributions. For termination of employment for other reasons, a participant is entitled to 100 percent of the participant's contributions and the vested portion of the Company's contributions based upon the Plan's vesting provisions in a lump sum. In-service and hardship withdrawals, subject to certain restrictions, are also permitted.

Account balances in excess of \$5,000 (not including rollover account balances) will be made as soon as administratively feasible following the date the Plan Administrator receives a written request for distribution.

Mandatory distributions of less than \$5,000 (not including rollover account balances) will be paid in a single lump-sum payment. The Plan will make the distribution as a direct rollover for any amounts greater than \$1,000. These distributions will be made if a participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or does not elect to receive the distribution directly.

Forfeited Accounts

If a participant is not fully vested upon termination, the non-vested portion of the account is forfeited. Forfeited non-vested accounts may be used to reinstate any previously forfeited amounts of certain former participants who are rehired. The remaining forfeitures will first be used to pay the administrative expenses of the Plan, as directed by the employer, with the remaining amounts used to reduce future employer contributions. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$15,074 and \$14,344, respectively. During the year ending December 31, 2024, the Plan used \$17,786 of the forfeited non-vested accounts to offset and employer contributions and \$4,841 of the forfeited non-vested accounts to pay plan expenses.

Allocated Insurance Contracts

The Plan may purchase allocated insurance contracts for eligible participants from an insurance company in accordance with Plan provisions. If purchased, the participant's account will be reduced by the amount of the premiums paid. These contracts are appropriately reported on Schedule A of the Form 5500 and excluded from the accompanying financial statements in accordance with accounting principles generally accepted in the United States of America and ERISA regulations. The Plan had no such contracts purchased on December 31, 2024, and 2023.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES-continued

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the guaranteed interest contract, which is at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Profit Sharing and 401(k) Oversight Committee determines the Plan's valuation policies utilizing information provided by the investment Custodian and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded at December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loans to be in default, the participant loan balance is reduced, and a benefit payment is recorded. During the plan year ended December 31, 2024, \$45,946 of notes receivable from participants were deemed distributed.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable and benefit payments are charged directly to the participant's account and are included in notes receivable from participants and benefits paid to participants. Investment-related expenses are included in net appreciation/depreciation of the fair value of investments.

Subsequent Events

Management of the Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Should an investment be re-characterized from one level to another level, Plan management would state the basis for the change. Under such circumstances the Plan would report the transfers in and transfers out at the beginning of the Plan quarter when change occurs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Registered investment companies value mutual funds at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Shares of pooled separate accounts are valued at the NAV of units held by the Plan at year end. The NAV is the basis for current transactions and the pooled separate accounts can be redeemed at NAV as of the measurement date. The NAV is used as a practical expedient to estimate fair value. Participant transactions (sales and purchases) may occur daily, and shares can be redeemed on a daily basis.

NOTE E--FIXED ANNUITY

At December 31, 2024 and 2023, the Plan invests in a single group annuity contract Delaware Charter and Trust Company d/b/a Principal Trust Company as the issuer of the contract. In accordance with ASC Subtopic 820-10, this investment is presented in the financial statements at its contract value. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined-contribution plan attributed to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The value of the traditional investment contract at December 31, 2024 and 2023 is \$8,324,704 and \$8,322,165, respectively.

NOTE E--FIXED ANNUITY-continued

With traditional investment contracts, the Plan owns only the contract itself. With synthetic investment contracts, the Plan owns the underlying assets of the synthetic investment contract. The group annuity contract is deemed to be a traditional investment contract.

The annuity contract pays a fixed rate of interest. The contract is not a portfolio of contracts with yields based on changes in the fair value of underlying assets as would be found in a stable value fund. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract. The interest crediting rate was 2.55% and 1.90% at December 31, 2024 and 2023, respectively, and is updated semiannually with the next crediting rate update scheduled for December 2025.

By definition, a group annuity contract is an insurance contract. As a result, the Plan may transact according to the terms defined in the contract at any time. Interest is credited to the Guaranteed Interest Fund on a daily basis from the date deposits are accepted until paid, transferred or applied in full. Fees may be paid in one of the following three ways: (1) by being netted from the effective annual interest rate; (2) by being paid separately by the Plan Sponsor; or by being deducted from the Guaranteed Interest Fund. Benefit payments are deducted from the value of the Guaranteed Interest Fund to the extent that the composite value is sufficient to make such payments. Payments and transfers are made in full within 3 business days after the date payment or transfer has been requested. In the event that market conditions are such that it is determined that they will not allow for the orderly transfer or sale of financial instruments, up to an additional 30 days may be required to make such payment or transfer.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) termination of a Plan's interest: if the Plan Sponsor wishes to terminate the Plan's interest, the value of the Plan's interest will be paid out in six installment payments. The first installment payment will be paid six months after the date of the notice to terminate the Plan's interest. Subsequent installment payments will be made on the same day of each year thereafter. In lieu of the six installment payment option, the record keeper may request payment be made on a date at least 90 days, but not more than 180 days from the date of the notice, subject to a potential Early Termination Charge and (2) termination of the contract: the Plan's contract shall be terminated on the date when arrangements have been made between the record keeper and Plan Sponsor and there are no guaranteed interest funds with a value greater than zero. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable to occur.

NOTE F--RELATED PARTY TRANSACTIONS

Certain Plan investments are held and invested by the Custodians. The Custodians perform administrative and recordkeeping services for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Company to the Custodians are not material to the financial statements.

Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services by the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan. These amounts are not material to the financial statements.

NOTE G--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE H--TAX STATUS

On June 30, 2020, the Internal Revenue Service stated that the prototype plan document, subsequently adopted by the Plan, as then designed, qualified under section 401(k) of the Internal Revenue Code (the "IRC"). The Plan has been amended since receiving the determination letter. The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator and the Plan's legal counsel believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE I--RISKS AND UNCERTAINTIES

The Plan's assets are invested directly and indirectly in various investment securities. Investments are exposed to various risks such as interest rate, market, and credit risks. The Plan's assets are subject to changes in the value of those underlying investments, including the potential for bankruptcy of one or more of the companies in which they are invested.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Participants who have borrowed from the Plan are all employees of the Company in various locations throughout the United States. Their ability to repay the notes could be affected by the economic conditions in the industry in general, the economic conditions of the location of the employees or the economic condition of the Company itself.

NOTE J--PLAN AMENDMENTS

Effective January 1, 2023, the Plan was amended and restated to increase the automatic deferral rate from 4% to 5% (see Note A).
