Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of USA DeBusk, LLC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information described in Note 4 to the financial statements is complete and accurate.

Opinion

For information included in the supplemental information that is agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1 – Plan Description

The following description of the USA DeBusk, LLC Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of the following: USA DeBusk, LLC; G & A Environmental Contractors, LLC; and Farr Front Chemical Service, LLC (collectively, the “Company” or “Employer”).

The Plan, which commenced effective February 1, 2014, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”). The Plan was amended and restated effective April 1, 2021, to comply with current law.

Plan Custodian and Trustees

Standard Insurance Company (“Standard” or the “Custodian”) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing recordkeeping services to the Plan. Among other duties, Standard receives contributions, holds, and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Two employees of the Company are the Trustees of the Plan.

Eligibility

Certain employees are not eligible to participate in the Plan, including union employees, leased employees, and non-resident aliens. Employees become eligible to make salary deferral contributions upon reaching age 21 and completing 500 hours of services within six months of employment. Eligible employees are permitted to enter the Plan on the first day of the quarter following the completion of the eligibility requirements.

Participant Contributions

Participants may elect to contribute on a pre-tax basis up to 100% of eligible compensation as defined by the Plan, and subject to the maximum annual deferral limit established by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the maximum amount allowed annually under the IRC, which was \$7,500 for 2024.

Rollover Contributions

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

Employer Contributions

The Company may make discretionary Employer matching contributions to the Plan on behalf of participants. During 2024, the Company matched 100% up to 3% of participant deferrals, not to exceed \$2,000 of eligible compensation. Participants must be employed on the last day of the Plan year to be eligible for the discretionary Employer matching contributions.

In addition, the Company may make discretionary profit-sharing contributions, as determined by the Company. Employees may share in the discretionary profit-sharing contributions if the employee is employed on the last day of the Plan year and has completed six months of service. No such contributions were made for the year ended December 31, 2024.

Note 1 – Plan Description (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings or losses thereon. Employees hired prior to March 31, 2020, are fully vested in Employer matching contributions and profit-sharing contributions when eligible to enroll in the Plan. Employees hired after March 31, 2020, will vest in Employer matching contributions and profit-sharing contributions on a two-year cliff vesting schedule.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, and participants may direct the allocation of their account balances to one or more of these options. The investment options vary in types of investments, rates of return, and investment risk.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 2% above Prime, as defined. Principal and interest are paid ratably through bi-weekly payroll deductions over a period of five years or less for a general loan, and up to thirty years for the purchase of a primary residence.

Payment of Benefits

Upon separation of service due to death, disability, retirement, or termination of employment, a participant receives a lump sum payment equal to the value of their vested balance. Participants or beneficiaries who must receive required minimum distributions under the IRC are permitted to receive partial withdrawals or installment payments. Vested account balances of less than \$5,000 are immediately distributed in a lump sum payment under the terms of the Plan, without the participant's consent. A participant may withdraw all or a portion of their account in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age of 59½.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,199 and \$491, respectively. These accounts will be used to reduce future Employer contributions or pay Plan expenses. During the year ended December 31, 2024, forfeitures of \$3,978 were used to pay Plan administrative expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants in October 2024.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Pooled Separate Accounts** – Valued using the net asset value (“NAV”) of units held by the Plan at year-end as provided by the Custodian. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate account, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations are carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Note 5 – Guaranteed Investment Contract with Insurance Company

The Plan maintains guaranteed investment contract related investment options (“MN Life Guaranteed Return Account” or the “Fixed Account”) issued by Minnesota Life Insurance Company. The contract underlying these investment options meets the fully benefit-responsive investment contract criteria, thus these investment contracts are reported at contract value.

Note 5 – Guaranteed Investment Contract with Insurance Company (continued)

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The Fixed Account minimum guaranteed interest rate, which is guaranteed for the lifetime of the contract, is 1.00%. The contracts cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include, but are not limited to, the following: (i) the Company provides effective communication to the Custodian that the agreement will be fully or partially terminated as of a date selected by the Company, which will be no earlier than thirty days after the Company provides effective communication to the Custodian; (ii) the IRS determines that the Plan no longer meets the requirements of Code section 401(a), 403(a), 414(d), 414(e), or any other applicable Code provision; (iii) there is a termination or partial termination of the Plan; (iv) the Company breaches a provision of the agreement; (v) the Custodian provides effective communication to the Company that the agreement will be terminated as of a date at least ninety days after the Custodian provides effective communication to the Company.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6 – Related Party Transactions and Party-in-Interest Transactions

Plan investments are shares of mutual funds managed by the Custodian; therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. As a result, these receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 8 – Tax Status

The Plan operates under an adoption agreement in connection with a preapproved non-standardized profit-sharing plan sponsored by Minnesota Life Insurance Company. This preapproved plan document has been filed with the appropriate agency and obtained a determination letter from the IRS, dated June 30, 2020, stating that the preapproved plan and related trust, as then designed, constituted a qualified plan under Section 401 of the IRC, and therefore were not subject to tax. Although the Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status, the Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC; therefore, no provision for income taxes has been made in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan has evaluated all events and transactions that occurred through October 10, 2025, the date these financial statements were available to be issued.

Effective May 1, 2025, the Plan was amended to allow for Roth contributions.

On December 5, 2023, USA Debusk, LLC announced the acquisition of Nitro Lift Technologies, LLC (“Nitro”). Effective May 31, 2025, the Plan was amended and the Nitro Lift Technologies, LLC Profit Sharing 401(k) Plan (the “Merged Plan”) merged with the Plan. The formal transfer of all assets was completed on May 31, 2025, and net assets totaling \$4,478,372 were transferred from the Merged Plan into the Plan.


