To the Participants, Administrator and Plan Committee  
APS Healthcare Puerto Rico Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of APS Healthcare Puerto Rico Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103 (a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not to extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held as prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## Notes to Financial Statements

December 31, 2024 and 2023

### Note 1 - Description of the Plan

The following description of the APS Healthcare Puerto Rico Retirement Savings Plan (the Plan), formerly APS Healthcare Puerto Rico, Inc. Retirement Savings Plan, is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's information.

#### General

The Plan is a defined contribution plan covering substantially all employees of APS Healthcare Puerto Rico, Inc., APS Clinics of Puerto Rico, Inc. and APS Management Corp. (the Companies). Banco Popular de Puerto Rico serves as the Trustee of the Plan. Principal Trust Company serves as the custodian and recordkeeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Employees are eligible to participate upon date of hire based on eligibility criteria, as defined by the Plan document. Each year the participants may contribute an amount of their compensation not exceeding the maximum deferral specified by law. The Companies contribute 100% of the first 1% and 50% of the following 4% for a maximum match of 3% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain Puerto Rico Internal Revenue Code (the Code) limitations.

#### Participants' Accounts

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contribution, the Company's matching contribution, and Plan earnings, and charged with withdrawals and allocation of the Plan's gain or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several registered investment companies and a common collective trust fund (CCT) as investment options for participants.

Notes to Financial Statements – (Continued)

December 31, 2024 and 2023

Note 1 - Description of the Plan – (continued)

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Companies' matching contribution portion of their accounts is based on years of continuous service. A participant's vesting percentage proportional in the Company's contributions over a five-year period and is 100% vested after five years of credited service.

Notes Receivable from Participants

Participants may borrow up to a maximum of \$50,000 or 50% of their vested account balance from their fund accounts, whichever is less. The loans are secured by an assignment of the participant's vested interest in the Plan, and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed, as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms shall not exceed five years. Participants may not have more than two loans outstanding at any time. As of December 31, 2024 and 2023, participants' loans have an interest rate between 4.25% through 9.50% with various maturities through 2029.

Payment of Benefits

On termination of service with the Companies (including termination of service due to death, disability, or retirement), a participant may generally receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or annual installments over a period of not more than their assumed life expectancy.

In addition, the Plan provides for in-service distributions in certain circumstances, including financial hardship withdrawals, subject to certain limitations. Also, in-service distributions may be available to participants as special disaster distributions, as determined by the Puerto Rico Treasury Department.

Forfeited Accounts

During the year ended December 31, 2024, the Plan Sponsor used \$70 to pay for administrative expenses of the Plan and \$51,829 to reduce employer contributions to participants accounts.

At December 31, 2024 and 2023, the remaining accumulated forfeited non-vested amounts totaled \$1,123 and \$8,929, respectively. These amounts might be used to reduce future employer contributions or pay Plan administrative expenses.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting and Presentation

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan utilizes various investment instruments, including mutual funds and a CCT. Investment securities, in general, are exposed to various risks, such as interest rates, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in their values will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (See Note 4).

The Plan's CCT invests mainly its assets in Galliard Stable Return PN15, a collective trust fund sponsored by Galliard Capital Management. The value of this investment is based on the underlying unit value reported by Galliard Stable Return PN15. The Galliard Stable Return PN15 invests in investment contracts and security-backed contracts.

#### Note 2 - Summary of Significant Accounting Policies – (continued)

##### Investment Valuation and Income Recognition – (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

##### Administrative Expenses

Administrative expenses of the Plan are paid by the Companies and the Plan, as provided in the Plan document.

##### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

##### Benefits Payable

The Plan accounts for benefits payable in accordance with the guidance provided by the American Institute of Certified Public Accountants (AICPA) *Audit and Accounting Guide, Audits of Employee Benefit Plans*. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. Benefits payable due to participants amounted to \$30,795 and \$2,020 as of December 31, 2024 and 2023, respectively.

##### Excess Participants Contribution

The Plan is required to return to participants contributions received during the Plan year in excess of the Code limits. Excess contributions are recorded as a liability in the accompanying statements of net assets available for benefits and as a reduction of participant-directed contributions for the year.

Note 3 - Information certified by Custodian (unaudited)

The plan administrator has elected the method of compliance permitted by Section 103(a)(3)(C) of the U.S. Department of Labor's Rule and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company (the Custodian), has certified, as to the completeness and accuracy of all investments related information reflected in the accompanying financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and the related notes to the financial statements, and schedule H, Part IV, line 41 – schedule of assets (held at year end) as of December 31, 2024.

The Custodian maintains all records, executes investment transactions, and holds all assets of the Plan. During 2024, the Plan's investments in mutual funds and collective trust funds (including gain and losses bought and sold, as well as held during the year) appreciated in value by \$1,255,898.

Note 4 - Fair Value Measurements

In accordance with the provisions of Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) No. 820, *Fair Value Measurements*, the Plan uses valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible to estimate fair values. The Plan determines fair values based on assumptions that market participants would have used in pricing an asset or liability in the principal or most advantageous market.

ASC No. 820 provides a fair value hierarchy that prioritizes the use of observable inputs in the valuation techniques used to measure fair value, as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active market that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 - Fair Value Measurements – (continued)

Following is a description of the valuation methodologies used by the Plan for investments measured at fair value at December 31, 2024 and 2023:

*Mutual funds* - Investments in mutual funds consist of shares of mutual funds that are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan consist of open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and were categorized as Level 1.

*Common collective trust funds* – Investments in the common collective trust funds is valued at the NAV based on the underlying unit value reported by Galliard Stable Return PN15.

Per US GAAP guidance, investments which use a net asset value per share (NAV) practical expedient for fair value measurement, as defined in ASC No. 820, should be removed from the leveling table and shown as a reconciling item. In general, the use of the practical expedient requires that the NAV is not publicly available.

Note 4 - Fair Value Measurements – (continued)

The investment in Galliard Stable Return PN15 is valued as a practical expedient utilizing the net asset value. The use of net asset value as fair value is deemed appropriate, as the collective trust funds do not have a finite life, unfunded commitments relating to these types of investments, or significant restrictions on redemptions. The practical expedient is used for valuation, unless it is probable that the common collective trust funds will sell a portion of the investment at an amount different from the net asset valuation.

Note 5 - Party-In-Interest Transactions

Certain Plan investments are managed by the Custodian, therefore, these transactions qualify as party-in-interest transactions.

Note 6 - Plan Termination

Although they have not expressed any intention to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth by ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

Note 7 - Income Tax Status

The Plan constitutes a qualified Plan, exempt from income taxes under the provisions of the Code, as amended.

The Plan obtained a favorable determination letter on December 6, 2018, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan is in compliance with the applicable requirements of the Code, as amended.

Management has evaluated the Plan's tax position and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

Note 8 - Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. No events have occurred subsequent to the statement of net assets available for benefits date and to the date these financial statements were available to be issued, that would require additional adjustment to, or disclosure in, the financial statements.
