We have performed audits of the accompanying financial statements of Peter Paul Electronics Co., Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Peter Paul Electronics Co., Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1: **Description of Plan:** The following description of the Peter Paul Electronics Co., Inc. 401(K) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Peter Paul Electronics Co., Inc. (the Company). Eligibility requirements for employee deferrals are employees must attain the age of 21 years and have completed 30 days of service. Plan entry dates are on the first day of each calendar month coinciding with, or next following, the date of meeting both eligibility requirements.

As amended by the Plan Sponsor on January 1, 2024, employees are eligible to participate in the discretionary match contribution once they have attained the age of 21 years and completed 30 days of service. Eligible employees will be permitted to participate in the employer discretionary match on the first day of each calendar month coinciding with, or next following, the date of meeting both eligibility requirements.

As amended by the Plan Sponsor on January 1, 2024, employees are eligible to participate in the discretionary profit sharing portion of the Plan when the employee satisfies the age requirement of 21 years and service requirement completion of 30 days of service. Eligible employees will be permitted to participate in the employer discretionary profit sharing portion on the first day of each calendar month coinciding with, or next following, the date of meeting both eligibility requirements.

The Plan provides for automatic enrollment contributions of 6% of compensation into a Qualified Default Investment Alternative fund as defined in the Plan document, unless employees elect otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: The Plan allows participants to elect to contribute a portion of their annual pre-tax earnings and after tax earnings as allowed by law. Participants may also contribute amounts representing distributions from other qualified plans. The discretionary Company match contribution for the year ended December 31, 2024 was 50% of the first 6% of the base compensation that a participant contributes to the Plan. Additional discretionary profit sharing contributions may be made at the option of the Company's board of directors. There was no additional discretionary profit sharing contribution to the Plan for the year ended December 31, 2024. The Company match contribution to the Plan was \$160,040 for the year ended December 31, 2024, of which \$9,241 of Plan forfeitures were used. The Company also made an additional \$7,426 of contributions during the year, which are to be forfeited.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a fixed annuity as investment options for participants. Contributions are subject to certain limitations imposed by the Internal Revenue Code.

Participant Accounts: Each participant's account is credited with an allocation of the participant's contributions, the Company's contribution, plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1: (Continued):

Vesting: Participants are 100% vested in their respective account balances attributable to the participant contributions. Vesting in the Company's discretionary employer match and discretionary profit sharing contributions plus actual earnings thereon is based on years of continuous service. Vesting in the Company's discretionary match and discretionary profit sharing contribution is based on the following schedule:

Less than 2 years	0%
2 years but less than 3 years	25%
3 years but less than 4 years	50%
4 years but less than 5 years	75%
5 or more years	100%

Notes Receivable from Participants: Participant loans are not permitted. However, withdrawals may be made for immediate and heavy financial need as specified in the Plan document. Withdrawals may only be made from the participant's 100% vested accounts.

Payment of Benefits: On termination of service due to death, disability or normal retirement, all amounts credited to a participant's account become fully vested. For termination of service due to other reasons, a participant is entitled to the value of the vested interest in their account. A participant may elect to receive the value in their account in either a lump sum amount or an annuity regardless of whether the participant was terminated due to death, disability, retirement, or for other reasons.

Forfeitures: Forfeitures of non-vested accounts totaled \$7,437 as of the year ended December 31, 2024. The Company has discretion in deciding how to use these forfeitures, such as paying Plan expenses. If any forfeitures are not used to pay Plan expenses, such forfeitures may be allocated as additional Employer contributions or forfeitures may be used to reduce other Employer contributions under the Plan. The Company will determine each year the amount of any forfeitures for such year and will use those forfeitures in the Plan year for which the forfeiture occurs or in the following Plan year. For the year ended December 31, 2024, \$9,241 of forfeitures were used for employer match contributions.

NOTE 2: **Summary of Significant Accounting Policies:**

Basis of Accounting and Use of Estimates: The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition: Investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Administrative expenses of the Plan are allocated to participant accounts. Administrative expenses for the year ended December 31, 2024 totaled \$33,679.

NOTE 3: Fair Value Measurements: Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds

Mutual funds are valued using Level 1 inputs, which consist of the quoted price of shares held by the Plan at year end.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4: Guaranteed Investment Contracts: The Plan entered into a benefit-responsive investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a separate investment account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower Annuity Insurance Company of America is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$22,600 and \$243,110, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America. Such events include the following: 1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This investment contract was credited with interest of 1.41% for the year ended December 31, 2024.

NOTE 5: Plan Termination: Although it has not expressed any intent to do so, the Company has the right, under the Plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 6: Party-In-Interest Transactions: Plan assets include investments in funds that were managed by Empower Trust Company, LLC through January 31, 2024 and ADP Retirement Trust Services, LLC from February 1, 2024 through December 31, 2024 and a guaranteed investment contract managed by Empower Annuity Insurance Company of America. Empower Trust Company, LLC and ADP Retirement Services, LLC are trustees as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Other parties in interest include professional service firms who provide services to the Plan.

NOTE 7: Tax Status of the Plan: The IRS has determined and informed the Plan sponsor by a letter dated May 26, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE 8: Financial Data Certified by the Trustee: Information presented in the accompanying statements and schedule, including investments held as of December 31, 2024 and 2023, and net change in fair value of investments and interest, dividend and capital gains income for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America, Empower Trust Company, LLC and ADP Retirement Trust Services, LLC, the qualified institutions.

NOTE 9: Risks and Uncertainties: The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10: Subsequent Events: Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued and no such events occurred that would require adjustment to or disclosure in the financial statements.
