NOTE 1 - DESCRIPTION OF PLAN

The following description of the Sunset Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all full-time employees who have completed at least three consecutive months of service with Standard Sand & Silica Company or its related companies: Transsystems, Inc., Crystal Data Services, Inc., Elmore Sand & Gravel, Inc., Santana Dredging, Inc., Walsdorf Metal Works, Inc., Surface Prep Supply, Inc., and Edgar Minerals, Inc. (collectively the “Company”). The primary purpose of the Plan is to provide employees of the Company with financial benefits upon retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute to the Plan up to 100% of their pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The participants may also contribute amounts representing distributions from other qualified plans, i.e., rollovers. Participants direct the investment of their contributions into various investment options offered by the Plan. At the discretion of the Board of Directors, the employer may make discretionary matching and non-elective contributions to the Plan. There were no matching or non-elective contributions to the Plan in 2024 or 2023. Contributions are subject to certain IRS limitations.

Participant Accounts - Each participant’s account is credited with the participant’s contribution, the Company’s contribution, if any, the Company’s non-elective contribution, if any, and Plan earnings and is charged with the participant’s withdrawals, Plan losses, and an allocation of administrative expenses. Allocations are made based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their contributions, rollover contributions, and the actual earnings thereon. Vesting in the Company’s matching and non-elective contribution, plus earnings thereon, is based on each employee’s length of continuous service. A participant is 100% vested after six years of credited service. The Plan’s vesting provision is as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 Years	0%
2 Years but Less than 3	20%
3 Years but Less than 4	40%
4 Years but Less than 5	60%
5 Years but Less than 6	80%
6 Years or more	100%

Non-matching contributions become 100% vested, regardless of years of credited service, upon termination of employment because of death or disability, satisfaction of conditions for retirement, or termination of the Plan.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Investment Options - Upon enrollment in the Plan, a participant may direct employee and Company contributions into various investment options, which include mutual funds. Participants may change their investment options periodically as permitted.

Forfeited Accounts - Forfeitures are applied to reduce future Employer contributions. The Company had \$0 and \$1,221 of forfeitures as of December 31, 2024 and 2023, respectively. These accounts are used to pay Plan administrative expenses or to reduce future Company matching or non-elective contributions to the Plan.

Notes Receivable from Participants - Participants may borrow from their fund accounts an amount not less than \$1,000 and not to exceed the lesser of \$50,000 or 50% of the value of the vested portion of the participant's account balance. The term of the loan may not exceed five years, unless meeting certain criteria. Notes are secured by the vested balance in the participant's account, are charged interest at a fixed rate equal to prime rate plus 1%, and are measured at their unpaid balance, plus any accrued but unpaid interest. There is no allowance for credit losses at December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions based on the terms in the Plan document. Principal and interest are paid ratably through weekly payroll deductions. Notes outstanding at December 31, 2024 bear interest at rates from 5.25%-10.5%.

Benefit payments - On termination of service due to retirement, death, or disability, or other reasons, a participant's account is distributed as a lump-sum distribution. If the participant reaches normal retirement age and their vested balance exceeds \$5,000, the participant has the option of receiving a lump-sum distribution at either the time of retirement or age 70 ½.

Hardship Withdrawals - Withdrawal of a portion of a participant's account will be permitted due to an immediate and heavy financial need, if it meets IRS requirements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates - The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events - The Plan evaluated subsequent events through October 10, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan, Principal Life Insurance Company, Principal Life Insurance Company as agent for Principal Global Investors Trust Company, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31:

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Investments in the mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Investments in pooled separate accounts are valued based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and had redemption prices that are determined by the fund's net asset value per unit.

Pooled separate accounts: Investment contracts are valued at discontinuance value, which is the amount the plan participant will receive if they transfer or surrender their funds out of the investment contract.

NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)

Common and/or collective trust: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. Individual participant redemptions for benefit payments and investment transfers are permitted without restriction. Redemptions for any other purpose, including major Plan changes (such as re-enrollments) or major events affecting the Plan sponsor must be given, in writing, one year prior to the valuation date on which the redemption is to be effected.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds an investment contract issued by Principal Global Investors Trust Co., an affiliate of Principal Trust Company, and pooled separate accounts issued by Principal Life Insurance Company. Therefore, these transactions and the Plan's payment of record keeping fees and investment management fees to Principal Trust Company qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 6 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC. Accordingly, the Plan administrator believes that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations prior to 2021.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the Plan's provisions and those of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
