The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of JCCSF 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of JCCSF 403(b) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about JCCSF 403(b) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of delinquent participant contributions for the year ended December 31, 2024, and of assets (held at end of year) as of December 31, 2024, (collectively, "supplemental schedules") are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the JCCSF 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan documents, as amended, for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution plan sponsored by the Jewish Community Center of San Francisco (the "Center", "Employer", or "Plan Sponsor"), pursuant to Section 403(b) and related provisions of the Internal Revenue Code (IRC), was established effective January 1, 2008, and amended effective January 1, 2024. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended (ERISA), and the IRC.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Center is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Center has delegated certain responsibilities for the operation and administration of the Plan. Charles Schwab Trust Bank and Standard Insurance Company ("The Standard") (collectively, the "Custodians") are responsible for the custody and management of the Plan's assets. Recordkeeping services are provided by Standard Retirement Services, Inc.

Eligibility

Employees covered under the Plan include all employees, except nonresident aliens, employees who normally work less than 20 hours per week, reclassified employees and residents of Puerto Rico. There are no age or service requirements that need to be satisfied in order to make elective deferral contributions, Employer discretionary matching contributions and discretionary non-elective profit sharing contributions. Employees are eligible to enter the Plan on the first day of employment.

1. DESCRIPTION OF THE PLAN (continued)

Contributions

The Plan requires automatic enrollment of newly eligible employees with a contribution of 4% of their eligible pre-tax compensation via payroll deduction unless the employee affirmatively elects otherwise. Participants may elect to contribute additional amounts up to the maximum amount allowed by the IRC. Participants who attained age 50 or over before the end of the year may contribute an additional catch-up contribution to the Plan. Participants are allowed to rollover contributions from other qualified retirement plans into the Plan. Participants direct the investment of all their contributions into various investment options offered by the Plan. The Plan also allows for after-tax Roth contributions.

The Plan allows for Employer discretionary matching contributions and Employer discretionary non-elective profit sharing contributions. For 2024, the Employer discretionary matching contribution was made at 50% of a participant's salary deferral contributions up to 4% of a participant's eligible compensation. For the year ended December 31, 2024, the Center made Employer discretionary matching and Employer discretionary non-elective profit sharing contributions to the Plan in the amounts of \$260,607 and \$563,552, respectively.

Allocations of the Employer discretionary non-elective profit sharing contribution are determined as follows for both union and non-union employees:

If a participant was age 40 or older as of December 31, 2007, and had completed five years for vesting under the Defined Benefit Plan of the Jewish Community Federation of San Francisco, a related employer of the Center, as defined, as of December 31, 2007, the participant(s) may receive a base contribution of 3% of their compensation plus an additional contribution based on their compensation, their age and the following rates as follows:

If a participant is not eligible to receive the above contributions, the participant may still receive the base contribution of 3% of their compensation plus an additional contribution based on their compensation, years of service and the following rates:

Participant accounts

Each participant's account is credited with the participant's contributions, rollovers, the Employer discretionary matching contributions and Employer discretionary non-elective profit sharing contributions, if any, an allocation of Plan earnings, if any, and charged with certain administrative expenses, as applicable, and Plan losses, if any. Allocations of investment earnings are based strictly on the participant's selection of investments and timing of purchases and sales. Other allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary and rollover contributions and actual earnings thereon. The Plan allows for additional vesting credit of up to three years with certain qualified organizations as defined by the plan document. Participants fully vest upon death, disability, normal retirement age, or Plan termination.

Prior to July 1, 2021, the vesting schedule for the Employer discretionary matching contributions and the Employer discretionary non-elective profit sharing contributions was as follows:

Notes receivable from participants

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Prior to April 1, 2015, only one outstanding note (or "loan") per participant was permitted at any given time. On or after April 1, 2015, participants may have up to two loans outstanding, however, if a participant requests an additional loan and has two loans outstanding at the time of the request, they must pay off one of the loans before a new loan can be authorized. A participant may not initiate more than two loans in one calendar year. A loan is secured by the remaining balance in the participant's account and bears interest at rates which are commensurate with prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. The loans must be repaid within a five-year period, unless used for the purchase of a principal residence, in which case the maximum repayment period may be longer. The Plan administrator establishes the specific terms and conditions of such loans. Outstanding participant loans for the year ended December 31, 2024, bear interest at annual rates between 4.75% and 8.50% and mature at various dates through October 2029.

Payment of benefits

Benefits are payable upon retirement, termination of employment, disability (as defined), or death. A participant may elect to receive a lump-sum, annuity, or installment amount equal to the value of the participant's interest in his or her account. If the terminated participant's total vested accrued benefit is equal to or less than \$1,000, the Plan Sponsor may distribute the account to the participant in a lump sum payment without the participant's consent. If the terminated participant's total vested accrued benefit is greater than \$1,000 and less than or equal to \$5,000, the Plan Sponsor may distribute the account to the participant by rolling the amount over into an individual retirement account designated by the plan administrator without the participant's consent. Participants with a total vested accrued benefit of greater than \$5,000, may also elect to rollover their account to another tax deferred account or remain in the Plan until they are legally required to begin taking distributions. Effective June 1, 2024, the Plan's involuntary cash out and automatic rollover provision amount was increased from \$5,000 to \$7,000.

Payment of benefits (continued)

In addition to the foregoing, participants are permitted to request distributions from their vested Plan accounts at any time after having attained age 65. Also, participants may request a distribution of their deferral account upon incurring a financial hardship, as defined in the plan document.

Forfeitures

Forfeitures represent unvested portions of terminated participants' accounts. These funds may be used to reduce Plan expenses, Employer discretionary matching contributions and Employer discretionary non-elective profit sharing contributions, in accordance with the plan document. During the year ended December 31, 2024, there were no forfeitures used to reduce Employer discretionary matching contributions or Employer discretionary non-elective profit sharing contributions. Forfeitures of \$42,286 were used to reduce Plan expenses for the year ended December 31, 2024. The unallocated forfeiture balance as of December 31, 2024 and 2023, was \$19,655 and \$22,644, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosures of contingent liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results may differ from those estimates. Significant estimates and assumptions include the fair value of investments (Note 4).

Investment valuation and income recognition

Investments held by the Plan are stated at fair value or at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date (Note 4). Contract value is the amount participants would receive under the terms of the contract with The Standard (Note 5).

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and changes therein.

Contributions and contribution receivables

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Center, which is the pay date. Employer contributions are recorded in the year they are earned and coincide with the year in which the Center records the contributions in its general ledger. The Plan records receivables for contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Rollover contributions from participants are recorded based on the date the rollover contributions have been received by the Custodians.

Notes receivable from participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. If a participant ceases to make loan repayments and the plan administrator deems the loan to be a distribution, the participant loan balance is reduced and a deemed distribution is recorded.

Payment of benefits

Benefits payments to participants are recorded as a reduction of net assets available for benefits when paid.

Administrative expenses

Administrative expenses paid by the Plan are recorded when incurred and accruals are recorded when due.

Subsequent events

The plan administrator has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS (UNAUDITED)

The Plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA.

Accordingly, the Custodians, determined to be qualified institutions by the plan administrator, have certified to the completeness and accuracy of the Plan's investment information and related activity. As such, as requested by the plan administrator, the Plan's auditor performed no procedures on the certified information other than to agree the certified information to the related information included in the financial statements and schedule of assets (held at end of year). 4. FAIR VALUE MEASUREMENTS

Accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy are as follows:

- *Level 1* - inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

- *Level 2* - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- *Level 3* - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Fully benefit-responsive guaranteed investment contracts are not included within the fair value hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported on the active market on which these securities are traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. GROUP ANNUITY CONTRACT WITH THE STANDARD

The Plan has entered into a group annuity contract with The Standard through which the Plan invests in the Standard Stable Asset A Fund (the "Fund") with The Standard acting as asset custodian for the fund. Net deposits invested in the fund become part of The Standard's general account. The fund is considered, a fully-benefit responsive guaranteed interest account, or contract. Crediting interest rates for the Fund are set quarterly by The Standard with a minimum interest rate of 1%. The crediting rate is 3.04% for the year ended December 31, 2024.

There are no unfunded commitments and daily liquidity is available for participant contributions and withdrawals at contract value of the Fund regardless of market conditions. The Standard may terminate the contract with 30 days advance written notice to the Plan Sponsor for reasonable cause, which includes the Plan's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, or Plan disqualification by the Internal Revenue Service (IRS). Upon termination by The Standard, a market value adjustment or other withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. The Plan Sponsor knows of no events that are probable of occurring which would limit the Plan or participants from transacting at contract value with The Standard.

The Plan may discontinue the contract for contract owner withdrawals such as spin-offs, divestitures, corporate relocations, layoffs, retirement incentive programs, partial or total Plan terminations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer or would limit the ability of the Plan to transact at contract value with participants. If any such contract owner withdrawals are elected, the Plan may incur a market value adjustment and The Standard reserves the right to delay the effective date of the transaction for up to 30 days.

6. TAX STATUS

The Plan is a defined contribution plan designed to qualify as a tax-exempt plan under the IRC. The Plan operates under Standard Retirement Services, Inc. Volume Submitter 403(b) Plan document which received an opinion letter from the IRS dated March 31, 2017, stating that the form of the Volume Submitter 403(b) Plan document is acceptable for use by employers for the benefit of their employees. Although the Plan has since been amended, the Plan Sponsor believes the Plan is being operated in conformity with the requirements of the IRC, therefore, no provision for income taxes is included in these financial statements.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines a party-in-interest similarly to a related party under financial accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

Some fees and expenses of the Plan are paid by the Center. The Plan is not required to repay expenses paid by the Center on its behalf.

An investment of the Plan is managed by The Standard, therefore, the related investment transactions and fees qualify as party-in-interest transactions.

Standard Retirement Services, Inc. or an affiliate may receive compensation from mutual fund companies or other investment vehicles held by the Plan to cover expenses relating to the services provided to such investments, including but not limited to the purchase and redemption of shares, participant-level fund recordkeeping, and administrative or distribution services. This compensation is paid directly to Standard Retirement Services, Inc. by such companies or their affiliates. Standard Retirement Services, Inc. will process the amount of such compensation received and, to the extent permitted by law, shall use it to offset Plan fees that are due and payable. The amount of any excess compensation received over and above that used to offset fees is paid to the Plan.

Standard Retirement Services, Inc. receives and retains as additional compensation under this Agreement any earnings (i.e., "float") on such compensation from such investment vehicles before such amounts are applied to offset fees or are paid to the Plan. Calculation of float earnings is tied indirectly to the US Treasury Bill rate. Standard Retirement Services, Inc. retains any such fees received following termination of the administrative services agreement that total less than \$500.

Charles Schwab Trust Bank receives and retains as additional compensation under this Agreement any earnings (i.e., "float") on such compensation from such investment vehicles before such amounts are applied to offset fees or are paid to the Plan. Calculation of float earnings is performed each business day by netting all cash activity and adjusting for cash reserved for investment or reinvestment and for cash reserved for distributions.
