Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Trico Bancshares Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Trico Bancshares (the "Company") Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan's provisions.

General: Trico Bancshares established the Plan effective January 1, 1984. The Plan is a defined contribution plan formed with the intent of providing retirement income for eligible employees of Trico Bancshares. The Trustees, who include independent directors of the Company and the Chief Executive Officer, are responsible for the administration and management of the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Under the Plan, all regular salaried non-union employees of the Company who have attained age 18 and complete 1,000 hours of service with the Company in the twelve-month period following commencement of their employment are eligible to participate in the Plan.

Participants who do not have at least 1,000 hours of service during the plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for the year.

Contributions: Contributions under the Plan are discretionary and made solely by the Company. The Board of Directors determines the amount of any contributions and may decide not to make a contribution for a particular year. The contribution may be made in cash or shares of Company common stock. For the year ended December 31, 2024, the Board of Directors approved a total of \$3,154,438 in cash contributions.

Vesting: Each participant shall become one hundred percent (100%) vested in the participant's account upon reaching age 65 while employed by the Company, or separation of employment due to permanent disability or death. Upon separation of employment for any other reason, each participant shall be vested for discretionary employer contributions as provided below:

<u>Years of Service</u>	<u>Vested %</u>
Less than 2	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years but less than 6	80%
6 years or more	100%

All cash dividends paid to the Plan subsequent to 2021 are 100% vested for all participants, irrespective of the years of service provision applicable for vesting of discretionary contributions.

Participant Accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited with allocations of Company contributions, forfeitures, and Plan earnings, and charged with withdrawals and allocations of Plan losses. Contributions are allocated to the account of each participant in the ratio of the participant's eligible compensation to the total eligible compensation for all Plan participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Diversification of Stock Account: When a participant has attained age 55 and completed ten years of participation in the Plan, including years prior to the Plan becoming an Employee Stock Ownership Plan, participants will have the right to diversify a portion of their account. Participants may elect to diversify a cumulative amount of up to 25% of the stock in their account for the first five years and a cumulative amount of 50% in the sixth and final year. Participants who elect to diversify receive a stock distribution.

Payment of Benefits: Upon a participant's retirement, permanent disability or death, or otherwise separation of employment with the Company, distribution of a participant's Company stock account shall be made in whole shares of Company stock, cash, or both, with the value of any fractional shares being paid in cash. If the value of a participant's entire vested account does not exceed \$7,000, a distribution will be made in a lump sum as soon as administratively feasible after the end of the Plan year in which the employee separates employment. Participants are required to take benefit payments in the year following the year in which the participant reaches age 70-1/2.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Forfeitures: Forfeitures from the nonvested portion of account balances associated with employees who have separated employment are allocated to remaining participants in the ratio of the participant's eligible compensation to the total eligible compensation for all Plan participants. The forfeitures allocated during 2024 consisted of \$1,789 of cash and 10,812 shares of plan sponsor common stock. As of December 31, 2024 and 2023, there were no remaining forfeitures available to allocate to the remaining participants.

Administrative Expenses: The Company provides bookkeeping and other administrative services for the Plan at no charge. Investment management and certain professional fees are paid by the Company.

Voting Rights: Participants are entitled to direct the Trustees how to vote shares in their account on all matters requiring shareholder approval.

Concentrations of Investments: Included in investments at December 31, 2024 and 2023 are shares of the sponsor's common stock amounting to \$49,682,792 and \$47,648,960, respectively. The sponsor's stock represents a concentration of approximately 99% and 98% of the Plan's investments at December 31, 2024 and 2023, respectively. A significant decline in the market value of the sponsor's common stock would have a materially adverse effect on the Plan's net assets available for benefits.

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties: The primary investment of the Plan is in the common stock of the Plan Sponsor. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes net unrealized market appreciation of investments and net realized gains and losses on the sale of investments during the period.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: The Plan has evaluated subsequent events through October 9, 2025 which is the date the financial statements were available to be issued.

NOTE 3 – PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 5 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Company Common Stock – The fair value of Trico Bancshares common stock is determined by obtaining quoted prices from a nationally recognized exchange (Level 1 inputs).

Interest-bearing cash – Fair value of interest-bearing cash is based on the cash balance available at the measurement date (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 – PLAN WITHDRAWAL BY PARTICIPANTS

If applicable, included in the net assets available for benefits are amounts allocated to individuals who have separated employment and elected to withdraw from the Plan, but who have not yet been paid out. There were no such participants that had not been paid out at December 31, 2024.

NOTE 7 - FEDERAL INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a determination letter dated September 14, 2017, that the Plan was designed in accordance with the applicable regulations of the IRC. Although the Plan has been amended since this determination letter, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are no audits for any tax periods in progress.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under U.S. Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments are shares of common stock of the Company and an interest-bearing cash account maintained with the Company. Therefore, while these transactions qualify as party-in-interest transactions, they are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. In addition, dividend income earned on Company common stock represents party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.
